<p>Rockville is a 13.5 square mile city of approximately 70,730 residents located in south central Montgomery County, Maryland, approximately 12 miles northwest of Washington, DC, and 35 miles southwest of Baltimore. Rockville is bisected by Interstate 270 and by Maryland Route 28. Rockville enjoys rail service and two Metro stations. A large portion of the I-270 Technology Corridors Biotech Industry Cluster is in the city. Today, Rockville is one of the largest municipalities in Maryland and serves as the Montgomery County seat. The City of Rockville operates under the council-manager form of municipal government and derives its governing authority from a charter granted by the General Assembly of Maryland. The city has strong financial management policies and holds a AAA/Aaa bond rating from both Standard and Poors and Moodys Investors Service.</p>
