10. Description and Purpose of Organization (Limit length to visible area)		
Winter Growth is a nonprofit serving older adults and adults with disabilities through Adult Medical Day, Assisted Living, Memory Care, and Respite services in Howard and Montgomery Counties. For more than 40 years, Winter Growth has helped individuals remain active, connected, and engaged while providing essential relief to family caregivers. Our programs support physical health, cognitive stimulation, and social connection, particularly for individuals living with dementia or complex medical needs. Just as importantly, we serve as a trusted partner for families navigating aging, offering, dignity, reassurance, and peace of mind. Winter Growth is nonsectarian and community-based, and our centers function as vital local resources that allow participants to remain rooted in their communities while aging safely and with purpose.		

11. Description and Purpose of Project (Limit length to visible area)

Our Ruth Keeton Center serves as a daily hub for older adults who participate in the Adult Medical Day Program for health monitoring, social engagement, and structured activities. The central dining and activity area was originally designed in 1999 for residential use and, as participant interests and abilities have evolved, so has the need for greater flexibility and functionality. This project will update and reconfigure the space to better support shared meals, movement-based activities, and small and large group programming that promotes cognitive, physical, and social well-being. The renovation will also add dedicated, secure storage for medical supplies, activity materials, and personal belongings, improving daily operations as enrollment grows. These improvements will allow us to expand programming options and remain responsive to the changing needs of older adults while continuing to provide safe, high-quality care in a familiar and trusted setting.
