**Modernizing Civil Relief for Service Members Act**

---

This bill explicitly authorizes an active service member or an active service member's spouse who relocates to the State due to orders for service and holds a license issued by another jurisdiction to practice under that license within Maryland if the individual submits an application including specified documentation and satisfies other criteria. If an active service member or spouse is authorized to practice under the bill's provisions, the individual may practice only in the discipline and scope of practice allowed by the license in the other jurisdiction, and the licensing authority in the State may not require another license unless the individual seeks to practice outside of the authorized discipline or scope of practice. The bill also makes conforming changes and modifies the eligibility requirements for certain expedited licensing procedures.

**Fiscal Summary**

**State Effect:** General and special fund expenditures may increase beginning in FY 2027, as shown and discussed below. General and special fund revenues decrease beginning in FY 2027 due to reduced license fee revenue, as discussed below.

## **Analysis**

### **Bill Summary/Current Law:**

#### *Authorization to Practice Under the Bill for Active Service Members and Spouses*

**Definitions:** “Active service member” means an individual who is (1) an active-duty member of the uniformed services or (2) serving in a reserve component of the uniformed services on active-duty orders. “Licensing authority” means an agency of the State that issues a license. “License” means a license, permit, certification, registration, or other legal authorization required for engaging in an occupation or a profession.

**Application Process:** An application to practice under the authorization in the bill must include:

- proof of the orders;
- for a spouse of a service member, a copy of the marriage certificate; and
- a notarized affidavit affirming under penalty of law that (1) the applicant is the individual described in the application; (2) all statements in the application are true, correct, and complete; (3) the applicant read, understands, meets, and will comply with the requirements for licensure and scope of practice in the State; and (4) the applicant is in good standing in all jurisdictions in which the applicant holds or has held a license.

A qualifying applicant under the bill must also (1) be in good standing with the regulatory authority that issued the license; (2) not be the subject of any disciplinary action (including revocation) taken by a regulatory authority against the applicant regarding the license; (3) not be the subject of a pending investigation relating to unprofessional conduct; and (4) not have voluntarily surrendered the license while under investigation for unprofessional conduct by a regulatory authority.

If the licensing authority cannot review the application within 30 days of receiving it, the licensing authority may issue a temporary license to the applicant that confers the same rights, responsibilities, and privileges as a permanent license while review is pending.

A licensing authority that receives an application may conduct a criminal history records check before authorizing the applicant to practice in the State or issuing a temporary license.

### *Authorizations and Licensure – In General*

Generally, under current law, an individual must be licensed by the appropriate licensing authority before practicing specified occupations in the State. For certain occupations, there are pathways to practicing in Maryland more readily, including through interstate compacts, licensure by reciprocity, and expedited licensure for veterans.

Licensing compacts are legally binding agreements between two or more states that allow providers licensed in one state to practice in another state without requiring an additional license. As of November 2025, the State has entered eight health occupations licensing compacts: the Audiology and Speech-Language Pathology Interstate Compact; the Nurse Licensure Compact; the Interstate Occupational Therapy Licensure Compact; the Interstate Physical Therapy Licensure Compact; the Interstate Medical Licensure Compact; the Counseling Compact; the Psychology Interjurisdictional Compact; and the Social Work Licensure Compact.

Section 1-704 of the Health Occupations Article requires each health occupations board to expedite the licensure, certification, or registration of an active service member, eligible veteran, or eligible spouse. Moreover, a board must assign to each such applicant an advisor to assist with the application process. If an active service member, eligible veteran, or eligible spouse meets the requirements for licensure, certification, or registration, a board must issue the license, certificate, or registration within 15 business days after receiving a completed application. If a board determines that an active service member, eligible veteran, or eligible spouse does not meet the education, training, or experience requirements for licensure, certification, or registration, a representative of the board must assist the applicant in identifying programs that offer relevant education or training or ways of obtaining needed experience. Section 2.5-106 of the Business Regulation Article, Section 6-101.1 of the Education Article, and Section 11-612.2 of the Financial Institutions Article contain similar provisions for other licenses, including educator and mortgage loan originator licenses.

Additionally, Maryland Rule 19-219 “Special Authorization for Military Spouse Attorneys” authorizes a military spouse to practice law in the State under direct supervision of a member of the Maryland Bar if the military spouse is in the State due to military orders.

The bill does not apply to an occupation or profession for which an individual may practice in the State under an interstate compact. Additionally, under the bill, licensing authorities that offer licensure by reciprocity or expedited licensure pathways for veterans may not require an authorized individual to apply for license by reciprocity or expedited licensure.

## *Supervisory Duties*

For certain occupations, under current law, a student, apprentice, or trainee can practice under supervision from a *licensed* individual. The bill alters references to practicing under the supervision of a licensed individual to allow students, apprentices, or trainees to practice under the supervision of *an individual authorized to practice in the State*.

## *Applicable Licenses Under the Bill*

### *Other Provisions*

Under current law, the Automotive Safety Enforcement Division of the Department of State Police must administer an examination to each inspection mechanic applicant. The bill alters that provision such that an individual authorized to conduct vehicle inspections under the bill must not be required to take the examination.

Under current law, to qualify for expedited educator, mortgage loan originator, or health occupations licensure with veteran status, an individual must be one of the following:

- an “eligible veteran,” which is a veteran who was discharged from active duty *within one year* before the date on which the application for a license is submitted, *and does not include a veteran who has been discharged for more than one year before the application is submitted*; or
- an “eligible spouse,” meaning the spouse of an active service member or eligible veteran, which includes the surviving spouse of (1) an eligible veteran or (2) an active service member who died *within one year* before the date on which the application for a license is submitted.

The bill repeals the provisions indicating that a veteran is no longer eligible for expedited licensure if the veteran was discharged from active duty more than one year before applying for licensure, and makes corresponding changes for an eligible spouse.

The bill also updates references to the U.S. Code for revisions to the Servicemembers Civil Relief Act (SCRA).

#### *Servicemembers Civil Relief Act*

Recent changes to the SCRA allow for *professional license* portability for active service members and the spouses of active service members. In general, the provisions in the federal law regarding the application process mirror the procedures established in the bill.

**State Fiscal Effect:** As discussed below, several licensing authorities in the State anticipate additional expenditures for personnel and/or programming changes to implement the bill, in addition to reduced revenues from licensing fees. The Department of Legislative Services advises, however, that because many of the changes in the bill codify the SCRA, some of these fiscal effects may not be directly attributable to the bill, but instead to federal requirements.

#### *Maryland Department of Agriculture*

The Maryland Department of Agriculture advises that most of the licenses for which the bill applies already have no-fee interstate reciprocity, with the exception of veterinarians. The State Board of Veterinary Medical Examiners (SBVME) estimates that no more than 10 active service members and/or spouses will seek licensure as a veterinarian under the bill, and current license fees are \$300 annually. Therefore, special fund revenues may decrease by up to \$3,000 on an annual basis.

SBVME advises that the bill may require modifications to its licensure software to accommodate the new authorization. Based on an estimate from similar projects, special fund expenditures may increase by at least \$15,000 in fiscal 2027 for a one-time software update.

*Maryland State Department of Education*

The Maryland State Department of Education (MSDE) advises that the expanded definition of “eligible veteran” and “eligible spouse” may significantly increase the number of individuals eligible for an expedited license. For context, the department received 487 military designated applications in calendar 2025. Of those applications, 288 were for initial licensure, 49 were for reinstatement, and 150 were for renewal.

To identify eligible veterans, active service members, and their spouses, and ensure the requirements for authorization under the bill are met by applicants, MSDE advises that it needs to hire one part-time administrative aide. MSDE also requires updates to the teacher licensure platform to create an expedited authorization process for active service members and their spouses eligible under the bill; a one-time cost of \$30,000 in fiscal 2027 is anticipated.

Therefore, MSDE general fund expenditures increase by \$67,429 in fiscal 2027, which accounts for the bill’s October 1, 2026 effective date. This estimate reflects the cost of hiring one part-time administrative aide to assist in processing military applications. It includes a salary, fringe benefits, one-time start-up costs, contractual services to update the licensing platform, and ongoing operating expenses.

Future year expenditures reflect a full salary with annual increases and employee turnover as well as annual increases in ongoing operating expenses.

*Maryland Department of Health*

**The Maryland Department of Health did not respond to a request for information on the fiscal and operational impact of the bill.** It is generally assumed that special fund expenditures for several health occupations boards may increase in fiscal 2027 to the extent that licensing systems need to be updated for the new authorization. Additional personnel expenditures may also be incurred to the extent that more individuals qualify for the expedited licensing process available under current law based on the bill’s expansion of eligibility. Additionally, special fund revenues may decrease to the extent that boards experience decreased revenues from licensing fees beginning in fiscal 2027.

### *Judiciary*

The Judiciary advises that the bill necessitates programming changes to its licensing system to account for the new authorization process. Accordingly, general fund expenditures increase by \$189,157 in fiscal 2027 only.

Additionally, certain business licenses are issued by the clerks of the circuit courts, with license fee revenues subsequently distributed to the general fund and the municipal corporation/county where the licensed business is located, as further specified in statute. To the extent that licensing fees are not collected due to the bill's authorization process, State general fund revenues and revenues to local jurisdictions are reduced.

### *Maryland Department of Labor*

The Maryland Department of Labor (MD Labor) advises that the Maryland Home Improvement Commission (MHIC) and Maryland Real Estate Commission (MREC) need to update their licensing systems to implement the bill. Accordingly, a one-time cost of approximately \$12,792 is anticipated in fiscal 2027 only. Additional costs may be incurred for the Office of Financial Regulation.

MHIC and MREC also advise that those individuals authorized to practice in the State under the bill's provisions would likely not contribute to the Guaranty Fund (an additional fee for the fund is assessed at the time of license application and renewal); accordingly, MD Labor special fund revenues may decrease beginning in fiscal 2027.

Other units of MD Labor can update regulations and handle additional applications using existing budgeted resources.

### *Other Agencies*

Other agencies impacted by the bill's changes generally anticipate being able to implement the bill using existing budgeted resources. State revenues associated with other licenses are anticipated to decrease, at least minimally, to the extent that individuals take advantage of the special procedures under the bill to practice under licenses issued in other jurisdictions.

**Small Business Effect:** Some active service members and their spouses who require professional licenses to work for certain small businesses in the State may benefit from the authorization process under the bill, as well as the expanded eligibility for expedited licensing procedures under current law. Small businesses employers may similarly benefit. However, any meaningful benefit is likely attributable to the federal changes to SCRA.
