Budget Overview

The Maryland Consolidated Capital Bond Loan (MCCBL) of 2020 includes general obligation (GO) bond funds for a variety of miscellaneous grants. A few of these grants are contained in separate analyses, but the remainder are presented in this combined analysis. Fiscal 2021 GO bond funds reflected in this analysis total \$48.17 million for 63 projects. Six of these 63 projects were listed in the 2020 *Capital Improvement Program* (CIP) as multi-year commitments. The aggregate future commitment to these projects is programmed at \$30.25 million from fiscal 2022 through 2025. Individual analyses for these project can be found on pages 5 through 13 of this analysis.

While only 6 projects are listed as having multi-year commitments, many of the 63 total projects have received State capital funding in prior year budgets. None of the projects described in this analysis require matching funds to be provided as a condition of the grant. However, most of the projects do require additional funds beyond the amount of the State grant to complete the project. **Appendix 1** provides detail for projects that are not programmed in the 2020 CIP to receive State funds beyond fiscal 2021. **Appendix 2** provides a summary of the status of Maryland Stadium Authority studies approved by the budget committees.

Carroll County Public Safety Training Center, Phase II

Project Description: Phase I of the project was completed in August 2015 with local funds and consisted of the conversion of an emergency operations center building into a classroom education facility as well as construction of a seven-bay vehicle storage building. Phase II of this project will be supported by 50% State funds and 50% local funds, totaling \$7.3 million, or \$3.65 million each. The \$1.0 million proposed for fiscal 2021 would bring the State commitment to \$2.65 million. The 2020 CIP programs another \$1.0 million for fiscal 2022 to complete the State’s commitment to the project. This project will design and construct site improvements, including:

- the replacement of a failing parking lot;
- a new live fire training burn building;
- an outdoor classroom;
- vehicle extrication pads;
- a confined space simulator;
- a trench rescue simulator;
- a drafting pit;
- miscellaneous firefighter props; and
- utility improvements.

The Carroll County Public Safety Training Center is operated by the Carroll County Volunteer Emergency Service Association that represents the 14 volunteer fire, rescue, and emergency medical services in Carroll County, which collectively respond to approximately 20,000 incidents each year, utilizing 700 volunteers. The facility serves not only Carroll County but the surrounding region of Baltimore, Frederick, Howard, and Montgomery counties. The facility also serves other public safety professionals in the region like the Carroll County Sheriff’s Office, the Health Department, and State agencies. During the first year of operation, the facility trained and provided space for committees and meetings for an average of 1,000 individuals each month, for a total of 3,000 hours of training. This project will increase capacity from 1,000 users to 1,250 users each month.

Comments: By increasing the parking by 126 spaces, more training can be held at the facility. In addition, the facility will be Americans with Disabilities Act compliant and will be compliant with storm water management requirements. With development of a new Live Fire Training Burn Building, professional and volunteer firefighters will be able to hone their skills by fighting live, Class “A” type fires within a controlled environment. Additionally, site pads and props for universal first responders (fire, police, and Emergency medical services) will also be developed. Elements such as drafting pits, vehicle extrication, confined space simulators, trench rescue simulators, and Class “B” propane props will be implemented into the project, allowing emergency personnel to be better prepared to respond to and mitigate emergency incidents more effectively and efficiently. The construction of bleachers will provide space where firefighters will have the opportunity to rehydrate, recover, and receive field instruction in accordance with national standards of practice. Additionally, it will provide space for other emergency responders to view the training of fellow companies and learn from other training exercises. In addition, other agencies, such as the Carroll County Sheriff’s Office, will utilize the outdoor training space for their exercises.

Recommendation: Approve.

Hagerstown Revitalization

Project Description: The project will expand and renovate the Maryland Theatre. Expansion of the theatre will expand customer amenities, improve accessibility, and create office and performance space for the Maryland Symphony. This project will be completed in conjunction with the Urban Educational Complex Expansion that involves the redevelopment of a vacant building between the Barbara Ingram School of the Arts and the theatre, allowing the expansion of specialized programs for public school students.

Note: Total State funds are comprised of \$7.5 million of grants for the renovation of the Maryland Theatre and \$15.621 million through the Public School Construction Program for the expansion of the Barbara Ingram School for the Arts. Prior authorized State funds include \$2.9 million for the renovation of the Maryland Theatre and \$15.621 million for the expansion of the Barbara Ingram School of the Arts.

Comments: The MCCBL of 2020 provides \$2.5 million of GO bond funds to the Washington County Board of Commissioners to fund construction of the expansion and renovation of the Maryland Theatre. Total State multi-year support remains at \$7.5 million as programmed in the last three State CIPs. Consistent with this level of support, the remaining State support of \$2.25 million is programmed for fiscal 2022.

This is one component of several projects that will tie into the revitalization of downtown Hagerstown. This project will reconstruct the four-story addition in the front of the Maryland Theatre that burned down in 1972 and is currently being used as a courtyard. The other project is the redevelopment of a vacant building between the Barbara Ingram School of the Arts and the theatre. The estimated cost of the project is \$35.4 million. The theatre expansion and redevelopment projects tie in with future program expansion, student housing, and business development initiatives proposed by the Washington County Board of Education, the University System of Maryland at Hagerstown (USMH), and private developers.

The expansion of the theatre will be completed in conjunction with USMH in developing the Urban Educational Complex Expansion. The State-funded component of the project involves the construction of an educational facility by the Washington County Board of Education. A vacant building between the theatre and the Barbara Ingram School of the Arts will be torn down to provide a site for a new building that will allow the Washington County Board of Education to expand specialized educational programs for public school students. The new building will allow 253 additional students to enroll in various new programs being considered and the possibility of expanding the Barbara Ingram School of the Arts programs and housing USMH programs in the future. The estimated cost of the project is \$19.3 million based on public school funding guidelines.

Recommendation: Approve.

Historic Annapolis

Project Description: Historic Annapolis, Inc. (HA) manages and maintains 11 State-owned historic properties in Annapolis. The proposed authorization funds restore the James Brice House to its original 1774 construction. The work completes the exterior envelope of the building. This includes finishing masonry work, replacing the roof on the east wing, window restoration, cornice work, and lighting protection. The table below shows that \$1 million is provided in fiscal 2021, and another \$4 million is planned in the CIP for fiscal 2022 to 2025, which would be used for interior renovations. If funds are sufficient, HA’s goal is that the building is ready for the public by the end of calendar 2023.

Comments: In April 2018, HA’s Board of Trustees approved the facilities master plan. The plan requires \$3 million annually in maintenance and renovation costs. The CIP provides \$1 million annually. HA may be required to adjust its timeline or modify the scope of this project.

Recommendations: Approve.

Lexington Market Revitalization

Project Description: The MCCBL of 2020 provides a \$2.0 million grant to the Board of Lexington Market, Inc. to assist in the renovation of the existing Lexington Market in downtown Baltimore City. The renovation of Lexington Market will create public market place space for local entrepreneurs and maintain the market as an important fixture in the heart of Baltimore City.

Comments: The State previously provided \$3.85 million to support the Lexington Market renovation including \$500,000 through the Department of Housing and Community Development (DHCD) Community Legacy Program. The State commitment to the project programmed at \$7.35 million in the 2020 CIP remains unchanged from the 2019 session amount. However, a revised project funding plan includes an additional \$1.5 million of Community Legacy grant funds not included in previous funding plans provided to the committees. This increases the level of State support to \$9.35 million. DHCD provides Community Legacy grants on an annual basis through competitive grant application reviews, so to the extent less is received through Community Legacy, the project funding plan would have to be adjusted.

The construction phase is significantly delayed from what was presented to the committee in the 2018 session, which scheduled construction to commence in the later part of calendar 2018 and take approximately 18 months to complete. While still scheduled to take 18 months, construction is not currently scheduled to commence until February 2020.

Recommendation: Approve.

Maryland Zoo in Baltimore

Project Description: The Maryland Zoo was founded in 1876 and is the third-oldest zoo in the country. It occupies 45 acres of the 135-acre parcel in Baltimore City in Druid Hill Park. The table below shows that the fiscal 2021 grant is \$4.75 million, and \$19 million is planned for the fiscal 2022 to 2025 period in the 2020 CIP. The zoo’s operating grant, which is budgeted in the Board of Public Works (BPW), receives an additional \$250,000 in fiscal 2021 to support capital costs that may not qualify for GO bonds so that the zoo gets a total of \$5 million in fiscal 2021 for its capital program.

The zoo maintains a list of needed improvements that are grouped into three categories:

- \$3.18 million for basic infrastructure improvements including:
 - \$1,140,000 to renovate parking lots A and B. This is the second year of a six-year renovation that also addresses storm water draining;
 - \$950,000 to address deficiencies identified by the U.S. Department of Agriculture, Associations of Zoos and Aquariums, as well as federal law change;
 - \$570,000 to replace the Mansion House’s exterior steps;
 - \$238,000 to upgrade electrical infrastructure at the Waterfowl Lake and Visitor Services trailer;
 - \$190,000 to replace roofs on buildings throughout the zoo; and
 - \$95,000 to design and install an emergency backup generator.

- \$1.14 million for strategic service improvements to renovate the 90-year-old Waterfowl Pavilion, including regrading the ground and replacing the pavilion floor, water fountains, and exterior lighting. This is the final year of a two-year project; and
- \$0.43 million to improve exhibits and attractions by renovating the Maryland Wilderness Reptile/Amphibian exhibit. Improvements include new lighting, drainage, and heating upgrades. This is the final year of a three-year project.

Recommendations: Approve.

National Aquarium in Baltimore

Project Description: The National Aquarium in Baltimore City’s Inner Harbor opened in 1981. The aquarium is 250,000 square feet (SF) and has more than 2.4 million gallons of water. The fiscal 2021 authorization supports repairing the glass pyramid above the rain forest exhibit and upgrading other infrastructure. The aquarium has completed a multi-year capital improvement plan to address infrastructure repairs. The following table shows the plan that proposes that the State provide \$8 million to fund 23% of the repairs.

The rain forest exhibit is approximately 23,000 gross SF with 15,000 SF of glazed glass. The glass pyramid above the rain forest is 40 years old. The project will replace the 684 glass double-panes. Predesign of the pyramid replacement has begun.

While the rain forest pyramid is the most urgent project, the aquarium advises that is that it has documented over \$50 million in infrastructure upgrades over the next eight years. Projects that are expected to begin during the next fiscal year include:

- replacing vertical pumps on Pier 3 that service Black Tip Reef and Shark Alley;
- replacing HVAC units that are located above animal tanks and certain galleries;
- replacing air cooled chillers with flat plate heat exchangers that service tanks;
- upgrading the electrical infrastructure that services the digital identification systems; and
- upgrading interpretive graphics in some of the exhibits.

Recommendation: Reduce and add preauthorizations for fiscal 2022 and 2023.

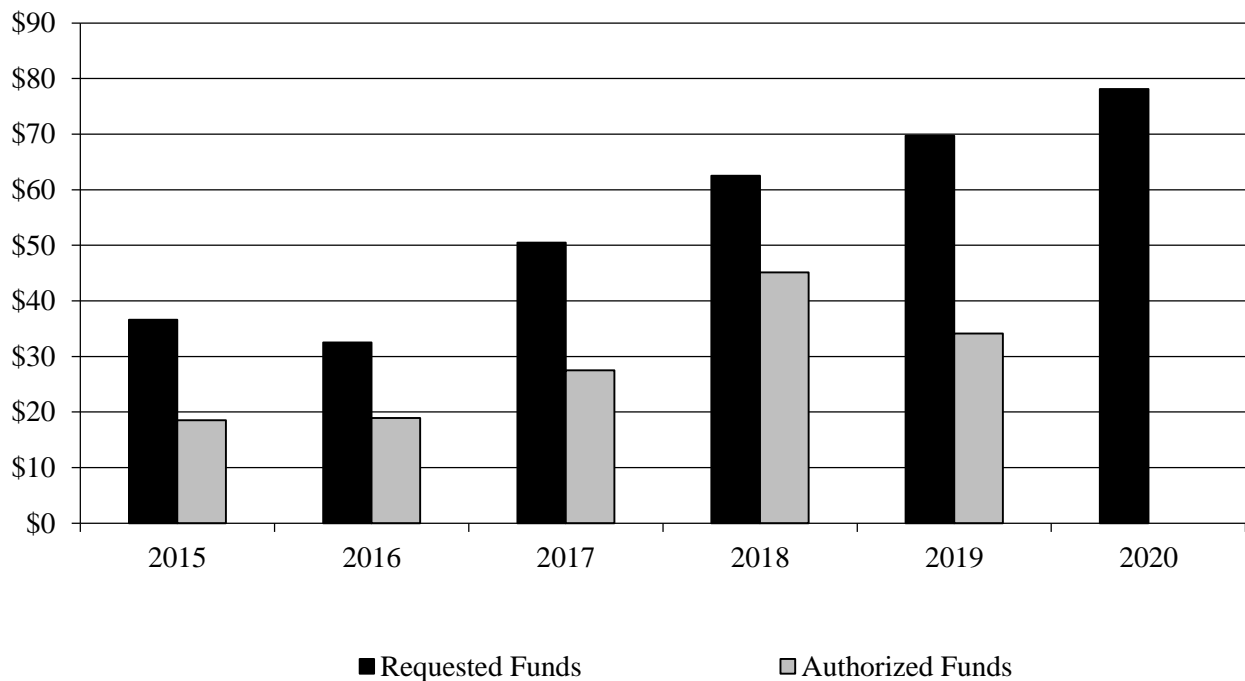
Local Initiatives

Legislative Bond Initiative Requests for the 2020 Session

Each legislative session, legislators are called upon to sponsor legislative bond initiatives (LBI) that provide State capital grants to a variety of local organizations throughout the State. The Governor’s fiscal 2020 capital budget does not include a set aside of bond funds for such projects; as of March 2, 2020, a total of 278 grant requests have been made totaling \$78.1 million of State funding.

Exhibit 1 shows funding provided for local initiative projects for the 2015 through 2019 sessions and the amount requested for the 2020 session. Annually, the amount of funding requested exceeds total authorized funding.

Updates and Issues

1. Lake Linganore Dredging

For the past several years, the city of Frederick has pursued State participation in the development of a new 183-room downtown hotel, 20,000 SF conference center, and public parking and related infrastructure. In the 2016 and 2017 sessions, the State authorized \$1.0 million and \$4.0 million, respectively, but neither authorization has been used because the execution of the grants and required BPW approval has not been allowed to proceed. The 2020 session capital budget bill includes amendments to these authorizations to redirect the use of the funds to support the dredging and removal of sediment in Lake Linganore, located in Frederick County.

Lake Linganore, a man-made reservoir used for recreational purposes, is the main drinking water supply for the city of Frederick and a backup source of drinking water for Frederick County. The city of Frederick, Frederick County, and the Lake Linganore Association partnered to fund the dredging project, which is currently underway through a contract with the Maryland Environmental Service. The current project, without State funding, dredges 130,000 cubic yards of sediment and costs \$18.0 million, as outlined below:

- **City of Frederick:** \$9.0 million, or 50%;
- **Frederick County:** \$4.5 million, or 25%; and
- **Lake Linganore Association:** \$4.5 million, or 25%.

The project is being designed to address the drought of record, which was in the 1960s. Therefore, this additional funding from the State would help increase the number of years that the project provides a safe yield of drinking water, which in this case is 6 million gallons per day. The 6 million gallons per day of drinking water can only be ensured during drought conditions if Lake Linganore is restored to closer to the 820 million gallons of the design capacity. The long-term capacity of Lake Linganore will be determined by the rate of sedimentation. According to the U.S. Geological Survey, the sedimentation rate for Lake Linganore is rather low in comparison to other Maryland Piedmont reservoirs, but 86% of the fine-grained sediment in Lake Linganore was eroded from agricultural land, which will be an ongoing challenge to maintaining the lake's design capacity.

The project is currently in a winter hiatus, but some spring 2020 work will continue through the summer until it is estimated that the current funding will be fully expended. By providing \$2,500,000 in fiscal 2021, which starts June 2020, the project could continue work until a preauthorization of \$2,500,000 for fiscal 2022 would become available in June 2021. **The Department of Legislative Services (DLS) recommends that the funding for the Lake Linganore dredging project be reduced by \$2,500,000, leaving \$2,500,000 in fiscal 2021. In addition, DLS recommends that a preauthorization of \$2.5 million in GO bonds be authorized for fiscal 2022.**

2. Status of Legislative Preauthorizations for Miscellaneous Capital Grants

The MCCBL of 2019 included several preauthorizations for fiscal 2021 for miscellaneous projects. **Exhibit 2** shows the funding levels proposed by the Governor and requested funding through the sponsorship of an LBI in the 2020 session for each project.

3. Capital Grant Administration Improvements

The fiscal 2020 capital budget authorized funds for 310 capital grant awards to be managed by the Department of General Services (DGS). The number of State-funded capital grants authorized each session continues to increase on a year-over-year basis. The department advises that it actively manages \$1.4 billion in grants. In response to concerns about how efficiently DGS is managing grants administration, the budget committees requested a review of the program in the fiscal 2020 *Joint Chairmen’s Report*, which required that a workgroup of DGS, the Department of Budget and Management, the State Comptroller’s Office, the Office of the Attorney General, and DLS staff be formed to review the program. DGS submitted the report to the budget committees in September 2019. The report recommended that:

- ***The Capital Grants Handbook Be Updated to Reflect New Legislation and Policies:*** This includes a redesigned workflow to simplify the process prior to issuing the new handbook. (**Appendix 3**).
- ***DGS Enforce Compliance and Have Sufficient Staffing:*** DGS now offers “Demystifying the Capital Grants Process” workshops. DGS has hired a policy and compliance specialist, and the group recommended adding 2 full-time grant administrators and 1 part-time compliance specialist position to help with the increased workload and improve operations. The budget includes 1 of the full-time administrator positions.
- ***Technology Be Used to Improve Workflow; Document Management, Records Management and Retention; and Expeditiously Provide Status Updates to Grant Recipients and Other Stakeholders:*** DGS has procured a subscription to SurveyMonkey Apply Professional, an online grant application and workflow management tool. The system is used to manage the 310 grant awards in the fiscal 2020 capital budget bill and will be used for the fiscal 2021 capital budget bill as well. Prior years are being migrated so that those recipients can also access the system.

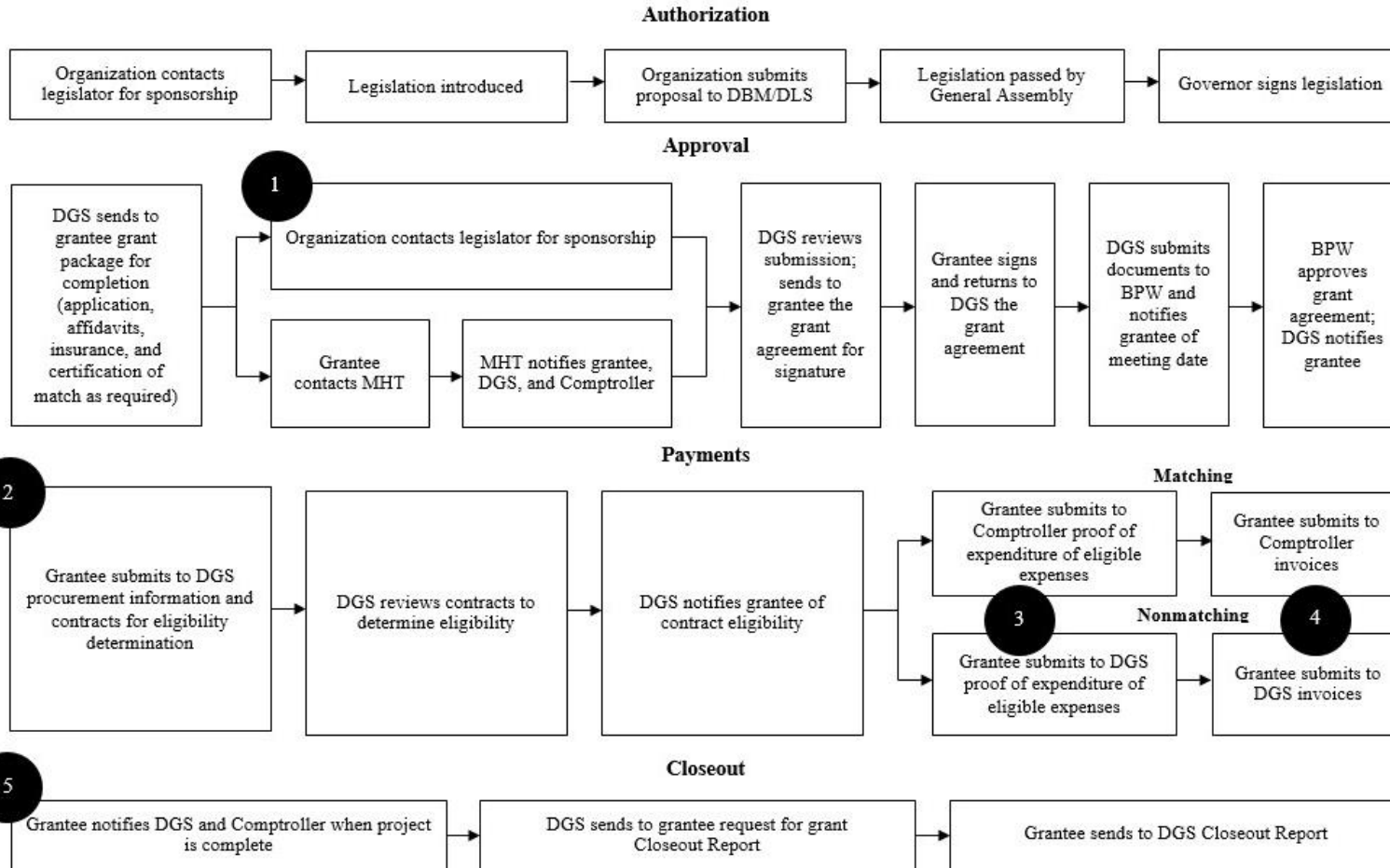
