## Report of the Conference Committee on House Bill 588

## The Budget Bill

April 2, 2021

Mr. President, Ladies and Gentlemen of the Senate:

Madam Speaker,

Ladies and Gentlemen of the House of Delegates:

The Conference Committee has reconciled the differences between the House and Senate versions of HB 588 and Supplemental Budgets No. 1 through No. 4, in which the House made general fund reductions of \$656.8 million, including \$122.1 million contingent on the Budget Reconciliation and Financing Act (BRFA) of 2021, and the Senate made general fund reductions of \$648.4 million including \$120.2 million contingent on the BRFA of 2021. The Conference Committee also received Supplemental Budget No. 5. In all, the Conference Committee made general fund reductions of \$522.1 million, including \$330.2 million contingent on the BRFA of 2021.

The House adopted 122 amendments to the budget bill including Supplemental Budgets No. 1 through No. 4. The Senate subsequently adopted 75 amendments to the budget bill, as amended by the House. The House concurred with none of the Senate amendments. All of these amendments have been reconsidered, and actions, including those taken to Supplemental Budget No. 5, are indicated in the attached *Report of the Conference Committee*.

The total operating growth in State spending is 4.0%, and the budget expands funding for core State services and priorities including public education, Medicaid, human services, and State employee compensation, as well as identifying funding for legislative priorities. The budget more than meets the guidelines established by the Spending Affordability Committee in 2020.

The budget also reflects significant investments in both fiscal 2021 and 2022 for both the health response to the COVID-19 pandemic as well as addressing the economic dislocation resulting from the pandemic, primarily as a result of available federal stimulus funding. In total, the final budget includes an additional \$5.8 billion in federal funds compared to the budget as introduced in January.

The projected general fund balance at the close of fiscal 2022, given the legislative actions on the budget, is \$696 million. The Rainy Day Fund balance is \$1.355 billion. Together, this leaves almost \$2.1 billion in cash reserves, a prudent hedge against potential uncertainty and leaving the budget in a projected balance posture for several years.

The Senate adopted 75 amendments to the budget bill, as amended by the House.

The House rejected all of the Senate amendments and called for a Conference Committee.

The Senate refused to recede and agreed to a Conference Committee.

The budget was then referred to the Conference Committee.

#### Conference Committee Amendment No. 1

On page 3 of the Committee Reprint, under the heading Judiciary, adopt Amendment 1; and on the same page, under the heading Judiciary, in program C00A00.04 District Court, following line 31, insert "Further provided that \$1,000,000 in general funds are added for the purpose of increasing the pay rate for appointed attorneys. These funds may be expended only for the purpose of providing attorneys for required representation at initial appearances before District Court Commissioners consistent with the holding of the Court of Appeals in DeWolfe v. Richmond. This report shall contain the following information:

- (1) an overview of the processes established by Chapter 225 to determine MOE for Amoss Fund disbursements;
- (2) identification of the three-year base period and the fiscal 2020 actual expenditures for each jurisdiction;
- (3) <u>identification of whether each jurisdiction has met the necessary MOE requirement</u> established by Chapter 225 for fiscal 2020 actual expenditures; and
- (4) for each jurisdiction which fails to meet the MOE requirement for fiscal 2020:

- (a) the dollar amount and percentage by which that jurisdiction fails to meet the requirement;
- (b) the fiscal 2022 disbursement prior to the application of a penalty;
- (c) the amount of the penalty to be applied to the fiscal 2022 disbursement; and
- (d) the fiscal 2022 disbursement after the application of a penalty.

This report shall be submitted to the budget committees no later than December 15, 2021. The budget committees shall have 45 days from the date of the receipt of the report to review and comment. Funds not expended for this restricted purpose may not be transferred by budget amendment or otherwise to any other purpose and shall revert to the General Fund if the report is not submitted".

#### Conference Committee Amendment No. 4

On page 37 of the Committee Reprint, under the heading Office of the Comptroller, in program E00A01.01 Executive Direction, adopt Amendment 12, and in line 4 following "Appropriation" insert ", provided that \$400,000 of this appropriation made for the purpose of administration may not be expended for that purpose but instead may be used only for the purpose of the oversight of the distribution and expenditure of federal and State stimulus funds provided for the purpose of pandemic relief in Maryland. Funds not expended for this restricted purpose may not be transferred by budget amendment or otherwise to any other purpose and shall revert to the General Fund.

Further provided that \$100,000 of this appropriation made for the purpose of administration may not be expended until the Comptroller of Maryland submits quarterly reports to the budget committees beginning on July 1, 2021 which shall include:

- (1) a full accounting of federal and State economic stimulus funds provided for pandemic relief received by business type and jurisdiction;
- (2) an update on investigative and fraud monitoring efforts taken by the agency in relation to the proper expenditure of federal and State stimulus funds provided for pandemic relief; and
- (3) any fraud identified through these monitoring efforts and the actions taken by the agency to recoup funds improperly utilized.

Further provided that funding restricted for this purpose may not be released until the receipt of all four quarterly reports by the budget committees. The budget committees shall have 45 days from the date of the receipt of the report to review and comment on the submitted quarterly reports. Funds restricted may not be transferred by budget amendment or otherwise to any other purpose and shall revert to the General Fund if all of the reports are not submitted".

On page 62 of the Committee Reprint, under the heading State Highway Administration, in program J00B01.01 State System Construction and Equipment, adopt Amendment 17, and strike beginning with "Better" in line 5 down through "(BUILD)" in line 7 and substitute "project-specific".

#### Conference Committee Amendment No. 6

Funds not expended for this restricted purpose may not be transferred by budget amendment or otherwise to any other purpose and shall revert to the General Fund.".

On page 33 of Supplemental Budget No. 5, under the heading Maryland Department of Labor, in Item 133, program P00G01.07 Workforce Development, add the following language to the federal fund appropriation ", provided that the Maryland Department of Labor shall distribute funds directly to local workforce development boards according to the same formula used to distribute fiscal year 2022 Federal Workforce Innovation and Opportunity Act adult funds to local workforce areas."

## Conference Committee Supplemental Budget Amendment No. 7

On page 36 of Supplemental Budget No. 5, under the heading of State Department of Education, in Item 146, program R00A02.60 Blueprint for Maryland's Future Grant Program, add the following language to the federal fund appropriation ", provided that \$25,000,000 of this appropriation made for the purpose of providing grants for summer school programs for those students most affected by learning loss shall be distributed based on each local education agency's proportionate share of the total fiscal 2021 Compensatory Education funding and used in accordance with Section 4 of HB 1372, contingent on the enactment of HB 1372."

On page 38 of Supplemental Budget No. 5, under the heading State Department of Education, in Item 157, program R00A07.02 Capital Appropriation – Interagency Commission on School Construction, add the following language to the general fund appropriation ", provided that these funds may only be used for the purpose of making grants for school security improvements and shall be distributed to county boards in accordance with § 5–317 of the Education Article. Further provided that funds shall be administered by the Maryland Center for School Safety."

## Conference Committee Supplemental Budget Amendment No. 15

On page 38 of Supplemental Budget No. 5, under the heading State Department of Education, in Item 158, program R00A07.02 Capital Appropriation – Interagency Commission on School Construction, add the following language to the general fund appropriation, ", grants may be provided only to nonpublic schools that were eligible to participate in Aid to Non–Public Schools R00A03.04 (for the purchase of textbooks or computer hardware and software for loans to students in eligible nonpublic schools) during the 2020–2021 school year or nonpublic schools that serve students with disabilities through the Non–Public Placement Program R00A02.07 Subprogram 0762, with a maximum amount of \$65 per eligible nonpublic school student for participating schools, except that at schools where at least 20% of the students are eligible for the free or reduced–price meal program or for schools that service students with disabilities though the Non–Public Placement Program, there shall be a distribution of \$85 per student and no individual school may receive less than \$5,000. Payment for work completed under this program will be through reimbursement to the grant recipient. Further provided that these grants will be administered by the Maryland Center for School Safety.".

On page 45 of Supplemental Budget No. 5, under the heading State Reserve Fund, in Item 188, program Y01A02.01 Dedicated Purpose Account, add the following language to the general fund appropriation ", provided that \$50,000,000 of this appropriation made for the purpose of relocation of agencies from State Center may be expended only for the purpose of relocating agencies into other locations in Baltimore City.
