The Museum has long desired to expand its presence in Middle River with a stand-alone facility with easy access to public roads, creating a valued, engaging go-to site for tourists while enriching the community with a quality of life anchor and economic engine resource. It is committed to be an inspirational force of the Middle River community, preserving and promoting its Glenn L. Martin aviation legacy and the history of Maryland's contribution to aerospace. This 33 year old education and cultural institution is the living connection to the rich heritage of this area - a place that brought aeronautics to the world; the first transoceanic flying boat, The China Clipper; the men and women (workers and neighbors) who by their efforts saved the nation; and a company that helped launch men and women into space. It is the mission of the Glenn L Martin Maryland Aviation Museum to educate, inspire and preserve, assuring that the world will remember the importance of this location, its people, its aviation pioneers and their stories.

With the closing of Lockheed Martin's Middle River complex, the Museum received a welcomed opportunity with the availability of an expansion venue, one that would serve as a community anchor, contributing to enrich the quality of life experience of Middle River and its surrounding region, enhance educational opportunities in regional school systems, and would set Middle River and eastern Baltimore County as a "must visit" tourist attraction destination. Funds for repurposing the 117,966 s.f 1986 building into a world class center of learning, preservation and achievement would be designated for planning, design, renovation, reconstruction, site improvement, and capital equipping.

Glenn L. Martin's name and legacy have been an integral developer of the Eastern Baltimore County area since Mr. Martin's arrival in 1929 with the goal to build an aircraft manufacturing facility. His facility impacted the surrounding area of his assembly plant by providing thousands of jobs, contributing to community development with housing and business expansions, and with his offerings of activities for his employees during non-working hours, he enriched their quality of life during a challenging time in history. As the Museum carries on his legacy, it will look to the past to regenerate its community with an historically connected to the space flight era Lockheed Martin Building "E", providing an innovative center of activity for all ages, an interactive experience to engage visitors, and a dream factory to capture the imagination of young visitors and propel them on to aerospace possibilities.
