Report of the Conference Committee on House Bill 350

The Budget Bill

April 7, 2025

Mr. President, Members of the Senate:

Madame Speaker, Members of the House of Delegates:

The Conference Committee has reconciled the differences between the House and Senate versions of HB 350 and Supplemental Budget No. 1, in which the House made general fund reductions of \$1.6 billion, including \$524.1 million contingent on the Budget Reconciliation and Financing Act (BRFA) of 2025, and general fund additions of \$229.1 million; and the Senate made general fund reductions of \$1.6 billion, including \$516.7 million contingent on the BRFA, and general fund additions of \$235.8 million. The Conference Committee also received Supplemental Budget No. 2. In all, the Conference Committee made general fund reductions of \$1.5 billion, including \$543 million associated with the BRFA, and general fund additions of \$224 million.

The House adopted 199 amendments to the budget bill including Supplemental Budget No. 1. The Senate subsequently adopted 71 amendments to the budget bill, as amended by the House. The House concurred with none of the Senate amendments. All of these amendments have been reconsidered, and actions, including those taken on Supplemental Budget No. 2, are indicated in the attached *Report of the Conference Committee*.

The total decrease in general fund spending is \$400 million (1.5%). The budget restores funding, including through rejecting proposed reductions in the budget, for legislative priorities including the Developmental Disabilities Administration, cancer research by the Statewide Academic Health Centers, and victims of crime assistance. The budget also supports general salary increases for all State employees and salary increments for employees in bargaining units. The budget meets the guidelines established by the Spending Affordability Committee in 2024.

The budget also makes significant investments in solutions to address climate change and efforts to grow the private-sector economy. The budget also provides additional support for infrastructure through capital investments.

The projected general fund balance at the close of fiscal 2026, given the legislative actions on the budget, is \$317 million. The Rainy Day Fund balance is \$2.1 billion. Together, this leaves \$2.4 billion in cash reserves, a prudent hedge against potential uncertainty.
