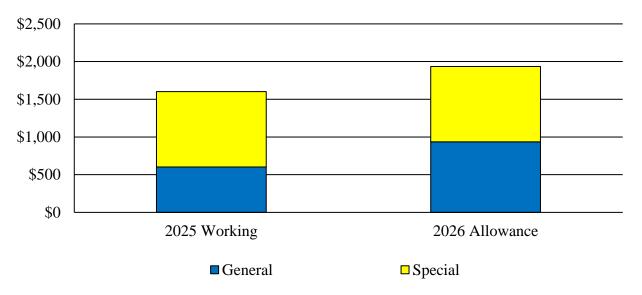
D74 Office of the Correctional Ombudsman

Program Description

The Office of the Correctional Ombudsman (OCO) is an independent oversight entity responsible for conducting investigations, assessments, and reviews to ensure the integrity of operations within the Department of Public Safety and Correctional Services (DPSCS) and the Department of Juvenile Services (DJS). OCO has the authority to refer investigations for criminal charges if it uncovers illegal acts. The ombudsman will implement procedures to help minimize risks to the health, safety, and welfare of incarcerated individuals, in addition to advising incarcerated persons, family members, and others regarding the rights of incarcerated individuals.

OCO oversees the new Adult Oversight Responsibility Unit and the Juvenile Justice Monitoring Unit (JJMU), which was previously budgeted under the Office of the Attorney General (OAG) and covered in the C81C – OAG analysis. The Adult Oversight Responsibility Unit oversees and investigates the wellbeing of adults under DPSCS jurisdiction and custody, while JJMU does the same for children under DJS supervision.

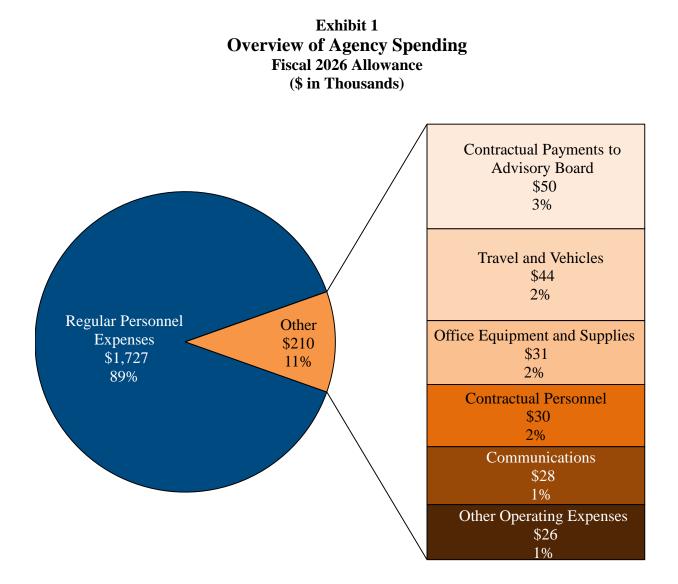
Establishment of OCO

Chapter 836 of 2024 established OCO effective July 1, 2024. The Act required the transfer of 4 JJMU positions and \$603,067 in general funds from OAG. Chapter 836 also expressed the legislature's intent that the Governor include an appropriation sufficient to fund the Act's provisions and to provide for at least 2 staff members for OCO in fiscal 2025 and at least 7 staff members in fiscal 2026 and each subsequent year. Furthermore, the Act provided that OCO will be guided by the 12-member Correctional Ombudsman Advisory Board.

Section 21 of the fiscal 2025 Budget Bill (Chapter 716 of 2024) appropriated \$1.0 million in special funds from the Performance Incentive Grant Fund in the Department of Budget and Management. The budget language provided the special funds to support startup costs for OCO and the Adult Oversight Responsibility Unit and authorized the funds to be transferred to an independent program. A fiscal 2025 budget amendment transferred the funding to OCO.

Fiscal 2026 Overview of Agency Spending

The fiscal 2026 allowance proposes approximately \$1.9 million in total spending for OCO. The majority of expenditures, 89%, supports personnel costs. The budget also includes \$50,400 for contractual payments for the Correctional Ombudsman Advisory Board. The advisory board currently has 4 of its 12 members appointed. **Exhibit 1** displays the fiscal 2026 allowance categorized by spending area.

Proposed Budget Change

The fiscal 2026 allowance increases by \$333,283, or 20.8%, from the fiscal 2025 working appropriation after accounting for a reduction of \$1.0 million in general funds contingent on a provision in the Budget Reconciliation and Financing Act (BRFA) of 2025. Personnel costs make

up a net \$156,862, or 47%, of the increase. Other increases fund additional operating costs of the office. The proposed budget changes are illustrated in **Exhibit 2**.

Budget Reconciliation and Financing Act

The BRFA of 2025 includes a provision that authorizes the use of up to \$1.0 million from the Performance Incentive Grant Fund for OCO operations each year, beginning in fiscal 2026. The fund is administered by the Justice Reinvestment Oversight Board, subject to the authority of the Executive Director of the Governor's Office of Crime Prevention and Policy. The fiscal 2026 budget as introduced includes a \$1.0 million general fund reduction and a corresponding \$1.0 million special fund appropriation under OCO, both contingent on the enactment of legislation authorizing the use of the Performance Incentive Grant Fund for OCO.

Personnel Data

- In fiscal 2025, 4 positions supporting JJMU were transferred from OAG to OCO, while 3 new positions were created by the Board of Public Works. OCO also received 6 contractual administrative positions. One of the full-time regular positions established in fiscal 2025 is the acting correctional ombudsman, who was appointed in September 2024.
- In fiscal 2026, all contractual positions are converted to full-time regular positions, bringing the total number of regular positions to 13. Personnel mostly includes administrative and program management positions.
- As of December 31, 2024, OCO reported no vacancies among its 7 regular positions in fiscal 2025.

Key Observations

1. Information Technology and Managing for Results Development

OCO has been working to establish its website, as required by Chapter 836 of 2024. The website will feature OCO reports and streamline the process for filing complaints for investigations. The website goes hand-in-hand with OCO's need for a case management system, which would enhance transparency and improve OCO's ability to track trends, identify relevant policies, and respond to inquiries and complaints. OCO has stated that it has been consulting with the Department of Information Technology (DoIT), other State agencies, and ombudsmen in other states to understand best practices and select the most effective case management system. As of January 2025, OCO and DoIT do not have an estimate for the time or cost of either the website or the case management system, but OCO hopes to have them running by the end of fiscal 2026. OCO is currently using an internal process to track complaints and is publishing reports to the Office of the Governor's website.

As a new agency, OCO has not yet specified or reported its key goals, objectives, and performance measures through a Managing for Results (MFR) submission. OCO should specify what measures that it is able to track with the resources currently available and discuss the goals and performance measures that will be reported in future MFR submissions.

Operating Budget Recommended Actions
