Clarifying the authority, powers, and duties of officers and employees of the Field Enforcement Division in the Office of the Executive Director of the Alcohol and Tobacco Commission over certain matters; authorizing the officers and employees to make certain cooperative arrangements with the Office of the Comptroller; authorizing the Division to recommend certain changes to improve the administration of certain provisions; authorizing the Executive Director to delegate certain duties to certain persons; etc.

HEALTH INSURANCE – POLICY OF GROUP HEALTH INSURANCE – ASSOCIATIONS

Clarifying that, for purposes of provisions of law concerning health insurance, a chamber of commerce may be considered an association; repealing certain provisions of law that apply certain provisions of law governing small group market plans to health benefit plans offered by certain entities; applying the Act to policies, contracts, and health benefit plans issued, delivered, or renewed in the State on or after January 1, 2021; etc.

Repealing certain requirements that a person be a resident for a certain period of time, a taxpayer, or a registered voter to be issued certain statewide alcoholic beverages licenses and permits; requiring that a person, to be issued a certain statewide license or permit, remain a resident for the duration of time that the license or permit is in effect; repealing from certain local alcoholic beverages licenses certain durational residency requirements; making conforming changes; declaring the intent of the General Assembly; etc.

Authorizing a trustee to send certain interested parties in a certain manner a certain report when the trust terminates or on the resignation or removal of the trustee; and providing that, if an interested party does not submit an objection to the report within 90 days after the trustee mailed the report, the interested party shall be deemed to have released the trustee and to have consented to and ratified the actions of the trustee; etc.

Allowing certain taxpayers with federal adjusted gross income for the taxable year that is \$6,000 or less to claim a credit against the State income tax for certain dependent children under certain circumstances; providing that the credit is equal to \$500 for each qualified child; allowing certain taxpayers to claim a refund in the amount of any excess credit; applying the Act to taxable years beginning after December 31, 2019, but before January 1, 2025; etc.

Requiring certain hospitals to provide each patient with a certain written notice related to outpatient facility fees that are charged for services provided at the hospital that is in a certain form; requiring that certain notices be provided to certain patients in certain manners and at certain times; requiring each hospital that charges an outpatient facility fee to use a certain range of fees and fee estimates; etc.

Requiring the Motor Vehicle Administration to adopt certain guidelines for the operation of a motorcycle on a roadway that is divided into two or more clearly marked lanes for vehicular traffic; and repealing certain provisions of law that prohibit an operator of a motorcycle on certain roadways from overtaking and passing in the same lane occupied by the vehicle being overtaken and from operating a motorcycle between lanes of traffic or between adjacent lines or rows of vehicles.

Altering the definition of "practice dentistry" to include the collection of oral saliva samples to screen for lead poisoning; authorizing a dentist to collect oral saliva samples to screen for lead poisoning in individuals under the age of 19 years; requiring a dentist to send a certain sample for analysis to a certain laboratory; requiring a dentist to send a certain notice to certain parents or legal guardians on receipt of the results of a certain saliva lead poisoning screen test; etc.

Establishing that, for certain areas of water or land or easements that have been subdivided in Garrett County or Allegany County, the Department of Natural Resources may acquire the area only if the acquisition of the area will not, when added to the acreage of any other areas or easements the Department has acquired from that subdivision over the previous 5 years, exceed 100 acres, subject to approval by the county.

Requiring the Maryland Health Care Commission to publish a certain notice of the closing or partial closing of a certain hospital or freestanding medical facility within a certain time period; requiring the Commission to ensure that a certain notice is available to the public for certain purposes and provided to a certain local governing body and certain members of the General Assembly; requiring the Commission to publish a notice of certain informational meetings; etc.

Establishing a gift basket permit in Baltimore County; authorizing the Board of License Commissioners for Baltimore County to issue the permit to certain persons; providing that the permit authorizes a permit holder to sell and deliver gift baskets containing wine to consumers of a legal drinking age in the State; requiring a permit holder to maintain certain records and submit certain reports; limiting the value of the wine contained in a gift basket to 75% of the total value of the gift basket; etc.

Requiring the Public Service Commission to develop a training and educational program for certain licensed energy suppliers; requiring the Commission to develop the program in consultation with certain interested stakeholders, including electricity suppliers and gas suppliers;; requiring designated representatives to demonstrate a thorough understanding of certain Commission regulations; requiring the Commission to conduct an examination at the conclusion of training and provide certification on a satisfactory score; etc.

Requiring a person who provides property management services to be registered as a property manager by the State Real Estate Commission before practicing in the State; prohibiting the providing of, attempting to provide, or offering to provide property management services unless registered with the Commission as a property manager; subjecting violators of this prohibition to a civil fine of not more than \$1,000; requiring certain property managers to be covered by a certain surety bond; etc.

Requiring the Governor to include in the annual budget for fiscal year 2022 and each fiscal year thereafter an annual appropriation of \$17,000,000 for the Maryland Health Benefit Exchange; and requiring the appropriation to be allocated in a certain manner to fund certain subsidies and activities.

This bill requires a mandated appropriation in the annual budget bill.

Altering a certain prohibition to apply only to a person at least 18 years old, against knowingly promoting, advertising, soliciting, distributing, or possessing with the intent to distribute any matter, visual representation, or performance that depicts a minor engaged as a certain subject or in a manner that reflects a certain belief or is intended to cause another to adopt a certain belief.

Requiring the Comptroller to distribute the sales and use tax revenue on the sale or use of certain digital products to the Education Trust Fund; defining "digital product" as one that is obtained electronically by the buyer and delivered by certain means through the use of technology having electrical, digital, magnetic, wireless, optical, electromagnetic, or similar capabilities; applying the sales and use tax to a sale or use of certain digital products; providing that the sales and use tax does not apply to a certain service; etc.

Providing that an advanced practice registered nurse is not precluded from delegating a nursing task to an unlicensed individual under certain circumstances; and providing that a registered nurse, a licensed practical nurse, or an advanced practice registered nurse is not precluded from delegating a nursing task to an assistant with medical training if the assistant performs only tasks that the assistant is trained and able to perform and the delegating nurse provides certain instruction and supervision.

Authorizing a certain formulary developed by the Naturopathic Doctors Formulary Council and adopted by the State Board of Physicians to include certain prescription drugs and devices; authorizing a licensed naturopathic doctor to dispense, order, or administer certain natural medicines in a certain manner; authorizing a licensed naturopathic doctor to prescribe, dispense, and administer certain prescription drugs and medical foods in a certain manner; etc.

Requiring the Office of Home Energy Programs, in coordination with the United Way of Central Maryland and the Fuel Fund of Maryland, to establish the Power to the People Pilot Program on or before July 1, 2021 to expand access to the Critical Medical Need Program; requiring the Pilot Program to provide training for certain individuals to serve as navigators under the Critical Medical Needs Program; requiring the United Way of Central Maryland to develop a certain screening intake process; etc.

This bill requires a mandated appropriation in the annual budget bill.

STATE BOARD OF DENTAL EXAMINERS – PRACTICE OF DENTISTRY – REVISIONS

Requiring a dental practice to be owned by a licensed dentist or a dental professional corporation; establishing that only a certain individual licensed by the State Board of Dental Examiners may take certain actions; prohibiting any person who is not a licensed dentist to direct, control, or interfere with the independent professional judgement of a dentist or dental hygienist regarding the care of a certain patient; prohibiting a licensed dentist from sharing revenues or splitting fees except under certain circumstances; etc.
