# **SENATE BILLS INTRODUCED January 20, 2020**

#### SB 235 Senator West

CRIMINAL LAW – ATTEMPT TO COMMIT SECOND-DEGREE MURDER – PENALTY

Increasing, from 30 to 40 years, the maximum term of imprisonment that may be imposed for the offense of attempt to commit second—degree murder.

TEACHERS' RETIREMENT AND PENSION SYSTEMS – OBSOLETE REEMPLOYMENT PROVISIONS

Repealing certain obsolete provisions relating to the reemployment of certain teachers and principals who are retirees of the Teachers' Retirement and Pension Systems.

# SB 237 Senator Hough, et al

VEHICLE LAWS – PROTECTIVE HEADGEAR REQUIREMENT FOR MOTORCYCLE RIDERS – EXCEPTION

Providing that the prohibition against operating or riding on a motorcycle without certain protective headgear does not apply to an individual at least 21 years old who has been licensed to operate a motorcycle for at least 2 years, has completed a certain motorcycle safety course, or is a passenger on a motorcycle operated by a driver who has been licensed for at least 2 years or has completed a certain motorcycle safety course.

# SB 238 Carroll County Senators

CARROLL COUNTY – ALCOHOLIC BEVERAGES – HOURS AND DAYS FOR CONSUMPTION AND SALE

Altering the hours and days for consumption and sale, in Carroll County, for certain alcoholic beverages licenses.

Establishing a small yacht club alcoholic beverages license in Anne Arundel County; authorizing the Board of License Commissioners to issue the license for use by a small yacht club that meets certain criteria; specifying that the license authorizes a license holder to sell beer, wine, and liquor to members and their guests for on–premises consumption under certain circumstances; authorizing a license holder to purchase alcoholic beverages from a retail dealer; specifying an annual license fee of \$525; etc.

Requiring the Board of County Commissioners of Allegany County, rather than the Governor, to fill a vacancy in an elected member's position on the Allegany County Board of Education for the remainder of that term and until a successor is elected and qualifies.

#### MARYLAND HEALTHY WORKING FAMILIES ACT – APPLICABILITY

Providing that the Maryland Healthy Working Families Act does not apply to employees of a county board of education who are called to work on an asneeded basis, can reject or accept the shift offered by the county board of education, and are not guaranteed to be called on to work by the county board of education.

#### NATURAL RESOURCES - WILD WATERFOWL POLICY - REPEAL

Repealing provisions of law authorizing the Department of Natural Resources to issue a license to feed waterfowl; repealing certain license application requirements; repealing provisions of law concerning the establishment, approval, and use of certain feeding zones; repealing a requirement that certain licensed areas be open to inspection by certain persons; repealing provisions of law authorizing the Secretary of Natural Resources to revoke a license to feed waterfowl under certain circumstances; etc.

Authorizing the Department of Natural Resources to allow a person to hunt any migratory game birds on Sundays during the open season on private property or public land designated for hunting.

Authorizing the Maryland Agricultural Land Preservation Foundation to use a fair market value determined in accordance with certain provisions of law for up to 2 years after the date on which the Foundation was first requested in writing to purchase the easement.

Altering the definition of "practice social work" to include counseling for alcohol and drug use and addictive behaviors; requiring the State Board of Social Work Examiners, under certain circumstances, to approve licensees approved to engage in independent practice to provide supervision; authorizing an applicant for a certain license to appeal the Board's rejection of an application to take a certain licensure examination by submitting certain documentation to the Board in a certain manner; etc.

Authorizing a court to issue an order authorizing or directing a law enforcement officer to use a cell site simulator after making a certain determination; limiting to 30 days or less the time period during which a cell site simulator may be used or location information may be obtained under the authority of a certain order; requiring cell site simulator use by law enforcement to begin 10 days after issuance of an order; providing that evidence obtained in violation of the Act is subject to the exclusionary rule, as judicially determined; etc.

Altering the definitions of "community association" and "local code violation" for purposes of certain provisions of law authorizing community associations to seek judicial relief for nuisance abatement in Baltimore County; repealing a provision of law requiring a certain court to determine in what amount and under what conditions a bond must be filed by a community association in a certain nuisance action; including in the definition of "community association" an association that represents two or more individual community associations; etc.

# JUVENILE LAW – JURISDICTION – ATTEMPTED CARJACKING AND ATTEMPTED ARMED CARJACKING

Providing that the juvenile court does not have jurisdiction over a child alleged to have committed attempted carjacking or attempted armed carjacking unless the child is under the age of 16 years or a court exercising criminal jurisdiction transfers a case to the juvenile court.

Authorizing a defendant in a malpractice claim against a licensed professional to move for a protective order to limit the disclosure of certain documentary evidence to protect the defendant from annoyance, embarrassment, oppression, or undue burden or expense; requiring a court, on a certain motion by the defendant, to review the claimant's request for documentary evidence and authorizing the court to issue a certain protective order for good cause shown; providing for the prospective application of the Act; etc.

Waiving the State's right to immunity from suit brought in a certain federal court alleging certain employment discrimination; and authorizing certain actions alleging discrimination to be brought in a federal court of competent jurisdiction.

Altering the deadline by which a certificate of candidacy for an office to be filled by a special election is required to be filed; establishing the filing deadline for a certificate of candidacy for a special election of a write—in candidate; establishing a filing deadline for a certificate of nomination of 5 p.m. on the day of a special primary election to fill a vacancy in the office of Representative in Congress; providing that a certain judicial review be sought by a certain date; etc.

Requiring that, for any fiscal year that an appropriation is included in the State budget for a third bridge that crosses the Chesapeake Bay, the Governor include in the budget certain capital grants for each county in which the bridge originates or terminates; requiring that the capital grants equal 25% of the amount appropriated for certain purposes related to the bridge; requiring that a capital grant be used only for infrastructure improvements necessitated by or related to the construction of the bridge; etc.

STATE FINANCE AND PROCUREMENT – PROHIBITED APPROPRIATIONS – MAGNETIC LEVITATION TRANSPORTATION SYSTEM

Prohibiting the State and certain units and instrumentalities of the State from using any appropriation for a magnetic levitation transportation system in the State; prohibiting a public or private entity that receives money from the State from authorizing a permit or giving any other form of approval for a magnetic levitation transportation system in the State; and prohibiting a proposal for a magnetic levitation transportation system from using certain rights—of—way or track owned or operated by Amtrak or CSX transportation.

#### ON-SITE SEWAGE DISPOSAL SYSTEMS - INSPECTION - LICENSING

Prohibiting an individual from engaging in the business of inspecting an onsite sewage disposal system unless the person holds a septic inspection license issued by the Department of the Environment on or after May 1, 2021; requiring the Department to adopt regulations establishing certain eligibility criteria and training requirements for septic inspection licenses on or before January 1, 2021; requiring an applicant for a certain license to submit a certain application and pay a certain fee; etc.

Requiring that a certain pregnant incarcerated individual be screened for substance use disorder at intake using a validated screening tool; requiring that a certain pregnant incarcerated individual be referred immediately to a behavioral health care provider and a reproductive health care provider for certain purposes; requiring a certain correctional unit to ensure that a pregnant incarcerated individual continues to receive certain medication in a certain manner under certain circumstances; etc.

CIRCUIT COURT REAL PROPERTY RECORDS IMPROVEMENT FUND – SURCHARGE ON RECORDABLE INSTRUMENTS

Increasing, from \$20 to \$40, the amount of the surcharge on certain recordable instruments that the State Court Administrator is required to establish for the Circuit Court Real Property Records Improvement Fund.

Requiring the Secretary of Natural Resources to adopt regulations requiring that all crab pots be equipped with ghost panels and establishing specifications for ghost panels used in crab pots; and defining the term "ghost panel" as a panel or any other mechanism that is designed to allow crabs to escape from a crab pot after a period of time if the crab pot has been abandoned or lost.

Prohibiting school employees from operating an electric retractable room partition in a public school except under certain circumstances; requiring any annual safety review, evaluation, or exercise for school employees in a certain school building to include certain information and demonstrations; and requiring the State Department of Education to develop and disseminate model safety guidelines on the safe operation of electric retractable room partitions.

Defining "mortgage lender" to mean a person that is duly licensed under certain provisions of the Financial Institutions Article; clarifying the definition of "consumer claim"; and declaring the intent of the General Assembly that the Act be construed as clarifying the Maryland Collection Agency Licensing Act and that, with regard to sales of real property to bona fide purchasers, the Act applies only to sales made on or after June 1, 2020.

Requiring certain taxpayers to add a certain deduction for gains from sales or exchanges of qualified opportunity zone property back to federal adjusted gross income to determine Maryland adjusted gross income; requiring certain taxpayers to add a certain deduction for gains from sales or exchanges of qualified opportunity zone property back to federal adjusted gross income to determine Maryland modified income; and applying the Act to taxable years beginning after December 31, 2019.

REDISTRICTING REFORM ACT OF 2020 – CONSTITUTIONAL AMENDMENT

Proposing an amendment to the Maryland Constitution to require single—member delegate districts; altering certain standards for the drawing of legislative districts; proposing a new article to the Maryland Constitution to establish standards for the drawing of congressional districts; establishing a Legislative and Congressional Redistricting and Apportionment Commission; requiring the Commission divide the State into certain legislative districts and congressional districts; submitting the amendment to the qualified voters of the State; etc.

Altering, from 55 years old to 50 years old, the age at which a resident is eligible for a subtraction modification under the Maryland income tax for retirement income attributable to certain employment; altering the amount of certain retirement income that may be included under a certain subtraction modification; applying the Act to taxable years beginning after December 31, 2019; etc.

Requiring a certain annual report by the State Commission on Criminal Sentencing Policy to identify certain information for crimes of violence; requiring the Commission to include certain entry locations on a sentencing guidelines worksheet for a court to report certain information; and requiring the Governor's Office of Crime Control and Prevention to submit a certain report on certain pleas that contains certain data.

Extending and altering, for certain fiscal years, the Electric Vehicle Recharging Equipment Rebate Program and vehicle excise tax credit for the purchase of certain electric vehicles; repealing the limitation on the maximum total purchase price of certain vehicles; requiring the Maryland Zero Emission Electric Vehicle Infrastructure Council to issue certain reports on or before certain dates; altering the amount required to be transferred each year from the Maryland Strategic Energy Investment Fund to the Transportation Trust Fund; etc.
