# **HOUSE BILLS INTRODUCED FEBRUARY 8, 2021**

# **HB 1254** Delegate Ivey

PUBLIC SCHOOL EMPLOYEES – WHISTLEBLOWER PROTECTION – CIVIL ACTIONS

Repealing a prerequisite that a public school employee who is subject to a certain prohibited personnel action relating to an act of whistleblowing must exhaust any administrative remedies before instituting a civil action against a public school employer; authorizing any public school employee who is subject to a certain personnel action to file a certain complaint; requiring a public school employer to provide an administrative remedial process and complete the process within 30 days of the complaint filing; etc.

# **HB 1255** Delegate Ivey

HOMESTEAD AND HOMEOWNERS' PROPERTY TAX CREDITS – ACCESS AND ELIGIBILITY

Requiring a contract for the sale of certain residential property to include a certain addendum concerning the homestead property tax credit; altering the definition of "gross income" for purposes of determining eligibility for and the computation of the homeowners' property tax credit; altering the minimum age, from 70 to 60 years, at which a homeowner becomes eligible to receive the homeowners' property tax credit for certain previous taxable years; applying the Act to all taxable years beginning after June 30, 2021; etc.

MARYLAND DEPARTMENT OF HEALTH – GENE SYNTHESIS PROVIDERS AND MANUFACTURERS OF GENE SYNTHESIS EQUIPMENT – CERTIFICATION

Requiring the Maryland Department of Health, by January 1, 2023, to develop gene sequence and customer screening guidelines for gene synthesis providers and manufacturers of gene synthesis equipment that include certain requirements; requiring the Department to develop a process to certify that gene synthesis providers and manufacturers of gene synthesis equipment are in compliance with the guidelines; requiring, on or after January 1, 2024, the Department to certify certain gene synthesis providers and equipment manufacturers; etc.

BUSINESS PERSONAL PROPERTY TAX – BUSINESSES AFFECTED BY COVID–19 RESTRICTIONS – REIMBURSEMENT

Requiring the State Department of Assessments and Taxation to reimburse businesses affected in a certain manner by certain COVID-19 restrictions that file a business personal property tax return during the period from January 1, 2021, to April 15, 2021, for the full amount of business personal property tax paid by the businesses in calendar year 2020; requiring the Department to reimburse eligible businesses exclusively out of certain State funds and in the order in which the businesses filed personal property tax returns; etc.

This bill requires a mandated appropriation in the annual budget bill.

HEALTH ENTERPRISE ZONES – ESTABLISHED (RESTORING THE PROMISE ACT OF 2021)

Declaring certain findings related to Health Enterprise Zones; requiring the Governor to include \$68,000,000 in the annual budget bill for fiscal year 2023 for waiting list services for individuals with developmental disabilities; requiring the Secretary of Health to designate contiguous geographic areas with documented health disparities and poor health outcomes as Health Enterprise Zones; authorizing certain entities to apply on behalf of certain areas for designation as Health Enterprise Zones; etc.

This bill requires a mandated appropriation in the annual budget bill.

HORSE RACING – FAIR HILL NATURAL RESOURCES MANAGEMENT AREA

Altering the amount of money to be credited to the Fair Hill Improvement Fund; requiring the Governor to include \$1,300,000 in the annual budget bill for fiscal years 2023 through 2027 for the Fair Hill Improvement Fund; and requiring the money appropriated to be spent on the operation and maintenance of the physical facilities within the Special Event Area of Fair Hill.

Proposing an amendment to the Maryland Constitution to require congressional districts to conform to certain standards and that due regard be given to natural boundaries and boundaries of political subdivisions; and submitting the amendment to the qualified voters of the State for their adoption or rejection.

Altering certain provisions of law related to the execution of wills, powers of attorney, and advance directives to authorize the electronic execution and remote witnessing of those documents under certain circumstances; providing that a will, a power of attorney, a notarization of a power of attorney, or an advance directive executed in conformance with the provisions of certain executive orders shall be deemed to satisfy certain requirements under the Act; applying the Act retroactively; etc.

Altering the powers and duties of the State Board of Master Electricians; changing the name of the State Board of Master Electricians to the State Board of Electricians; requiring the Department, by December 1, 2024, to adopt regulations necessary for the regulation and licensing of low–voltage electricians if certain legislation establishing a certain licensing program is not enacted by July 1, 2024; prohibiting, beginning on a certain date, local jurisdictions from issuing certain licenses; etc.

Requiring the Maryland Department of Health, on or before April 1, 2021, and with input from certain persons, to develop and submit to the General Assembly a certain plan for vaccinating residents of the State against COVID–19; requiring that the plan include certain information, a dedication of time and recourse for certain purposes, and a certain education campaign; requiring the Department to provide to the General Assembly, for the duration of calendar year 2021, certain weekly progress reports on implementation of the plan; etc. EMERGENCY BILL

Requiring a person having custody of a will to maintain custody of the will, except under certain circumstances; prohibiting the custodian of a will from taking certain actions related to the will, except under certain circumstances; authorizing the custodian of a will to deposit the will for safekeeping with a certain register of wills under certain circumstances; requiring the custodian of a will to deliver the will to certain persons under certain circumstances; etc.

Establishing the Workgroup on Public Water Access; requiring the Workgroup to study and make recommendations regarding certain matters; requiring the Workgroup to submit an interim report and a final report to certain committees of the General Assembly on or before certain dates; requiring the Governor to include in the annual budget bill for fiscal year 2023 an appropriation of \$60,000 to the Chesapeake Bay Trust to support the duties of the Workgroup; providing for the termination of the Act; etc.

This bill requires a mandated appropriation in the annual budget bill.

#### LEGAL EDUCATION SUCCESS COLLABORATIVE – ESTABLISHED

Establishing a Legal Education Success Collaborative for the purpose of developing methods of increasing diversity in the legal field; requiring institutions to develop and administer programs and cooperatives related to the Collaborative; beginning in fiscal year 2023, requiring appropriations to be made each year to certain institutions and programs and to support a certain coordinator position; etc.

FREDERICK COUNTY – BARBERSHOP AND BEAUTY SALON BEER AND WINE LICENSES – ALTERATIONS

Increasing from 5 ounces to 12 ounces the amount of beer that a holder of a barbershop or beauty salon beer and wine license in Frederick County may provide to a barbershop or beauty salon customer for on–premises consumption.

Requiring the initial evaluation of a certain child to determine whether the child is in need of special education services to include certain questions regarding the history of traumatic brain injury; and requiring these questions to be developed by the State Department of Education in consultation with the State Traumatic Brain Injury Advisory Board.

Requiring the Maryland Automobile Insurance Fund to offer primary or supplemental coverage to certain applicants that provide school bus services to a county board of education; requiring the coverage to include certain minimum coverages and to equal or exceed the coverage provided to public contractors for school bus services in the county; and exempting coverage under the Act from a certain limitation.

Requiring the Maryland Emergency Management Agency (MEMA) to study and make recommendations on best practices and model policies, including those addressing emergency responder training, for the culturally sensitive inclusion of minority communities in State and local emergency plans and management; requiring MEMA to conduct a survey of State and local emergency management plans to ascertain certain current emergency planning strategies; requiring MEMA to review certain emergency management plans; etc.

Establishing that, within the Office of the Public Defender, the deputy public defender, district public defenders, assistant public defenders, and other employees are placed in certain employment categories in the State Personnel Management System; authorizing the Public Defender to employ, rather than appoint, assistant public defenders and other employees; authorizing assistant public defenders and other employees to be terminated or disciplined only for cause in accordance with certain provisions of law; etc.

Requiring the Department of Legislative Services to contract with a consultant to study and make recommendations regarding the capacity and accountability of the State Department of Education to carry out certain responsibilities and duties; requiring the consultant to be independent and have certain expertise; requiring the consultant to collect certain data, account for certain spending, and review certain mitigation plans and corrective actions taken with regard to student learning loss during the COVID–19 pandemic; etc.

Establishing the Maryland Community Health and Public Safety Center of Excellence within the Governor's Office of Crime Prevention, Youth, and Victim Services; authorizing the Center to enter into contracts with the University of Maryland System or other entities for the purposes of carrying out its mission; requiring the activities of the Center to include certain planning, assistance, and coordination; requiring the Center to provide technical assistance to local governments for certain purposes; etc.

Authorizing an individual to bring a nuisance action for damages caused by rodent harborage on real property against an owner of the property; defining "rodent harborage" as a condition that provides sustenance or shelter for rodents, promotes their reproduction and continued existence on a property, creates or contributes to property damage, is injurious to public health and safety or obstructs the reasonable use of the property; authorizing the court to award certain damages to a prevailing plaintiff; etc.

#### REAL PROPERTY – RESIDENTIAL LEASES – RENT RESTRICTIONS

Establishing a fee on rental housing licenses issued in Howard County to fund educational services for any tenant or landlord in need of assistance and legal services for any tenant with a household income of up to 60% of the median household income in Howard County; requiring that the fee be \$15 per unit in fiscal year 2022; specifying that the fee is in addition to any other fees required for the issuance or renewal of a rental housing license; requiring a certain report; applying the Act prospectively; etc.

Requiring the State Department of Assessments and Taxation to publish on the Department's website certain information in plain language relating to the assessment process and methodology used by the Department in determining the value of real property; requiring the Department and certain assessors employed by the Department, when determining the value of real property, to conform to certain federal guidelines, consider certain matters, and provide certain information; etc.

Prohibiting a person from manufacturing, assembling, possessing, selling, offering to sell, transferring, purchasing, or receiving a certain firearm or unfinished frame or receiver not imprinted with a serial number by a federally licensed firearms manufacturer or federally licensed firearms importer; establishing penalties for a violation of the Act of imprisonment for up to 2 years or a fine not to exceed \$5,000 or both; etc.
