# **SENATE BILLS INTRODUCED February 5, 2021**

#### **SB 721 Senator Hester**

PROCUREMENT - SMALL BUSINESS RESERVE PROGRAM -ADMINISTRATION AND APPLICATION

Requiring the Governor's Office of Small, Minority, and Women Business Affairs to establish certain guidelines for the administration of the Small Business Reserve Program; requiring that certain guidelines for the Program be developed in partnership with certain persons; requiring that a unit assess certain procurements with a total dollar value of \$500,000 or less under the guidelines for the Program and either designate the procurement for the Program or request a certain waiver; etc.

# **SB 722** Senator Hester

DEPARTMENT OF SMALL BUSINESS, ENTREPRENEURSHIP, AND INNOVATION – ESTABLISHED

Establishing the Department of Small Business, Entrepreneurship, and Innovation to assist units of State government in identifying and evaluating qualified minority business enterprises to help achieve the objective for greater use of minority business enterprises; establishing the Department in the Executive Branch; transferring authority over from the Maryland Small Business Development Financing Authority; transferring the responsibilities of the Governor's Office of Small, Minority, and Women Business affairs to the Department; etc.

Establishing the Maryland Food System Resiliency Council; providing the goals of the Council are to address the food insecurity crisis in the State due to the pandemic, develop recommendations to increase the long—term resiliency of the food system, and develop by November 1, 2021, a plan to increase the production and procurement of Maryland certified food; requiring the Council to submit an interim report by November 1, 2021, and recommendations on a statewide food policy council to the General Assembly by November 1, 2022; etc.

MORTGAGE SERVICERS – REQUIREMENTS AND PROHIBITIONS DURING AND AFTER A STATE OF EMERGENCY AND CATASTROPHIC HEALTH EMERGENCY (FORECLOSURE RELIEF ACT OF 2021)

Prohibiting a certain mortgage servicer from commencing or completing an action to foreclose a mortgage or deed of trust during a state of emergency and catastrophic health emergency; requiring a servicer to grant a forbearance to a borrower under certain circumstances; prohibiting a period of forbearance from lasting more than 180 days except under certain circumstances; requiring a servicer to notify a borrower of a certain right to mediation under certain circumstances; etc.

WORKERS' COMPENSATION – OCCUPATIONAL DISEASE PRESUMPTIONS – COVID–19

Providing that certain covered employees who are suffering from the effects of severe acute respiratory syndrome coronavirus 2 are presumed, under certain circumstances, to have an occupational disease that was suffered in the line of duty or course of employment and is compensable in a certain manner.

VEHICLE LAWS – PERSONAL DELIVERY DEVICES – STANDARDS AND REQUIREMENTS

Establishing an exception to motor vehicle registration requirements for personal delivery devices; authorizing a personal delivery device to operate on any highway, sidewalk, or crosswalk in the State; prohibiting a personal delivery device from being operated in certain manners; creating certain marking, equipment, and insurance requirements for personal delivery devices being operated on highways, sidewalks, or crosswalks; and excluding personal delivery devices from the defined terms "motor vehicle" and "vehicle".

Repealing the exemption from the Maryland Healthy Working Families Act for certain on—call employees; requiring employers to allow employees to use earned sick and safe leave during a public health emergency; requiring certain employers to provide employees certain earned sick and safe leave on the date that a public health emergency is declared or proclaimed for a jurisdiction; requiring an employer to provide certain earned sick and safe leave regardless of the employee's length of employment with the employer; etc.

LABOR AND EMPLOYMENT – WORKER SAFETY AND HEALTH – INJURY AND ILLNESS PREVENTION PROGRAM

Requiring employers with 10 or more employees, or whose rate of work—related injury and illness exceeds the average incidence rate of all industries in the State to develop and implement a health and safety committee to promote health and safety in the workplace; providing for the membership, meetings, and duties of the committee; requiring that the committee maintain certain records and retain the records for a certain period of time; requiring each employer to establish and maintain an injury and illness prevention program; etc.

MARYLAND HEALTH BENEFIT EXCHANGE – STATE-BASED YOUNG ADULT HEALTH INSURANCE SUBSIDIES PILOT PROGRAM

Requiring the Maryland Health Benefit Exchange to establish and implement a State—Based Young Adult Health Insurance Subsidies Pilot Program to provide a means for young adults to reduce the amount they pay for health benefit plans in the individual health insurance market; requiring the Exchange, in consultation with the Maryland Insurance Commissioner and as approved by the Board of Trustees of the Exchange, to establish certain subsidy eligibility and payment parameters for calendar years 2022 and 2023; etc.

This bill requires a mandated appropriation in the annual budget bill.

INCOME TAX – CREDIT FOR TRAVEL, HOSPITALITY, AND ENTERTAINMENT EXPENSES

Allowing an individual to claim a credit against the State income tax for certain travel, hospitality, and entertainment expenses paid or incurred by the individual during taxable years 2021 and 2022 under certain circumstances; providing that the credit may not be allowed for certain travel expenses for which the individual claimed a certain federal deduction; requiring the Department of Commerce, on application by an individual, to issue a tax credit certificate in a certain amount; etc.

ALLEGANY AND GARRETT COUNTIES – ALCOHOLIC BEVERAGES – GIFT BASKET PERMITS

Establishing, in Allegany County and Garrett County, gift basket permits; authorizing the Board of License Commissioners for Allegany County to issue a gift basket permit to certain persons; authorizing the Board of License Commissioners for Garrett County to issue a gift basket permit to certain persons; prohibiting each of the Boards from issuing the permit for certain uses; providing that the permit authorizes a permit holder to sell and deliver gift baskets containing beer, wine, or liquor to certain individuals; etc.

Establishing the Maryland Innovation Initiative University Partnership Pilot Program within the Maryland Technology Development Corporation to expand opportunities for technology validation, entrepreneurial development, and industry engagement at eligible universities; requiring the Maryland Innovation Initiative within the Corporation to implement and administer the Pilot Program; authorizing Bowie State University and Salisbury University to participate in the Pilot Program; etc.

This bill requires a mandated appropriation in the annual budget bill.

# EDUCATION – STUDENT DATA PRIVACY – REPORTS AND STUDENT DATA PRIVACY COUNCIL SUNSET EXTENSION

Requiring each county board of education to provide a certain list of digital tools to the State Department of Education on or before July 1 each year; requiring the Department to publish certain information on digital tools provided by each county board on or before September 1 each year; requiring the Student Data Privacy Council to submit a certain report to the Governor and the General Assembly on or before December 1, 2024; and extending the termination date for the Council to September 30, 2025.

Requiring the Department of Information Technology to issue certain standards and guidelines for units of State government for the appropriate use and management of certain Internet of Things devices under certain circumstances; requiring the Department to review and revise its standards and guidelines at least once every 5 years to ensure that they are at least as comprehensive as the standards and guidelines adopted by the Director of NIST; etc.

Expanding the availability of remote notarial acts to include certain wills and trust documents; clarifying the application of certain provisions of law regarding identity proofing and credential analysis; and affirming the validity of the notarization of certain documents in conformance with certain executive orders.

Authorizing a pharmacist to administer certain vaccinations to an individual who is at least 3 years old but under the age of 18 years; altering the age of an individual to whom a pharmacist may administer certain vaccinations; requiring a pharmacist to administer certain vaccinations under a written protocol; repealing the requirement that individuals in a certain age group have a certain prescription in order for a pharmacist to be allowed to administer a certain vaccination to the individual; etc.

# SB 737 Senator Rosapepe

#### COMPREHENSIVE CONSERVATION FINANCE ACT

Providing that Department of Agriculture, the Department of Natural Resources, and the Maryland Environmental Trust must allow participants in certain programs to participate in and receive compensation from certain markets, credits, or programs under certain circumstances; authorizing certain units to enter into pay—for—success contracts with certain aggregators to procure certain environmental outcomes projects or already certified environmental outcomes; etc.

This bill requires a mandated appropriation in the annual budget bill.

# SB 738 Senator Rosapepe

# INCOME TAX – MECHANICAL INSULATION INSTALLATION TAX CREDIT

Allowing a credit against the State income tax for certain qualified expenses paid or incurred by a taxpayer for the installation of certain mechanical insulation in a certain manner on a certain property and for which the taxpayer obtains a tax credit certificate from the Maryland Energy Administration; prohibiting the Administration from issuing tax credit certificates for credit amounts in aggregate totaling more than \$5,000,000; requiring that the tax credits be issued on a first–come, first–served basis; etc.

Providing that the requirement to obtain a certain entertainment permit does not apply to the holder of a certain license under certain circumstances; authorizing a certain license holder to offer entertainment when persons under the age of 21 years are on the licensed premises if the license holder enters into a certain agreement with certain persons and the lease of the property on which the licensed premises is located contains certain provisions; etc.

Establishing the Maryland COVID–19 Small Business Grant Program in the Department of Commerce; requiring the Department, subject to certain circumstances, to distribute to each county certain funds for the purpose of providing grants to certain eligible small businesses; authorizing a county to apply to the Department for a distribution of funds in accordance with the Act; authorizing a county to designate a certain entity to receive and distribute certain funds; etc.

Requiring, on or before April 1, 2021, the Maryland Department of Health, in collaboration with local health departments of the State, to adopt and implement a certain plan to respond to the outbreak of COVID–19; requiring, for calendar year 2021, institutions of higher education in the State to adopt and implement a certain COVID–19 testing plan; requiring certain insurers, nonprofit health service plans, and health maintenance organizations to provide coverage for certain COVID–19 tests and associated costs; etc.

Establishing the Maryland Model Prisons Study Workgroup to develop a plan for fundamental changes to the culture and practices of State prisons with emphasis on reduction of recidivism for all incarcerated individuals, prioritizing the classification of incarcerated individuals who committed offenses when under the age of 25 years; requiring the Workgroup to report its findings and recommendations to the Governor and the General Assembly by December 1, 2022; etc.

Establishing collective bargaining rights for certain community college employees; establishing procedures for the selection and certification of an exclusive bargaining representative; establishing a cap on the number of bargaining units that may be within each community college; requiring certain contracts and agreements entered into before October 1, 2021, to remain in effect until the agreement or contract expires; etc.

STATE BOARD OF ELECTIONS – MEMBERSHIP, CONTRACT MANAGEMENT, BALLOT DROP BOXES, AND VOTING SYSTEM FINANCING

Altering the membership of the State Board of Elections; requiring certain members of the State Board to have expertise or experience in certain areas; providing for a nonvoting, ex officio member of the State Board; altering the duties of the State Board to include reviewing and voting on certain contracts and ensuring the cost effectiveness of the use of certain funds; requiring the State Administrator of Elections to report contracts, contract renewals, and change orders to the State Board; etc.

Requiring a nursing home, on request of the Maryland Department of Health, to electronically submit clinical information to the State designated exchange; authorizing the State designated exchange to provide certain information to certain individuals and entities; providing that information submitted under a certain provision of this Act may be combined with other data maintained by the State designated exchange to facilitate a state health improvement program, mitigate a public health emergency, and improve patient safety; etc.

Authorizing the Charles County Board of County Commissioners to establish a community service program and a pretrial release program in Charles County; authorizing the Board to enact certain local laws and ordinances; providing that a court may order a person to participate in the community service program; providing for a fee of up to \$40 for each 8—hour period of community service; providing a person is eligible for the pretrial release program if not being held for a certain crime of violence or escape; etc.

#### SOUTHERN MARYLAND - HUMAN RELATIONS COMMISSION

Authorizing the county commissioners of a code home rule county of the Southern Maryland class to establish a Human Relations Commission for the county; specifying the purpose of the Commission is to use its influence to direct the efforts of the community to solving problems that are often the basic reasons for racial tensions and to encourage and ensure equal treatment of all people; making certain provisions of law governing a certain county human relations commission applicable to a Human Relations Commission established under the Act; etc.

Altering the procedures used by the Police Commissioner of Baltimore City to award promotional appointments; and authorizing the Commissioner to remove certain applicants from the list of eligible appointees if the Civilian Review Board has sustained a certain misconduct complaint against the applicant between the time the applicant applied for the promotion and the time in which the applicant is to be selected for the promotion.

Requiring the Maryland Department of Commerce to submit to the House Appropriations and the Senate Budget and Taxations Committees a report containing demographic information, including race, age, gender, and socioeconomic status, of each recipient of COVID–19 business relief in the State such as small business relief and other financial assistance intended to address the economic impact of COVID–19 within 30 days after enactment of the Act.

PUBLIC SERVICE COMMISSION – DAMAGED, OBSOLETE, OR EXCESSIVE LINES – FINES

Requiring the Public Service Commission to promptly notify the owner of a utility pole about damaged, dangling, obsolete, or redundant lines or blight or public nuisance caused by an excessive number of lines on a utility pole under certain circumstances; requiring the owner of a utility pole to require the person that controls the line or lines to investigate and repair or remove offending lines within 30 days after receiving a certain notice from the Commission; etc.

#### BALTIMORE CITY – 40TH DISTRICT ALCOHOLIC BEVERAGES

Authorizing the Board of License Commissioners for Baltimore City to issue a Class C beer, wine, and liquor license in certain areas of the 40th alcoholic beverages district in Baltimore City; prohibiting certain license holders in the 40th alcoholic beverages district in Baltimore City from selling alcoholic beverages before 10 a.m. or after 10 p.m., with certain exceptions; and making technical corrections.

Establishing that, within the Office of the Public Defender, the deputy public defender, district public defenders, assistant public defenders, and other employees are placed in certain employment categories in the State Personnel Management System; authorizing the Public Defender to employ, rather than appoint, assistant public defenders and other employees; authorizing assistant public defenders and other employees to be terminated or disciplined only for cause in accordance with certain provisions of law; etc.
