# **SENATE BILLS INTRODUCED January 15, 2021**

### SB 357 Senator Rosapepe

#### JOINT COMMITTEE ON WORKFORCE DEVELOPMENT

Establishing a Joint Committee on Workforce Development to evaluate the condition of the State's public and private sector workforces, monitor skills shortages, identify strategies to expand employment opportunities, increase earnings, and evaluate the effectiveness of certain programs and policies; requiring the Committee to submit its findings and recommendations to the Governor and the General Assembly on or before December 31 each year; etc. EFFECTIVE OCTOBER 1, 2021

# **SB 358** Senator Rosapepe

GENERAL PROVISIONS – COMMEMORATIVE DAYS – PONGAL DAY

Requiring the Governor annually to proclaim January 14 as Pongal Day, Pongal being one of the main festivals celebrating the importance of the harvest in the state of Tamil Nadu in south India, Sri Lanka, and many other countries.

# SB 359 Senator Rosapepe

DEPARTMENT OF TRANSPORTATION AND DEPARTMENT OF THE ENVIRONMENT – PURPLE LINE TREE REPLACEMENT PLAN

Requiring the Department of Transportation, in conjunction with the Department of the Environment, to develop a plan to replace trees removed during construction of the Purple Line; requiring the Department of Transportation to consult with businesses, community representatives, local governments, and residents about the plan; requiring the plan to provide for the replacement of trees in areas affected by Purple Line construction with priority given to those with environmental justice issues or the heat island effect; etc.

STATE GOVERNMENT – NOTARIES PUBLIC – NOTARY PUBLIC FUND AND REMOTE NOTARIAL ACTS

Establishing the Notary Public Fund as a special, nonlapsing fund; specifying that the purpose of the Fund is to provide funding to support the Secretary of State in the implementation, regulation, and enforcement of certain actions; requiring the Secretary of State to administer the Fund; requiring the State Treasurer to hold the Fund and the Comptroller to account for the Fund; specifying the contents of the Fund; specifying the purpose of the Fund; requiring the Secretary of State to distribute certain fees to the Fund; etc.

#### PUBLIC-PRIVATE PARTNERSHIPS - PROCESS AND OVERSIGHT

Establishing the Public-Private Partnership Oversight Review Board; requiring a certain reporting agency to include in presolicitation reports for public-private partnerships with a total value that exceeds \$500,000,000 presolicitation reports of certain contracts and a certain environmental impact statement under certain circumstances; requiring certain agreements to be submitted to the Legislative Policy Committee; prohibiting the Board of Public Works, under certain circumstances, from designating a public-private partnership; etc.

# TRANSPORTATION – HIGHWAY USER REVENUES – REVENUE AND DISTRIBUTION

Increasing the amounts of capital grants calculated based on highway user revenues that are required to be appropriated to Baltimore City, counties, and municipalities in certain fiscal years.

Authorizing a certain civil action to be brought against a person who knowingly summons a police officer with the intent to infringe on the person's constitutional rights, unlawfully discriminate against the person, cause the person to feel harassed or humiliated or to be expelled from a certain place, or damage a person's reputation or certain other interests; specifying certain types of damages that a certain person is entitled to recover; and providing that the Act does not restrict certain legal remedies.

BALTIMORE CITY – CIVIL CLAIMS AGAINST LAW ENFORCEMENT OFFICERS OF AN INSTITUTION OF HIGHER EDUCATION – PROHIBITION AGAINST NONDISCLOSURE PROVISION IN SETTLEMENT AGREEMENT

Prohibiting the use or enforcement of a confidentiality or nondisclosure provision in a settlement agreement or other release of liability between the parties in a claim of misconduct in the performance of duties against a law enforcement officer of an institution of higher education in Baltimore City.

# SB 365 Senator McCray

NEIGHBORHOOD BUSINESS DEVELOPMENT PROGRAM – FOOD DESERT PROJECTS – BUSINESS RETENTION

Expanding the purposes of the Neighborhood Business Development Program to include retaining certain businesses and enterprises in food deserts and certain areas that serve food deserts; increasing to \$100,000 the maximum amount of a certain small loan that may be provided to an approved entity for assistance in providing or maintaining access to healthy food in certain food deserts; etc.

Requiring the Department of Assessments and Taxation to convene a task force to study and make recommendations on the adoption of a unique Maryland Identification Number for each registered or licensed business in the State to be used by certain State agencies; requiring the task force to include representatives of certain State agencies; authorizing the task force to include representatives of certain State agencies; providing for the duties of the task force; etc.

# SB 367 Senator McCray

HOUSING AND COMMUNITY DEVELOPMENT – NEIGHBORHOOD REVITALIZATION PROGRAMS – APPLICATION REQUIREMENTS

Requiring an application for the Community Legacy Program, the Neighborhood Business Development Program, and the Baltimore Regional Neighborhood Initiative Program within the Department of Housing and Community Development to include a letter of support from the legislative district in which a certain project or plan is proposed; and applying the Act prospectively.

Authorizing a municipal corporation to implement and use a speed monitoring system on a municipal highway within its corporate limits under certain circumstances; prohibiting a county from unreasonably denying a certain request or from placing exactions, fees, or certain restrictions on the implementation and use of a speed monitoring system; authorizing a municipal corporation to contest in the circuit court a certain denial of permission by the county; etc.

Requiring a local department of social services with a military installation in its jurisdiction to enter into a memorandum of understanding with the Military Family Advocacy Program for that installation; and establishing certain requirements for a memorandum of understanding under the Act.

Increasing to \$20,000 the amount of a subtraction modification under the Maryland income tax for certain military retirement income for individuals who are at least 55 years old; increasing to \$10,000 the amount of a subtraction modification under the Maryland income tax for certain retirement income attributable to a resident's employment as a correctional officer, a law enforcement officer, or a fire, rescue, or emergency services personnel; etc.

Altering the circumstances under which a parent may request an independent educational evaluation of a child with a disability at public expense to include a parent who submits a certain request to a local school system and the local school system does not respond within 30 days after the date the request was received or, on approval and under certain circumstances, the educational evaluation meeting does not occur within 60 days after the date the request was received.

Authorizing the recovery of actual damages, expenses, litigation costs, and interest in obligee claims against surety insurance providers under certain circumstances; applying certain provisions of law on unfair claim settlement practices to surety insurance; requiring an obligee to comply with certain procedures before bringing a certain claim against a surety insurance provider; applying the Act prospectively; etc.

# SB 373 Senator Reilly

VEHICLE LAWS – SUSPENSION OF DRIVER'S LICENSE OR VEHICLE REGISTRATION – UNPAID JUDGMENTS

Requiring the Motor Vehicle Administration, on receiving notice from a certain insurer, to suspend the driver's license and all vehicle registrations of a motor vehicle judgment debtor who fails to pay the judgment, subject to certain exceptions; prohibiting the Administration from renewing or reissuing a license or registration suspended under the Act until certain conditions are met; requiring the Administration to reinstate the license and registrations of a judgment debtor who enters into an installment plan; etc.

CAMPAIGN FINANCE – SPECIAL SESSION OF THE GENERAL ASSEMBLY – CONTRIBUTIONS PROHIBITED

Prohibiting the Governor, Lieutenant Governor, Attorney General, Comptroller, and members of the General Assembly and persons acting on behalf of those officials from receiving, soliciting, depositing, or using a certain contribution or conducting a certain fund—raising event during a special session of the General Assembly except under certain circumstances.

AGRICULTURE – NEONICOTINOID PESTICIDES – SALE AND STORAGE

Restricting a person that sells a neonicotinoid pesticide under certain provisions of law to selling a neonicotinoid pesticide only to a certain certified applicator or farmer; and requiring a person selling a neonicotinoid pesticide to store each neonicotinoid pesticide behind the counter and in a manner that is inaccessible to customers.

Altering, beginning in fiscal year 2022, the percentage to be paid by the Comptroller from the Small, Minority, and Women–Owned Businesses Account to the Nonprofit, Interest–Free, Micro Bridge Loan (NIMBL) Account within the Maryland Nonprofit Development Center Program Fund.

BALTIMORE CITY – CIGARETTES, OTHER TOBACCO PRODUCTS, AND ELECTRONIC SMOKING DEVICES – LOCAL LAWS AUTHORIZATION

Authorizing Baltimore City to enact and enforce local laws regulating the sale and distribution of cigarettes, other tobacco products, and electronic smoking devices, subject to certain exceptions.

Requiring, on or after October 1, 2022, an individual to be registered by the State Board of Examiners for Audiologists, Hearing Aid Dispensers, and Speech–Language Pathologists before assisting in the practice of audiology in the State, except as otherwise provided under certain provisions of law; establishing qualifications to obtain an audiology assistant registration; authorizing a licensed audiologist to provide general supervision for up to two audiology assistants at any time; etc.

Providing that a law enforcement agency and the agency's superior governmental authority and a collective bargaining unit may not enter into an agreement that is inconsistent with the provisions of the Law Enforcement Officers' Bill of Rights; repealing a certain authorization for a law enforcement agency or the agency's superior governmental authority to negotiate with a certain representative, under certain circumstances, an alternative method of forming a certain hearing board; etc.

HARFORD COUNTY – BOARD OF EDUCATION – TERMS OF APPOINTED MEMBERS

Requiring the appointed members of the Harford County Board of Education to be appointed within 90 days of the general election beginning in November 2024; and providing for the termination of the terms of certain appointed members of the county board.

COURT ORDER TO USE A CELL SITE SIMULATOR OR OBTAIN LOCATION INFORMATION FROM AN ELECTRONIC DEVICE – PROCEDURES

Providing the ways in which an application for a court order authorizing or directing a law enforcement officer to use a cell site simulator or obtain location information from an electronic device may be submitted to a judge; providing the ways in which an applicant for the court order and a judge may converse about the court order application; and providing the ways in which a judge may issue the court order.

HEALTH FACILITIES – RESIDENTIAL SERVICE AGENCIES – COMPLIANCE WITH STATE LABOR LAWS

Requiring the Office of the Attorney General, in consultation with the Maryland Department of Health and the Maryland Department of Labor, to produce a guidance document, by December 30, 2021, concerning the application of employee protection laws to personal care aides employed by residential service agencies; providing for the content and structure of the report; requiring a residential service agency to certify certain information through the signature of a certain individual as a condition of obtaining or renewing a license; etc.

Providing that multiple thefts committed by the same person in multiple counties under one scheme or continuing course of conduct may be aggregated and prosecuted in any county in which any one of the thefts occurred; altering a certain reference to the maximum value of certain property or services applicable to misdemeanor theft; requiring a court to make a finding as to whether a certain crime is organized retail theft; providing that the State has the burden of proving that a certain crime is organized retail theft; etc.

### **SB 386** Harford County Senators

HARFORD COUNTY – ALCOHOLIC BEVERAGES – ASSISTED LIVING PROGRAM LICENSE

Establishing an assisted living program beer, wine, and liquor license in Harford County; authorizing the Board of License Commissioners for Harford County to issue the license to a manager of an assisted living program, but not more than five ALP licenses to a person; authorizing the license holder to provide beer and wine for on–premises consumption by a resident or guest; authorizing the license holder to store liquor, prepare mixed drinks, and serve liquor or mixed drinks; specifying a license fee of \$5,000; etc.

VEHICLE REGISTRATION – DISABILITY PLATES – PARKING METER FEES

Repealing the requirement that a parking meter be noncompliant with the federal Americans with Disabilities Act before an individual who is issued special disability registration plates is exempted from parking meter fees.

MARYLAND MEDICAL ASSISTANCE PROGRAM – EMERGENCY SERVICE TRANSPORTERS – REIMBURSEMENT

Altering the medical services provided by an emergency service transporter for which the Maryland Department of Health is required to reimburse the emergency service transporter under certain circumstances; and requiring the Department to increase the amount of certain reimbursement for emergency service transporters by \$25 each fiscal year, beginning in fiscal year 2022, until the rate is at least \$300.

Establishing, in Harford County, a gift basket permit; authorizing the Board of License Commissioners for Harford County to issue the permit to a person whose business includes the sale and delivery of gift baskets; prohibiting the Board from issuing the permit for use in conjunction with or on the premises of certain establishments; limiting the total annual sales from alcoholic beverages to 10% of the annual gross sales of the permit holder; establishing a permit fee of \$100; etc.

Authorizing certain gas and electric utilities to adopt a limited—income mechanism to benefit certain eligible limited—income customers, subject to the approval of the Public Service Commission; authorizing various forms that a mechanism may take; requiring a utility company to apply for Commission approval of a mechanism in certain manners; requiring a proposal for a mechanism to allocate certain costs across rate classes; providing for the required contents of a proposal for a mechanism; etc.

MARYLAND MEDICAL ASSISTANCE PROGRAM AND HEALTH INSURANCE – COVERAGE AND REIMBURSEMENT OF TELEHEALTH SERVICES

Altering the health care services the Maryland Medical Assistance Program is required to provide through telehealth; requiring the Maryland Department of Health to include certain health care providers and programs when specifying by regulation the types of health care providers eligible to receive certain reimbursement; requiring certain insurers, nonprofit health service plans, and health maintenance organizations to provide certain coverage for certain services delivered through telehealth; etc.

# CRIMINAL LAW – FELONY MURDER – LIMITATION AND REVIEW OF CONVICTIONS FOR CHILDREN

Altering provisions of law relating to murder in the first degree; providing that a person who was a child at the time of the offense may not be found to have committed murder in the first degree under certain provisions of law; authorizing a persons convicted, on or before September 30, 2021, of first degree murder who was a child at the time of the offense to file a motion for review of conviction; requiring a court to hold a certain hearing on the filing of a motion for review of conviction under certain circumstances; etc.

Awarding a diminution credit of 90 days per program completed to reduce the term of confinement of an inmate if the inmate successfully obtains a certain educational certificate, diploma, or degree; requiring the Commissioner of Correction to establish a uniform system of deductions and participation criteria; etc.

MENTAL HEALTH LAW – PETITIONS FOR EMERGENCY EVALUATION – PROCEDURES

Authorizing, rather than requiring, a certain petitioner for emergency evaluation of an individual to give the petition to a peace officer; repealing the requirement that a peace officer explain certain information to a certain petitioner; requiring a certain petitioner for emergency evaluation to take an emergency evaluee to the nearest emergency facility under certain circumstances; etc.
