HISTORIC REVITALIZATION TAX CREDIT - SMALL COMMERCIAL PROJECTS – ALTERATIONS

Increasing from \$4,000,000 to \$5,000,000 the maximum aggregate amount of initial tax credit certificates that the Director of the Maryland Historic Trust may issue for certain small commercial projects.

Repealing a requirement that the Comptroller pay an annual grant from the Racing Special Fund to the Maryland Humanities Council; and requiring the Comptroller to pay a grant of \$150,000 from the State Lottery Fund to the Maryland Humanities Council for Maryland History Day and other programming.

Altering the basis for calculating a certain license fee credited to the Maryland Oil Disaster Containment, Clean—Up and Contingency Fund; and authorizing the Maryland Oil Disaster Containment, Clean—Up and Contingency Fund to be used, in fiscal years 2022 through 2026, to reimburse the owner of a heating oil tank that applied to the Oil Contaminated Site Environmental Cleanup Fund on or before June 30, 2021.

Requiring public high school students, beginning in the 2022–2023 school year, to confer with a high school guidance counselor or other designated representative regarding certain financial aid applications as a requirement for graduation; authorizing a student or the parent or legal guardian of a minor student to submit to a county board of education a statement that the student understands the application and declines to confer with a high school counselor or other designated representative regarding the application; etc.

Requiring each county board of education, beginning in the 2021–2022 school year, to install at least one video recording device in each self—contained special education classroom; requiring video recording devices to record self—contained special education classrooms and exclusion areas during school hours and during any time that the classroom or exclusion area is in use; prohibiting the use of a video recording device in bathrooms or in areas that students use to change clothing; etc.

Proposing an amendment to the Maryland Constitution to change the name of the Court of Appeals to be the Supreme Court of Maryland, to change the name of the Court of Special Appeals to be the Appellate Court of Maryland, to change the name of a Judge of the Court of Appeals to be a Justice of the Supreme Court of Maryland, and to change the name of the Chief Judge of the Court of Appeals to be the Chief Justice of the Supreme Court of Maryland; submitting the amendment to the qualified voters of the State for their adoption or rejection; etc.

Requiring certain county boards of education to consider the pursuit of certain certificates, certifications, or apprenticeships as the equivalent of pursuing postsecondary education; authorizing a student or student's parent or guardian to release certain student information to certain apprenticeship sponsors and employers; requiring certain public high schools to inform students of certain employment and skills training opportunities in a certain manner through certain apprenticeship sponsors and employers; etc.

Modifying the circumstances under which a police officer is required to charge by citation for certain misdemeanor or local ordinance violations that have an imprisonment penalty of up to 90 days and do not involve serious injury or an immediate health risk; requiring the Maryland Police Training and Standards Commission to develop and maintain a certain uniform statewide training and certification curriculum to ensure the use of best practices in the issuance of citations in lieu of arrest; etc.

Requiring the Motor Vehicle Administration to require certain persons who are convicted of, or granted probation before judgment for, certain criminal offenses to participate in the Ignition Interlock System Program for certain periods of time.

Altering the membership of the Commission on Environmental Justice and Sustainable Communities; requiring the membership of the Commission to reflect the diversity of the State to the extent practicable; specifying the term of certain members; requiring the Department of the Environment to provide a new member with an orientation reviewing environmental justice issues in the State; altering the manner in which a chair is chosen for the Commission; requiring the Commission to meet at least six times per calendar year; etc.

Requiring the Maryland Judiciary, in consultation with domestic violence and child abuse organizations, to develop a training program for judges presiding over child custody cases involving child abuse or domestic violence and to review and update the training program at certain intervals; requiring the training program to include certain information; requiring the Maryland Judiciary to make information on a certain training program available on request; etc.

Requiring certain guidelines for absentee voting established by the State Board of Elections to provide for a permanent absentee ballot list; providing that all voters are eligible for permanent absentee ballot status; authorizing a voter to apply for permanent absentee ballot status in a certain manner; authorizing a voter to apply for permanent absentee ballot status at any time; requiring a voter to specify in the permanent absentee ballot application one of certain methods by which the voter chooses to receive an absentee ballot; etc.

Repealing the termination of certain provisions of law making sales and charges related to peer—to—peer car sharing subject to a certain sales and use tax rate; repealing an exemption for certain peer—to—peer car sharing programs from certain requirements that marketplace facilitators collect the sales and use tax on certain sales; altering the sales and use tax rate imposed on certain short—term vehicle rentals; repealing an exemption for certain rental vehicles from the vehicle excise tax; etc.

Requiring a custodian of records to deny inspection of the part of a recording from a certain body—worn digital recording device worn by a law enforcement officer regarding certain individuals; requiring certain notification of certain individuals; requiring the Police Training and Standards Commission to develop certain uniform standards and policies in consultation with certain groups; requiring a custodian of records to allow inspection of a recording under certain circumstances; etc.
