HOUSE BILLS INTRODUCED FEBRUARY 15, 2022

HB 1387 Delegate Guyton

EMPLOYEES – DEPARTMENT OF STATE POLICE – EMERGENCY DISPATCHER CLASSIFICATION

Requiring the Department of State Police to establish certain emergency dispatcher classifications; and establishing certain compensation levels and employment requirements for emergency dispatcher classifications.

WINERY AND VINEYARD ECONOMIC DEVELOPMENT GRANT PROGRAM

Establishing the Winery and Vineyard Economic Development Grant Program within the Department of Commerce; authorizing certain individuals and corporations to receive a grant equal to 25% of the qualified capital expenses incurred in connection with establishing new wineries and vineyards or completing capital improvements at existing wineries and vineyards; requiring the Governor each year to include in the annual budget bill an appropriation of at least \$1,000,000 to be used for grants under the Program; etc.

This bill requires a mandated appropriation in the annual budget bill.

MARYLAND DEPARTMENT OF HEALTH – PREVENT WORKPLACE VIOLENCE IN HEALTH CARE SETTINGS PUBLIC AWARENESS CAMPAIGN WORKGROUP

Requiring the Secretary of Health to establish the Prevent Workplace Violence in Health Care Settings Public Awareness Campaign Workgroup to develop a public awareness campaign on preventing workplace violence in health care settings and to create a plan for implementing the campaign.

ANNE ARUNDEL COUNTY – SPEED MONITORING SYSTEMS – MARYLAND ROUTE 648 (BALTIMORE–ANNAPOLIS BOULEVARD)

Authorizing the placement and use of speed monitoring systems on Maryland Route 648 (Baltimore–Annapolis Boulevard) at the intersections with Cypress Creek Road and Brandywine Avenue in Anne Arundel County subject to certain placement and signage requirements.

CLEAN CARS ACT OF 2022

Extending and altering, for certain fiscal years, the vehicle excise tax credit for the purchase of certain electric vehicles; decreasing, from \$63,000 to \$55,000, for purposes of the electric vehicle excise tax credit, the limitation on the maximum total purchase price of certain electric vehicles; reducing the vehicle excise tax credit for certain electric drive vehicles; etc.

This bill requires a mandated appropriation in the annual budget bill.

HB 1392 Delegate Queen**PUBLIC HEALTH – BEHAVIORAL RISK FACTOR SURVEILLANCE SYSTEM – REQUIREMENTS**

Establishing requirements related to the conduct of a survey as part of the Behavioral Risk Factor Surveillance System and the reporting of summary data and trends reports.

Altering the definition of “harassment” for purposes of certain provisions relating to discrimination in employment to include sexual harassment and certain unwelcome and offensive conduct; and altering the definition of “sexual harassment” for purposes of certain provisions relating to State government sexual harassment prevention training.

ALCOHOLIC BEVERAGES – MARYLAND ALCOHOL
MANUFACTURING AND PROMOTION

Repealing the Maryland Wine and Grape Promotion Fund and the Advisory Commission on Maryland Wine and Grape Growing; establishing the Advisory Commission on Maryland Alcohol Manufacturing in the Department of Commerce as the successor to the Advisory Commission on Maryland Wine and Grape Growing; establishing the Maryland Alcohol Manufacturing Promotion Fund to provide grants that promote the advantages and attributes of State breweries, distilleries, and wineries and their products; etc.
