HOUSE BILLS INTRODUCED FEBRUARY 22, 2022

HB 1430 Delegate C. Branch

COURTS – SPECIAL COURT DOCKETS – WEAPONS CRIMES

Requiring the Chief Judge of the Court of Appeals to establish a special court docket in each of the circuit courts to exclusively hear and decide cases alleging a violation of certain provisions of law relating to weapons and to assign necessary personnel; and requiring a court assigned a case under the Act to follow the rules of practice and procedure applicable to that court.

PUBLIC HIGH SCHOOLS – STUDENT ATHLETES – COMPENSATION FOR NAME, IMAGE, AND LIKENESS

Providing that certain entities may not establish rules or other limitations to prevent a public high school student athlete from earning compensation for the use of the student athlete's name, image, or likeness or prevent certain public high schools from participating in certain interscholastic athletics under certain circumstances; and authorizing a public high school student athlete to enter into a contract providing compensation for the use of the student athlete's name, image, or likeness if certain conditions are met.

HB 1432 Delegate Kittleman

PUBLIC-SECTOR COLLECTIVE BARGAINING – SERVICE, REPRESENTATION, AND MAINTENANCE FEES – REPEAL

Repealing provisions of law authorizing or requiring the charging of service, representation, or maintenance fees by public-sector exclusive representatives to nonmembers.

Requiring the State Highway Administration to designate Maryland Route 210 as the Piscataway Highway.

PROCUREMENT – BALLOT PRINTING SERVICES CONTRACTS – BOARD OF PUBLIC WORKS APPROVAL

Requiring the Board of Public Works to approve the award of a procurement contract for ballot printing services for ballots before a unit may execute the contract; and prohibiting the Board from delegating its authority to approve the award of a procurement contract for ballot printing services.

HB 1435 Delegate Arentz, et al**TRANSPORTATION – ELECTRONIC TOLL COLLECTION BACKLOG – FEE PROHIBITION**

Prohibiting the Maryland Transportation Authority from charging an administrative fee or a civil penalty for failure to pay video tolls for which processing or billing was delayed due to COVID-19 related factors until 180 days after the Authority has eliminated the toll charge backlog; requiring the Authority to reimburse the registered owner of a motor vehicle that incurred a certain video toll the amount of any administrative fees or civil penalties paid; and applying the Act to certain video tolls incurred on or after March 5, 2020.

HB 1436 Wicomico County Delegation**WICOMICO COUNTY – ORPHANS’ COURT – SALARY OF ORPHANS’ COURT JUDGES**

Increasing the salary of a judge of the Orphans’ Court of Wicomico County from \$9,500 to \$11,600.

HB 1437 Delegates Stein and Lierman**PUBLIC HIGH SCHOOLS – FINANCIAL LITERACY – CURRICULUM, GRADUATION REQUIREMENT, AND PROFESSIONAL DEVELOPMENT**

Requiring the State Board of Education, with the assistance of the Maryland Council on Economic Education, to develop curriculum content for a certain course in financial literacy; requiring each county board of education to implement the curriculum in every public high school beginning in the 2025–2026 school year; requiring the completion of a certain financial literacy course in order to graduate from high school beginning in 2029; etc.

HB 1438 Delegates Johnson and Lisanti**STATE EMERGENCY MEDICAL SERVICES BOARD – PARK SERVICES ASSOCIATES – CERTIFICATION AS EMERGENCY MEDICAL RESPONDERS**

Requiring the State Emergency Medical Services Board to credit certain training and education completed by a certain park services associate toward certification as an emergency medical responder; prohibiting the EMS Board from charging certain fees to any individual who is a certain park services associate; and providing for the issuance of temporary certification as an emergency medical responder to certain park services associates and a process for issuing permanent certification to certain park services associates.

HB 1439 Delegate Landis, et al**MARYLAND INTRASTATE EMERGENCY MANAGEMENT ASSISTANCE COMPACT – CITY OF BOWIE**

Authorizing the City of Bowie to participate in the Maryland Intrastate Emergency Management Assistance Compact; and providing that the Compact is intended to provide for emergency management mutual assistance between certain jurisdictions and for mutual cooperation in emergency management–related exercises, testing, or other training activities.

HB 1440 Delegate Saab, et al**INCOME TAX – SUBTRACTION MODIFICATION – MILITARY RETIREMENT (TAX RELIEF FOR MILITARY RETIREES ACT OF 2022)**

Altering for certain taxable years a certain limitation on a subtraction modification under the Maryland income tax for certain military retirement income; providing the subtraction for the tax year beginning after December 31, 2021, but before January 1, 2023, is the greater of \$15,000 or 50% of the amount of military retirement income received during that taxable year; and providing that for a taxable year beginning after December 31, 2022, all military retirement income received can be subtracted.

ANNE ARUNDEL COUNTY – SCHOOL VEHICLES – DURATION OF OPERATION

Altering the number of years that a school vehicle may be operated in Anne Arundel County from 12 years to 15 years.

CRIMINAL PROCEDURE – EXPUNGEMENT OF RECORDS – MODIFICATIONS

Authorizing the expungement of certain arrest warrants under certain circumstances; altering the waiting periods for applying for expungement of certain records; altering the convictions for which an individual may seek expungement; and prohibiting certain records from being expunged by obliteration for a certain period of time and limiting access to the records during that time.

BALTIMORE CITY – SPEED MONITORING SYSTEMS ON INTERSTATE 83 – USE OF REVENUE FROM FINES

Establishing that revenue from fines collected as a result of violations enforced by speed monitoring systems on Interstate 83 in Baltimore City may be used for roadway improvements to entrance and exit ramps along Interstate 83 in Baltimore City and at the nearest intersection to each ramp.

HB 1444 Delegate Wilkins, et al**INCOME TAX CREDIT – ENDOWMENTS OF MARYLAND HISTORICALLY BLACK COLLEGES – SUNSET REPEAL**

Repealing the termination of certain provisions of law that allow a credit against the State income tax for a certain amount of donations to certain permanent endowment funds at certain institutions of higher education.

HB 1445 Delegate Otto**LAW ENFORCEMENT OFFICERS' PENSION SYSTEM – CRISFIELD POLICE DEPARTMENT**

Requiring membership in the Law Enforcement Officers' Pension System for certain local law enforcement officers of the Crisfield Police Department under certain circumstances; providing that a certain individual is entitled to eligibility service and creditable service that was earned before the effective date of the Crisfield Police Department's participation in the Law Enforcement Officers' Pension System; providing for the transfer of creditable service for a certain individual; etc.

HB 1446 Delegate Solomon**UNIVERSITIES AT SHADY GROVE REGIONAL HIGHER EDUCATION CENTER – WORKFORCE DEVELOPMENT PROGRAMS – FUNDING**

Requiring the Governor to include a \$5,000,000 appropriation in each of fiscal years 2024 and 2025 to the Universities at Shady Grove Regional Higher Education Center; and requiring the Center to use the funding to establish or support workforce development programs at the Center.

This bill requires a mandated appropriation in the annual budget bill.

BALTIMORE CITY – ALCOHOLIC BEVERAGES LICENSES –
OUTDOOR TABLE SERVICE PRIVILEGES – FEE PROHIBITION AND
ALTERATION OF APPLICATION PROCESS

Prohibiting the Board of License Commissioners for Baltimore City from charging a holder of an alcoholic beverages license a certain fee if the holder holds a temporary outdoor seating permit issued by the Mayor and City Council of Baltimore City; and authorizing the Board to grant certain ancillary license privileges to a holder of an alcoholic beverages license and to alter certain notice requirements under certain circumstances.

DISTRICT COURT – CONCURRENT CIVIL JURISDICTION –
VIOLATION OF ORDINANCES

Establishing that the District Court has concurrent civil jurisdiction with a governing body of a county or the Mayor and City Council of Baltimore over a proceeding for adjudication of a violation of certain ordinances.

HOUSE BILLS REASSIGNED FEBRUARY 17, 2022**HB 1238 Delegate Bhandari**

PLACES OF PUBLIC ACCOMMODATION – MOTION PICTURE
HOUSES – CAPTIONING

Requiring all motion picture houses to offer closed captioning for each screening of a motion picture; and requiring that certain motion picture houses provide open captioning for at least certain screenings each week.

HB 1270 Delegates Hill and Carr**MARYLAND REAL PROPERTY TRANSFER-ON-DEATH (TOD) ACT**

Altering the Maryland Uniform Disclaimer of Property Interests Act to provide for the disclaimer of nonprobate transfers at death; providing for the creation, revocation, recordation, and effects of a transfer-on-death deed for real property; requiring the Administrative Office of the Courts to develop an informational sheet regarding transfer-on-death deeds for use at courthouses and on the website for the Maryland courts; providing example forms for the creation and revocation of a transfer-on-death deed; etc.

HB 1349 Delegate Henson**EDUCATION SUPPORT PROFESSIONALS – WORKGROUP AND BONUS**

Establishing the Workgroup to Study the Wages of Education Support Professionals to determine what percentage of education support professionals in the State earn a living wage and to study increasing the wages of education support professionals to attract and retain skilled workers; and requiring the Governor to include in the annual budget bill an appropriation sufficient to provide a bonus to noncertificated public school employees in fiscal year 2024 under certain circumstances.

This bill requires a mandated appropriation in the annual budget bill.
