# HB 425 The Speaker (By Request – Office of the Attorney General) and Delegate Lopez

#### PUBLIC SAFETY – UNTRACEABLE FIREARMS

Altering a certain definition of "firearm" to include a certain unfinished frame or receiver; prohibiting a person from purchasing, receiving, selling, offering to sell, or transferring an unfinished frame or receiver, or possessing a firearm on or after January 1, 2023, unless it is required by federal law to be, and has been, imprinted with a certain number in a certain manner; and requiring the Secretary of State Police to suspend or revoke a certain dealer's license if the dealer is charged with or convicted of a certain crime.

VEHICLE LAWS – POLICIES AND PROHIBITION AGAINST DISCRIMINATORY TRAFFIC STOPS

Requiring the Maryland Police Training and Standards Commission in consultation with the Maryland Statistical Analysis Center to expand the model policy against race—based traffic stops to include traffic stops based solely on an individual's national origin, religion, gender, gender identity, or sexual orientation and requiring law enforcement agencies to adopt similar policies; etc.

ELECTION LAW – FOREIGN MANUFACTURE OF ELECTION SYSTEMS – NOTIFICATION AND TERMINATION OF CONTRACT

Prohibiting the State Board of Elections from approving a contract with an election service provider unless the contract includes a clause requiring the election service provider to report to the State Administrator of Elections if any stage in the manufacturing of a component of the provider's election system occurred outside the United States or if any material change to a component in any stage in the manufacturing of an election system occurred outside the United States; etc.

Requiring certain law enforcement agencies to require, on or before certain dates, the use of body—worn cameras by certain law enforcement officers, subject to certain policies; and requiring certain law enforcement agencies to issue body—worn cameras to law enforcement officers who are required to use body—worn cameras.

Requiring an employer who employs individuals in a food service facility or retail establishment to pay certain employees at a certain rate of pay for certain shifts of work, except under certain circumstances; and providing that certain employees employed in a food service facility or retail establishment have the right to decline to work hours that occur during the 11 hours following the end of a shift; etc.

Increasing the aggregate amount of film production activity tax credit certificates that the Secretary of Commerce may issue in fiscal year 2023 to \$25,000,000 and for fiscal year 2024 and each fiscal year thereafter to \$50,000,000.

Altering the number of, the voting rights of, and the process for electing student members of the Baltimore City Board of School Commissioners; and establishing the Task Force to Study Compensation for the Baltimore City Board of School Commissioners including the student members; and requiring the Task Force to report its recommendations regarding the amount of and revenue stream for any proposed compensation to the Governor and the General Assembly by April 1, 2023.

MOTOR VEHICLES – SPEED LIMITS – ESTABLISHMENT AND ENFORCEMENT

Authorizing Baltimore City to decrease or raise to a previously established level the maximum speed limit on a highway under its jurisdiction without performing an engineering and traffic investigation; and prohibiting a local jurisdiction from implementing a new speed monitoring system to enforce speed limits on any portion of a highway for which the speed limit has been decreased without performing an engineering and traffic investigation.

YOUTH SPORTS PROGRAMS – REGISTRATIONS, PERSONNEL, AND POLICY

Altering the circumstances under which students or youth athletes who are suspected of sustaining a concussion or other head injury in practice or a game and have been removed from play may return to play; requiring a youth sports program to maintain and update a registry of youth sports program personnel who participate in the youth sports program; requiring a youth sports program to provide a copy of its removal and return—to—play policy to the program's personnel and each parent or guardian of a registered youth athlete; etc.

MOTOR VEHICLE INSURANCE – USE OF CREDIT HISTORY RATING POLICY

Prohibiting an insurer, with respect to private passenger motor vehicle insurance, from rating a risk based, in whole or in part, on the credit history of an applicant or insured in any manner; and repealing certain provisions of law authorizing an insurer to use the credit history of an applicant or insured to rate a new policy of private passenger motor vehicle insurance subject to certain limitations and requirements.

CRIMINAL LAW – PUBLIC SAFETY – COMMUNICATIONS WITH PUBLIC SAFETY ANSWERING POINTS

Prohibiting a person from making communications that are reasonably expected to impair the functioning of a public safety answering point or intended to disrupt an emergency response; prohibiting a person from making a false statement, report, or complaint to a public safety answering point or law enforcement officer that results in a certain response; and providing that a person who violates the Act is guilty of a felony and on conviction is subject to imprisonment of up to 5 years or a fine of up to \$25,000 or both.

WASHINGTON METROPOLITAN AREA TRANSIT AUTHORITY – FUNDING FORMULAS – ALTERATION (WMATA DEDICATED FUNDING AMENDMENT ACT OF 2022)

Requiring the appropriation in the annual budget for the purpose of providing grants to pay the capital costs of the Washington Metropolitan Area Transit Authority to equal at least the amount appropriated in fiscal year 2022; requiring, subject to a certain contingency, that a certain mandated appropriation be increased by 3% each year; etc.

This bill requires a mandated appropriation in the annual budget bill.

WORKERS' COMPENSATION – OCCUPATIONAL DISEASE PRESUMPTIONS – 9–1–1 SPECIALISTS

Providing that a 9–1–1 specialist who is diagnosed by a licensed psychologist or psychiatrist with post–traumatic stress disorder is presumed to have an occupational disease that was suffered in the line of duty or course of employment and is compensable under the workers' compensation law.

Increasing the maximum generating capacity of a community solar energy generating system from 2 megawatts to 5 megawatts.

Requiring a court and the Office of the State's Attorney, in the case of a release before trial of a defendant charged with murder in the first or second degree, attempted murder in the first or second degree, robbery with a dangerous weapon, or armed carjacking, to notify the law enforcement agency that arrested the defendant within 48 hours of the release.

Authorizing Baltimore City to enact and enforce local laws regulating the sale and distribution of cigarettes, other tobacco products, and electronic smoking devices, subject to certain exceptions.

Altering certain purposes of the Maryland Corps Program; establishing that the Program is exempt from certain provisions of law relating to procurement but is subject to a certain review by the Office of Legislative Audits; altering the membership of the Board of Directors of the Program; establishing that the Board is a body politic and corporate and is an instrumentality of the State; requiring the Board to meet at least once every two months and that Board meetings are subject to the Open Meetings Act; etc.

This bill requires a mandated appropriation in the annual budget bill.

Requiring an account holder of the Maryland Senator Edward J. Kasemeyer College Investment Plan to be at least 18 years old to qualify for the State matching contribution for applications filed on or after January 1, 2022.

Altering certain notice requirements relating to the intention of a county or municipal corporation to set a certain real property tax rate that exceeds the constant yield tax rate.

Increasing, from one to two, the maximum number of apprentices that certain licensed cosmetologists may directly train and supervise; and requiring the State Board of Cosmetologists in the Maryland Department of Labor to adopt regulations consistent with the Act.

Requiring a State procurement unit to include the dollar value of its contracts with Maryland Correctional Enterprises in the total dollar value of its procurements for the purpose of calculating the unit's Minority Business Enterprise Program participation rate.

Prohibiting an employee of a correctional facility from discriminating against inmates on the basis of certain protected classes; requiring the managing official of a correctional facility to develop a written nondiscrimination policy regarding inmates; and establishing certain requirements for correctional facilities relating to the gender identity of inmates and inmates who are transgender, nonbinary, or intersex.

CORRECTIONAL SERVICES – PREGNANCY AND POSTPARTUM SUPPORT (PREVENTION OF FORCED INFANT SEPARATION ACT)

Requiring the Division of Correction to allow a certain pregnant woman and a certain woman who recently gave birth to transfer to the prerelease unit for women for a certain time period; establishing the Healthy Start Bonding Program to facilitate strong bonds between incarcerated women and their children; and requiring the Division to allow liberal visitation between certain individuals and certain children under certain circumstances.

Requiring each State employee to complete a certain amount of implicit bias awareness training at certain times; requiring that the training include certain information; requiring each unit to designate a representative to coordinate with the Maryland Commission on Civil Rights to implement the training; authorizing a unit to incorporate the training into existing employment training; requiring the Commission to train certain representatives in the prevention of implicit bias; etc.

SUPPLEMENTAL NUTRITION ASSISTANCE PROGRAM – STATE SUPPLEMENT

Lowering from 62 to 60 the minimum age that a member of a household must be for eligibility for a State-provided supplemental benefit under the Supplemental Nutrition Assistance Program; increasing the amount of the supplemental benefit that the State must provide by increasing the minimum total monthly benefit from \$30 to \$45; etc.

CORPORATE INCOME TAX – THROWBACK RULE AND COMBINED REPORTING

Requiring that certain sales of tangible personal property be included in the numerator of the sales factor used for apportioning a corporation's income to the State under certain circumstances; requiring affiliated corporations to compute Maryland taxable income using a certain combined reporting method; authorizing certain corporations, subject to regulations adopted by the Comptroller, to determine certain income using the water's edge method; etc. VARIOUS EFFECTIVE DATES

Altering the collective bargaining process for State employees, including by requiring the selection of a neutral arbitrator to oversee all aspects of collective bargaining, establishing a process of arbitration in the event of impasse, and providing that certain decisions of a neutral arbitrator are binding; requiring that each budget bill contain the appropriations necessary to implement all terms and conditions of employment in certain memoranda of understanding for the next ensuing fiscal year; etc.

Altering provisions of law relating to the jurisdiction of the juvenile court, the juvenile intake process, and the placement of a certain child in detention or community detention; altering provisions of law relating to the authority of the juvenile court in making a disposition on a certain petition; specifying the authority of the juvenile court to place a child on probation under certain circumstances; etc.

Authorizing the Board of License Commissioners for Baltimore County to approve the transfer of a Class B or Class D license in Election District 15 existing on a certain date to another election district under certain circumstances; prohibiting the Board from authorizing the transfer of a certain number of licenses out of Election District 15; repealing a certain transfer schedule of Class B and Class D licenses from Election District 15; and altering requirements related to the issuance of a Class B Service Bar (SB) license.
