#### HB 461 Delegate Rogers, et al

INCOME TAX SUBTRACTION MODIFICATION – MILITARY AND PUBLIC SAFETY RETIREMENT INCOME

Increasing from \$15,000 to \$20,000 the amount of certain subtraction modifications under the Maryland income tax for individuals who are at least 55 years of age for certain retirement income received as a result of the individual's military service or attributable to the individual's employment as a correctional officer, a law enforcement officer, or a fire, rescue, or emergency services personnel.

HEALTH OCCUPATIONS – AUTHORIZED PRESCRIBERS – REPORTING OF FINANCIAL GRATUITIES OR INCENTIVES

Requiring each authorized prescriber who receives a financial gratuity or incentive from a pharmaceutical distributor or manufacturer to file a disclosure form with a certain health occupations board that licenses the authorized prescriber within 30 days after the financial gratuity or incentive is received by the authorized prescriber; and applying the Act prospectively EFFECTIVE OCTOBER 1, 2022 HO, § 1-227 - added Assigned to: Health and Government Operations

#### HB 463 Delegate Acevero

CIVIL RIGHTS – VIOLATION OF RIGHTS – GOVERNMENTAL LIABILITY

Establishing the civil liability of a police officer who deprives or allows another to deprive an individual of certain rights under the Maryland Declaration of Rights and the Maryland Constitution; requiring that the employer of a police officer indemnify the law enforcement officer against a judgment or settlement entered against the officer under the Act subject to certain exceptions; requiring that a civil action under the Act be filed within 2 years after the cause of action occurs; etc.

Repealing a prerequisite that a certain public school employee shall exhaust administrative remedies before instituting a certain civil action; authorizing a public school employee who is subject to a certain personnel action to file an administrative complaint with a public school employer; requiring a public school employer to provide an administrative remedial process; requiring certain public school employees to give prior notice to the local superintendent of schools about instituting a civil action; etc.

Authorizing the Motor Vehicle Administration to enter into a certain agreement with another jurisdiction for the reciprocal enforcement of traffic violations recorded by a traffic control signal monitoring system under certain circumstances; requiring a political subdivision to coordinate with the Administration to facilitate the reciprocal enforcement of violations recorded by a traffic control signal monitoring system; etc.

Prohibiting a person from indecently exposing the person's genitals with lascivious or prurient intent in a public place in the presence of another; and altering a certain definition of "tier I sex offender" to include a person who has been convicted of conspiring to commit, attempting to commit, or committing indecent exposure with lascivious or prurient intent in a public place in the presence of a minor under the age of 14 years and at least 4 years younger than the convicted person.

Requiring the State Board of Education, by March 31, 2023, to develop policies and procedures for reporting, administering, investigating, and resolving complaints related to incidents of sexual misconduct and violations of Title IX of the Education Amendments of 1972; and authorizing a person to bring a civil action against a local system that fails to comply with certain policies and procedures and to recover damages, reasonable costs, and attorney's fees.

Authorizing certain local governments to allow, by law, a first-time homebuyer in the State to calculate the homestead property tax credit for property that includes a newly purchased dwelling using a certain method; requiring that the credit for a newly purchased dwelling be calculated in a certain manner; and providing that a certain homeowner may receive the larger of the homestead property tax credit amounts as calculated using certain methods. Requiring the Department of State Police to make a tow list of towing businesses authorized by the Department to perform nonconsensual towing services of disabled or abandoned commercial vehicles and approved rates available to the public on request; and establishing certain requirements and procedures for the nonconsensual towing of certain commercial vehicles at the direction of the Department.

Authorizing the governing body of a county to establish a system of public campaign financing for the offices of State's Attorney, sheriff, register of wills, judge and clerk of the Circuit Court, judge of the Orphans' Court or an elected member of the County Board of Education after the governing body of the county has implemented a system of public campaign financing for elective offices in the executive or legislative branches of county government for at least one complete election cycle.

Repealing the requirement that an individual serve beer, wine, and liquor under a Harford County stadium beer, wine, and liquor license only in plastic, Styrofoam, or paper containers and authorizing an individual to serve beer, wine, and liquor under the license by the drink and by the bottle, from one or more outlets, for on-premises consumption.

This bill requires a mandated appropriation in the annual budget bill.

INCOME TAX – SUBTRACTION MODIFICATION – RETIREMENT INCOME

Including income from certain retirement plans within a certain subtraction modification allowed under the Maryland income tax for certain individuals who are at least 65 years or who are disabled or whose spouse is disabled; altering the maximum amount of the subtraction modification beginning in taxable year 2022; providing that income included in certain subtraction modifications may not be taken into account for purposes of the subtraction modification for retirement income; etc.

Authorizing the Workers' Compensation Commission, if there is no compensation other than a medical benefit payable to a covered employee, to order that a fee of not more than \$2,000 for legal services rendered on behalf of the covered employee be payable by the covered employee, an employer or its insurer, a self-insured employer, or the Uninsured Employers' Fund; exempting the ordered fee from the requirement that a fee approved by the Commission be a lien on compensation awarded; and applying the Act prospectively.

Expanding the applicability of the annual sales and use tax-free period to certain sewing items used to make clothing if the taxable price of each item is less than \$100; and providing that "sewing item" includes the material used to make clothing, fabric, thread, zippers, bias tape, and elastic but does not include sewing machines, pins, pin cushions, scissors, or needles.
