## SENATE BILLS INTRODUCED February 10, 2022

### **SB 908 Harford County Senators**

HARFORD COUNTY BOARD OF EDUCATION – APPOINTMENT OF MEMBERS – ALTERATIONS

Altering the process for appointing members of the Harford County Board of Education.

HEALTH OCCUPATIONS – NURSING HOME ADMINISTRATOR – QUALIFICATIONS

Establishing an exception to the requirement that an individual be licensed by the State Board of Examiners of Nursing Home Administrators before the individual may practice in this State for a person who holds a license in another state and has certain experience; altering the qualifications for applicants for a license to practice as a nursing home administrator; etc.

NONDISCRIMINATION – COURTS AND OTHER GOVERNMENTAL ENTITIES – PROHIBITIONS, POLICY, AND TRAINING (ACCESS TO JUSTICE FOR ALL YOUTH)

Requiring the Administrative Office of the Courts and the Department of Juvenile Services to provide certain nondiscrimination training to certain employees and contractors; establishing that certain provisions of law prohibiting discrimination apply to units, officers, employees, and contractors of the State, a county, or a municipal corporation and to a grantee, a program, or an entity receiving State funds; and establishing a certain policy of the State relating to equal access to courts and nondiscrimination.

CONSTITUTIONAL AMENDMENT – ENVIRONMENTAL RIGHTS

Proposing an amendment to the Constitution of Maryland to establish that every person has the fundamental and inalienable right to a healthful and sustainable environment; and requiring the State to serve as the trustee of the State's natural resources, including the air, land, water, wildlife, and ecosystems of the State, and to conserve, protect, and enhance the State's natural resources for the benefit of every person, including present and future generations.

**SB 785    The President (By Request – Department of Legislative Services)**

DEPARTMENT OF LEGISLATIVE SERVICES – COLLECTION OF INFORMATION RELATED TO PUBLIC SAFETY, CRIMINAL JUSTICE, CORRECTIONS, AND JUVENILE SERVICES

Requiring the Department of Public Safety and Correctional Services, the Department of State Police, the Maryland Police Training and Standards Commission, and the Governor's Office of Crime Prevention, Youth, and Victim Services to provide certain information related to public safety and criminal justice in a certain manner to the Department of Legislative Services on or before a certain date each year; etc.
