CIVIL ACTIONS – CHILD SEXUAL ABUSE – DEFINITION AND STATUTE OF LIMITATIONS (THE CHILD VICTIMS ACT OF 2023)

Altering the definition of "sexual abuse" for purposes relating to civil actions for child sexual abuse to include any act that involves an adult allowing or encouraging a child to engage in certain activities; repealing the statute of limitations in certain civil actions relating to child sexual abuse; repealing a statute of repose for certain civil actions relating to child sexual abuse; providing for the retroactive application of the Act under certain circumstances; etc.

INCOME TAX – SUBTRACTION MODIFICATION – UNION DUES

Allowing a subtraction modification under the Maryland income tax for certain union dues paid during the taxable year; and applying the Act to all taxable years beginning after December 31, 2022.

MARYLAND STATE POLICE GUN CENTER – FIREARMS SURRENDERED UNDER FINAL PROTECTIVE ORDERS

Altering the purpose of the Maryland State Police Gun Center to include the tracking, screening, and vetting of all firearms surrendered under final protective orders in the State; and requiring each law enforcement agency to report to the Center the number and type of firearms surrendered, the jurisdictions where the firearms were surrendered, and certain information regarding the individual who surrendered each firearm under final protective orders.

Repealing a certain prohibition on prosecuting a person for rape or a certain sexual offense against a victim who was the person's legal spouse at the time of the alleged rape or sexual offense.

EDUCATION – PLAYGROUND ACCESSIBILITY – COMMUNICATION BOARDS

Requiring county boards of education to construct communication boards in each public school playground on or before October 1, 2028; and defining "communication board" as a device that displays photos, symbols, or illustrations to enable individuals with limited language skills to express themselves and communicate.

DEPARTMENT OF GENERAL SERVICES – ENERGY–CONSERVING STANDARDS (MARYLAND SUSTAINABLE BUILDINGS ACT OF 2023)

Requiring the Department of General Services to establish and periodically update standards for State buildings to conserve energy and minimize adverse impacts on birds; requiring the Maryland Green Building Council to include the standards in any requirements established for participation in a higher–performance building program in the State; defining "State building" as one acquired, constructed, or renovated by the State or one for which 50% of the money for acquisition, construction, or renovation came from State funds.

ELECTRIC VEHICLE RECHARGING EQUIPMENT REBATE PROGRAM – RENEWAL

Altering the Electric Vehicle Recharging Equipment Rebate Program by extending the duration of the Program through fiscal year 2027, increasing the total amount of rebates issued annually under the Program to \$2,000,000, repealing the rebates that may be issued to retail service station dealers, limiting the issuance of rebates to one recharging system per individual per address, and authorizing the Maryland Energy Administration to offer additional benefits under certain circumstances; etc.

This bill requires a mandated appropriation in the annual budget bill.

Requiring the departments of Housing and Community Development, Planning, Human Services, and Agriculture jointly to produce a report to the General Assembly for each county and State legislative district on the food environment in the county and district on or before July 1, 2024, and every 2 years thereafter; requiring the reports to include metrics that determine food insecurity zones; authorizing the departments to collaborate with certain universities, nonprofit organizations, and local planning and zoning departments; etc.

EQUITY IN TRANSPORTATION SECTOR – GUIDELINES AND ANALYSES

Requiring that equity be considered when State transportation plans, reports, and goals are developed; altering the membership of the advisory committee on State transportation goals; requiring the Maryland Department of Transportation to conduct transit equity analyses, cost—benefit analyses, and consult with certain communities before announcing or proposing any major service change or any reduction or cancellation of a certain capital expansion project in the construction program; etc.

Requiring membership in the Correctional Officers' Retirement System for certain local detention center officers of Talbot County in the event Talbot County becomes a participating governmental unit in the Correctional Officers' Retirement System; and providing that certain local detention center officers who join the Correctional Officers' Retirement System and receive certain service credit shall no longer be members of the Employees' Pension System and shall have no further rights to any benefit in the Employees' Pension System.

Establishing the Private Well Safety Program in the Department of the Environment to manage and, subject to the availability of certain funding, address the contamination of certain private and domestic water supply wells in the State; establishing the Private Well Safety Fund to award grants to certain counties and households for costs associated with water quality testing and remediation; requiring the Department to utilize an online portal to receive and upload certain information; etc.

Establishing the Transit-Oriented Development Capital Grant and Revolving Loan Fund to promote the equitable and inclusive development of transit-oriented developments; requiring interest earnings of the Fund to be credited to the Fund; authorizing the Department of Transportation to use the Fund to provide financial assistance to local jurisdictions; requiring the Governor to include in the annual budget bill an appropriation sufficient to ensure a fund balance of at \$10,000,000 at the start of the fiscal year; etc.

This bill requires a mandated appropriation in the annual budget bill.

INCOME TAX SUBTRACTION MODIFICATION – MILITARY AND PUBLIC SAFETY RETIREMENT INCOME

Increasing the amount of certain subtraction modifications under the Maryland income tax for individuals who are at least 55 years of age for certain retirement income received as a result of the individual's military service or attributable to the individual's employment as a correctional officer, a law enforcement officer, or a fire, rescue, or emergency services personnel; etc.

PRIMARY AND SECONDARY EDUCATION – TITLE IX – NOTICE (HEAR OUR VOICES ACT)

Requiring each public school to provide information to students, faculty, staff, and parents regarding who serves as the Title IX coordinator for the school, the process in place for filing a sexual misconduct complaint, and the support measures that are in place for filing a sexual misconduct complaint and how to access the support measures.

EMPLOYMENT STANDARDS – RETAIL ESTABLISHMENTS – SEATING FOR EMPLOYEES

Establishing requirements related to the provision of seating for employees employed at retail establishments in the State that have 20 or more retail employees for each working day in each of 20 or more calendar weeks; establishing enforcement mechanisms, including by creating a private right of action; and providing a penalty of \$100 per pay period for an initial violation and \$200 per pay period for subsequent violations.

Altering statutory forms for a limited and general power of attorney to include certain provisions relating to the authority of an agent to perform certain acts to assist the principal in meeting eligibility requirements and qualifying for certain governmental benefits or programs; and altering a certain provision in a certain statutory form for a limited power of attorney relating to the authority of an agent to make a gift of part or all of a principal's property or to take certain action with respect to certain trusts.

Requiring the State Board of Examiners of Psychologists to issue electronic licenses and certificates; repealing the requirement that the Board include certain information on each license and registration; and requiring the Board to send renewal notices by first—class mail if the electronic notice is returned as undeliverable, or on a specific request by the registrant.

Prohibiting an adult from allowing certain minors to ride a horse, donkey, mule or pony on a highway, public—horse—riding path, or any other property open to the public or used by the public for pedestrian or vehicular traffic unless the minor is wearing a helmet that meets or exceeds the standards of the American Society of Testing and Materials for protective headgear used in equestrian riding.

PROPERTY TAX – TAX SALES – NOTICES AND PAYOFF AMOUNT FOR REDEMPTION

Requiring that the holder of a certificate of sale include the e-mail address of certain persons in certain notices required to be sent to certain persons with an interest in a property that is sold at a tax sale; authorizing the owner of owner-occupied property sold at a tax sale to request the current payoff amount to redeem the property; providing that the payoff amount to redeem the property provided by the holder of the certificate to the owner of the property is valid for 30 days; etc.

Prohibiting a local board of elections from removing an absentee ballot from a return envelope or ballot/return envelope or counting the ballot unless the return envelope or ballot/return envelope is signed by the voter and, except under certain circumstances, a witness, and the local board verifies the voter's signature; and providing that the witness signature requirement does not apply to active duty uniformed services members serving overseas or their spouses or dependents who live overseas.

Requiring the owner of a manufactured housing community to comply with certain requirements when selling the manufactured housing community; requiring the owner, at least 60 days prior to entering into a contract for the sale of the community, to provide notice of the terms of the offer to each homeowner in the community and provide homeowners the opportunity to purchase the manufactured housing community; and providing that the community owner is liable to the homeowners organization for \$10,000 under certain circumstances. EFFECTIVE OCTOBER 1, 2023

SALES AND USE TAX – MUSICAL INSTRUMENTS – EXEMPTION

Exempting the sale or rental of musical instruments to be used by students in elementary school, a secondary school, or a postsecondary institution, or is registered with a local school system as receiving home instruction from the sales and use tax.

Requiring that an individual to be licensed as a psychologist by the State Board of Examiners of Psychologists must have a doctoral degree in psychology from a certain school or university, received a postdoctoral respecialization certificate from a certain department of psychology, completed at least 1,500 hours advanced training or precertification hours of service as a registered psychology associate, and at least two years of professional, supervised experience in psychology approved by the board.

Requiring a floral wire service to adopt clear and concise billing practices in dealings with local florists or third—party sellers; requiring a floral wire service to disclose to a customer when the floral wire service is buying from a floral wire service and not directly from a local florist; requiring a floral wire service to provide to local florists or third—party sellers a method for submitting charge disputes; providing that a violation of the Act constitutes an unfair, abusive, or deceptive trade practice; etc.

Allowing a credit against the State income tax for qualified expenses paid or incurred by a caregiver during the taxable year in caring for a qualified senior family member; and defining "qualified senior family member" as an individual who is at least 60 years of age, is a relative of the taxpayer, and resides on the same property as the taxpayer's permanent place of residence for at least 6 months of the taxable year.

Altering certain plastic resin labeling requirements for rigid plastic containers and plastic bottles to require the "chasing arrows" symbol; altering the capacity of the plastic bottles to which the plastic resin labeling requirements apply; establishing plastic resin labeling requirements for plastic bags; prohibiting the display of a certain symbol on plastic bags, plastic bottles, and rigid plastic containers if the bags, bottles, and containers do not meet certain requirements; prohibiting certain environmental marketing claims; etc.

Regulating the use of biometric data by private entities, including by requiring certain private entities in possession of biometric data to develop a written policy, made available to the public, establishing a retention schedule and guidelines for permanent destruction of biometric data; prohibiting an entity that collects biometric data from selling, leasing, or trading an individual's biometric data; authorizing an individual alleging a violation of the Act to bring a civil action against the offending private entity; etc.

Prohibiting a landlord from increasing a tenant's rent because a judgment was entered against the tenant in a failure to pay rent action; requiring the District Court to seal all court records within 60 days after the final resolution of a failure to pay rent proceeding under certain circumstances; requiring the District Court to seal all court records relating to a failure to pay rent proceeding, on motion by a tenant, under certain circumstances; requiring the Maryland Judiciary to publish on its website a certain form; etc.

Requiring an election judge to establish a voter's identity by requiring the voter to present a valid government—issued photo identification or a valid nongovernment—issued photo identification, and a current bill, statement or check that states the voter's name and address as proof of identity; requiring a voter to vote a provisional ballot if the voter is unable to provide certain proof of identity; and prohibiting a person from knowingly and willfully voting or attempting to vote under a false form of identification.

Requiring a publicly traded corporation that is required to file a Maryland income tax return to attach a statement identifying the corporation's effective tax rate and an explanation of the calculation of the effective tax rate; and requiring that the statement be made under oath, signed in in the same manner as required for income tax returns, subject to audit by the Comptroller, and treated as confidential taxpayer information.

Requiring that single-occupancy public restrooms be marked with gender-inclusive signage that does not indicate a specific gender, contains certain descriptive language, and contains a picture or icon that does not indicate a specific gender in certain places of public accommodation and certain public buildings; providing that a county is responsible for enforcing the signage requirement in places of public accommodation; and authorizing a county to set certain fines for second and subsequent violations after a certain period of time.
