Renaming the Alcohol and Tobacco Commission to be the Alcohol, Tobacco, and Cannabis Commission; establishing a regulatory and licensing system for adult–use cannabis; imposing the sales and use tax on the sale of adult–use cannabis at certain rates in certain fiscal years; establishing the Cannabis Regulation and Enforcement Division in the Commission; requiring the Division, on or before July 1, 2023, to convert medical cannabis licenses to licenses to operate a medical and adult–use cannabis business; etc. EMERGENCY BILL

Authorizing and empowering the County Commissioners of Carroll County to borrow not more than \$65,600,000 in order to finance the construction, improvement, or development of certain public facilities in Carroll County, and to effect such borrowing by the issuance and sale at public or private sale of its general obligation bonds; etc.

Authorizing a holder of a Class 9 limited distillery license to sell and deliver alcoholic beverages manufactured under the license in bulk to a person in the State that is authorized to acquire them and to a person outside the State that is authorized to acquire them; and repealing the prohibition against a holder of a Class 9 limited distillery license applying for or possessing a wholesaler's license.

Prohibiting a public school from prohibiting a student from organizing or participating in a student–organized peaceful demonstration, imposing certain limits on a student's right to free speech while participating in a student–organized peaceful demonstration, or disciplining a student for organizing or participating in a student–organized peaceful demonstration under certain circumstances; and requiring each county board of education to develop a written policy regarding student–organized peaceful demonstrations. Establishing the Education Savings Account program in the State administered by the State Department of Education to provide grants to the account of the parent of an eligible student in order to provide for the eligible student's education; requiring the parent of an eligible student to participate in a certain agreement with the Department; and allowing a subtraction modification under the Maryland income tax for deposits into an education savings account. PUBLIC HEALTH – PRESCRIPTION OPIOIDS – DEACTIVATION SYSTEMS

Prohibiting the dispensing of prescription opioids unless the dispenser provides a personal use pharmaceutical disposal system to the ultimate user at no cost; defining a "personal use pharmaceutical disposal system" as a portable product designed to allow the ultimate user to deactivate the prescribed opioid to a nonretrievable condition; and authorizing the Maryland Department of Health to provide personal use pharmaceutical disposal systems to certain pharmacies. Requiring the Maryland Department of Health to allow certain entities provided opioid overdose reversal drugs by the Department under the Overdose Response Program to choose the formulation or dosage of opioid overdose reversal drugs approved by the federal Food and Drug Administration with which the entity is to be provided.

Requiring the State Board of Elections, in collaboration with the local boards of elections, to conduct a risk–limiting audit after each statewide election; authorizing, rather than requiring, the State Board, in collaboration with the local boards, to conduct an automated software audit after a statewide election; repealing a requirement to conduct a manual audit after each statewide general election; etc.

Altering certain requirements for a model policy prohibiting bullying, harassment, or intimidation in public and nonpublic schools; requiring that if the act of bullying, harassment, or intimidation is determined to be motivated by the alleged victim's actual or perceived sex, sexual orientation, or gender identity, notification to the parent or guardian of the alleged victim shall be at the discretion of the alleged victim; and requiring the State Board of Education and each nonpublic school to update the model policy by September 1, 2023. Establishing reentry–into–society status as a protected class for purposes of State fair housing laws and prohibiting discriminatory practices in residential real estate transactions and the sale or rental of a dwelling because of a person's reentry–into–society status; and defining "reentry–into–society status" as the state of having completed a court–ordered sentence of imprisonment.

#### ELECTION LAW – POLLING SITES – FIREARMS PROHIBITIONS

Prohibiting a person from carrying or displaying a firearm on the premises of a privately or publicly owned building being used as a polling site during an election, including a parking lot, or carrying or possessing a firearm within 100 feet of a polling site during an election, subject to certain exceptions. Requiring the inclusion of certain State service while an individual was employed by the Historic St. Mary's City Commission for the purpose of determining eligibility for State retiree health benefits for a retiree of the Historic St. Mary's City Commission.

Requiring a law enforcement agency to file any administrative charges arising out of an investigation of alleged police officer misconduct that is not required to be reviewed by an administrative charging committee within 1 year and 1 day from the date of the incident that led to the investigation.

Extending a tax credit against the State income tax for fresh farm and organic fresh farm food donations; altering the amounts of the tax credit from 75% to 100% of the value of the donated certified organic produce a qualified farm is eligible to receive under certain circumstances; etc.

### PUBLIC SAFETY – USE OF FORCE INCIDENT REPORTS

Altering the reporting requirement applicable to a law enforcement officer or police officer involved in a use of force incident in the line of duty to include the law enforcement officer's justification for the use of force; and requiring a local law enforcement agency to publish on its website by January 1, 2024 and every 3 months thereafter, certain information regarding the use of force incidents reported for the preceding 3 months.

Authorizing, for a certain period of time, the Board of License Commissioners for Baltimore City to exchange a Class B–D–7 beer, wine, and liquor license in a certain area for a Class A–7 beer, wine, and liquor license under certain circumstances; and terminating the Act on July 1, 2024. HEALTH INSURANCE – QUALIFIED RESIDENT ENROLLMENT PROGRAM (ACCESS TO CARE ACT)

Altering the purpose of the Maryland Health Benefit Exchange Fund to include the provision of funding for the establishment and operation of the Qualified Resident Enrollment Program; requiring the Maryland Health Benefit Exchange to establish and implement the Program to allow qualified residents to obtain coverage, facilitate the enrollment of qualified residents in qualified health plans, and, based on the availability of funds, provide premium assistance and cost-sharing reductions to qualified residents; etc.

## HB 590 Delegate Pruski

WORKERS' COMPENSATION – BENEFITS – OFFSET AND HEARING LOSS

Altering the circumstances under which the payment of a benefit by a governmental unit or quasi-public corporation to a covered employee offsets the liability for benefits under the workers' compensation law; altering the method used to determine the deduction required to be made to allow for the average amount of hearing loss from nonoccupational causes in the population for purposes of calculating workers' compensation benefits for occupational deafness; etc.

CRIMINAL PROCEDURE – RESTITUTION ORDERS – RECORDING FEES

Providing that value–added agricultural activities are a farm or agricultural use of land for assessment purposes; creating a subclass of real property consisting of improvements on an actively used farm that support value–added agricultural activities; requiring improvements on an actively used farm that support value–added agricultural activities to be assessed at the agricultural use rate; etc.

Establishing the Lifesaver Schools Program to recognize public schools that provide health and safety training to students and school personnel; and requiring the State Department of Education to adopt certain criteria for designation as a Lifesaver School that at a minimum require public schools to offer to students and school personnel evidence–based training on CPR and first aid and a mental health wellness program or a peer mentoring program. ## HB 594 Delegate Fair

### ELECTION LAW - ASCERTAINMENT OF RESULTS - PROCESS

Requiring that the Governor ascertain and enumerate the number of votes cast for each candidate in certain elections consistent with the returns of the election received by the Governor in accordance with certain provisions of law; and requiring the Governor to issue and transmit a certificate of ascertainment of presidential electors under certain provisions of federal law.

Establishing the Rural Nonemergency Medical Transportation Program for hospitals to coordinate transportation provided by a nonprofit organization to or from medical services for eligible individuals; repealing a certain cap on the amount of grants that may be awarded by the Maryland Transit Administration under the Maryland Senior Rides Program; requiring the Governor to provide \$1,000,000 annually for the Rural Nonemergency Medical Transportation Program in the State budget beginning in fiscal year 2025; etc.

This bill requires a mandated appropriation in the annual budget bill.

Repealing the definition of "public safety officer" for purposes of a certain credit against the county or municipal corporation property tax imposed on a dwelling owned by a public safety officer; repealing a certain limitation on the amount of the credit; requiring the governing body of a county or municipal corporation that authorizes the credit to establish, by law, the definition of "public safety officer" for purposes of eligibility for the credit; and applying the Act to all taxable years beginning after June 30, 2023.
