# HB 724 Delegate Charkoudian

## **UNEMPLOYMENT INSURANCE MODERNIZATION ACT OF 2023**

Altering the taxable wage base used to determine employer contributions to the Unemployment Insurance Trust Fund; requiring the Secretary of Labor to set the taxable wage base and the maximum weekly benefit amount in a certain manner for certain years; prohibiting the applicable table of rates from shifting more than a certain number of tables under certain circumstances; establishing certain collateral requirements for certain investment funds that own certain portfolio companies; etc.

## **HB 725** Delegate Henson

MARYLAND MEDICAL ASSISTANCE PROGRAM, MARYLAND CHILDREN'S HEALTH PROGRAM, AND COMMUNITY FIRST CHOICE PROGRAM – REIMBURSEMENT OF SERVICE PROVIDERS

Increasing from 4% to 10% the percentage reimbursement rate increase that is required to be included in the Governor's proposed budget for fiscal year 2024 for providers of certain health care services under the Maryland Medical Assistance Program, the Maryland Children's Health Program, and the Community First Choice Program; requiring that 90% of the funding increase be used to fund wage increases for certain workers; and requiring that nursing homes annually submit a cost report to the Maryland Department of Health.

## HB 726 Delegate Feldmark, et al

MARYLAND MEDICAL ASSISTANCE PROGRAM – AUTISM WAIVER – MILITARY FAMILIES

Requiring, unless the child's family requests that the child be removed, that a child on the registry for the Autism Waiver remain on the registry if the child's family relocates out of the State for military service; and providing that if a child on the registry for the Waiver becomes eligible for services while the child's family is out of the State for military service, the child shall be eligible for services through the waiver if the family relocates to the State.

PHYSICIAN ASSISTANTS – REVISIONS (PHYSICIAN ASSISTANT MODERNIZATION ACT OF 2023)

Requiring that a physician assistant have a collaboration registration, rather than a delegation agreement, in order to practice as a physician assistant; altering the scope of practice of a physician assistant; altering the education required for licensure as a physician assistant; authorizing physician assistants who are employees of the federal government to perform acts, tasks, or functions as a physician assistant during a certain disaster; and providing certain immunity to certain physician assistants.

# **HB 728** Delegate Amprey

RESIDENTIAL PROPERTY – EXCLUSIVE LISTING AGREEMENTS – LIMIT ON DURATION

Prohibiting an exclusive listing agreement for the sale of residential property from being effective for more than 1 year; and requiring the State Real Estate Commission to include an assessment of the use of exclusive listing agreements and any detrimental impact of these agreements on transactions for resident property in a certain annual report.

REAL PROPERTY – SHERIFF'S SALES – NOTICE, PROCEDURES, AND SUBORDINATE INTERESTS

Requiring a judgment creditor to provide notice by certified and first—class mail to certain persons regarding the time, place, and terms of the sale of any real property subject to a sheriff's sale at least 20 days before the property can be sold and to file a certain affidavit that the individual provided such notice; establishing that a sheriff's sale of real property extinguishes subordinate liens on the land being executed if the requirements of the Act are met and the judgment creditor has complied with any applicable rules; etc.

# HB 730 Delegate Fisher, et al

CONSTITUTIONAL AMENDMENT – ALTERATION OF RATE OF TAXATION – LEGISLATION BY GENERAL ASSEMBLY REQUIRED

Prohibiting the General Assembly from providing, by law, for the alteration of the rate of an existing State tax based on inflation or formula; and prohibiting a certain alteration to a rate of State tax from taking effect unless the General Assembly, by legislation passed in a certain manner, explicitly approves the new tax rate.

PENSIONS AND RETIREMENT – FORFEITURE OF BENEFITS – LAW ENFORCEMENT OFFICERS

Establishing that law enforcement officers are subject to forfeiture of benefits from the State Retirement and Pension System or a local system when a law enforcement officer is found guilty of, pleads guilty to, or enters a plea of nolo contendere to a qualifying crime that is committed in the course of the performance of the law enforcement officer's duties; providing for the processes and procedures to implement a forfeiture of benefits; and providing for the processes and procedures to reverse a forfeiture of benefits.

HEALTH – MENTAL HEALTH CARE PROVIDER IMMUNITY AND ESTABLISHMENT OF SPECIALTY TERTIARY CARE PSYCHIATRIC PROGRAMS

Establishing that certain mental health care providers, administrators of certain programs, and certain employees of administrators have immunity from liability for certain actions related to harm to or from certain patients; and providing that the Maryland Department of Health is a "reporting agency" for the purpose of certain provisions of law governing public—private partnerships under certain circumstances.

#### YOUTH SPORTS SAFETY ADVISORY COMMISSION

Establishing the Youth Sports Safety Advisory Commission to study evidence—based policies and practices for maximizing safety for youth athletes with a concentration on youth athletes who are under the age of 15 years; and requiring the Commission to submit a report of its findings and recommendations to the Governor, the State Board of Education, the Maryland Department of Health, and the General Assembly by December 31, 2024.

## HB 734 Delegates Hill and Wu

YOUTH SPORTS PROGRAMS – REGISTRATIONS, PERSONNEL, AND POLICY

Requiring youth sports programs to maintain and update a registry of youth sports program personnel who participate in the youth sports program; requiring a parent or guardian of a youth registered with a youth sports program to sign and submit to the youth sports program an acknowledgment of the receipt of certain information; and requiring a youth sports program to post its removal and return—to—play policy on its website, if available.

# HB 735 Chair, Appropriations Committee (By Request – Departmental – University System of Maryland)

UNIVERSITY SYSTEM OF MARYLAND – ACADEMIC FACILITIES BONDING AUTHORITY

Approving certain projects for the acquisition, development, and improvement of certain academic facilities for the University System of Maryland; approving the issuance of bonds by the University System of Maryland in a total principal amount of \$25,000,000 for financing the projects; and providing that the bonds are not a debt or obligation of the State or any of its subdivisions.

CRIMINAL PROCEDURE – PRETRIAL RELEASE – CRIME OF VIOLENCE (NO BAIL FOR REPEAT VIOLENT OFFENDERS ACT OF 2023)

Prohibiting a judicial officer from authorizing the pretrial release of a defendant who is charged with a crime of violence if the defendant has a pending charge for a crime of violence or was convicted within the previous 10 years of a crime of violence.

# HB 737 Delegate Ghrist, et al

ALTERNATIVE EDUCATION OPTIONS – RIGHT TO LEARN AND BROADENING OPTIONS AND OPPORTUNITIES FOR STUDENTS TODAY PROGRAMS (RIGHT TO LEARN ACT OF 2023)

Requiring, on or before January 1 each year, and based on certain star ratings, each county board of education to notify the parents or guardians of students in a failing school that the school is failing and provide a list of options; establishing the Right to Learn Program to provide students in failing schools with certain scholarships; establishing the Broadening Options and Opportunities for Students Today Program to provide scholarships for students eligible for free and reduced—price lunches to attend a non—public school; etc. This bill requires a mandated appropriation in the annual budget bill.

# HB 738 Delegate Griffith, et al

PUBLIC SCHOOLS – APPROPRIATIONS FOR SCHOOL SAFETY EXPENDITURES – INCREASE (SCHOOL SAFETY ENHANCEMENT ACT OF 2023)

Beginning in fiscal year 2025, increasing from \$10,000,000 to \$20,000,000 an annual appropriation to the Safe Schools Fund to provide grants to local school systems and local law enforcement agencies to assist in meeting an annual reporting requirement on law enforcement coverage in public schools.

This bill requires a mandated appropriation in the annual budget bill.

PRIMARY AND SECONDARY EDUCATION – FULL–TIME EQUIVALENT ENROLLMENT COUNT – ALTERATIONS (TRUANCY REDUCTION ACT OF 2023)

Altering the definition of "full–time equivalent enrollment" in the calculation for State education aid to include the average number of students enrolled in kindergarten through grade 12 on September 30, December 31, March 31, and the last day of the prior school year; and applying the Act to the calculation of education funding for fiscal years beginning after June 30, 2024.

EDUCATION – ACCOUNTABILITY AND IMPLEMENTATION BOARD – MEMBERSHIP

Altering the membership and qualifications of members of the Accountability and Implementation Board; and requiring the Accountability and Implementation Board Nominating Committee to submit a certain slate of nominees to the Governor on or before August 1, 2023.

CORPORATE INCOME TAX – RATE REDUCTION (ECONOMIC COMPETITIVENESS ACT OF 2023)

ELECTION LAW - PARTY AND ELECTED PUBLIC OFFICES - PROHIBITION

Altering the application of provisions of law that prohibit an individual from simultaneously being a candidate for more than one public office or office of a political party; prohibiting individuals from simultaneously being a candidate for, or holding, a party office and an elected public office; and providing certain exceptions.

MINORITY BUSINESS ENTERPRISES – CALCULATION OF PARTICIPATION RATES – PROCUREMENTS FROM MARYLAND CORRECTIONAL ENTERPRISES

Requiring a State procurement unit to include the dollar value of its contracts with Maryland Correctional Enterprises in the total dollar value of its procurements for the purpose of calculating the unit's Minority Business Enterprise Program participation rate.

CRIMINAL LAW – PUBLIC SAFETY – INTERFERENCE WITH A PUBLIC SAFETY ANSWERING POINT – PENALTIES

Prohibiting a person from taking certain actions with the intent to interrupt or impair the functioning of a public safety answering point; and prohibiting a person from taking certain actions that interrupt or impair the functioning of a public safety answering point; and authorizing certain penalties.

Prohibiting a person from making or causing to be made a false statement, report, or complaint to a governmental emergency report recipient with reckless disregard of causing bodily harm to an individual as a direct result of a response to the statement, report, or complaint; and providing that a person who violates the Act, in addition to any penalties imposed, is civilly liable to an individual harmed by the violation.

CRIMINAL PROCEDURE – EXPUNGEMENT OF RECORDS – WAITING PERIOD

Repealing the waiting period for applying for expungement of certain records; and prohibiting certain records from being expunged by obliteration for 3 years after the date of dispostion and limiting access to the records during that time. EFFECTIVE OCTOBER 1, 2023

# HB 747 Delegate Pasteur, et al

CORRECTIONAL SERVICES – INMATE EMPLOYMENT – AGRICULTURAL WORK

Repealing the authority of the Division of Correction to arrange for inmates not needed or being used by State Highway Administration to perform emergency road work to be employed in agricultural work during any part of the year at a camp in Queen Anne's County or any other county with a similar camp.

# **HB 748** Delegate Williams

LAW ENFORCEMENT OFFICERS – SEXUAL CONTACT WITH PERSON IN CUSTODY – PENALTY

Altering penalties relating to sexual contact with a person who is under arrest, in detention, or otherwise in the actual custody of a law enforcement officer under certain circumstances.

JUVENILE COURT – CONCURRENT JURISDICTION – JUVENILE OFFENSES ON MILITARY INSTALLATIONS

Establishing that the jurisdiction of the juvenile court is concurrent with that of a federal court sitting in the State over certain proceedings involving violations of federal law by a on a military installation if the federal court waives exclusive jurisdiction and the violation of federal law is also a crime under State law.

## **GUN THEFT FELONY ACT OF 2023**

Classifying the theft of a firearm as a felony; and establishing a penalty for theft of a firearm of imprisonment not exceeding 5 years or a fine not exceeding \$1,000 for a first offense, and imprisonment not exceeding 10 years or a fine not exceeding \$2,500 for a second or subsequent offense.

# PUBLIC SAFETY – OFFICER AND COMMUNITY WELLNESS TRAINING GRANT FUND

Establishing the Officer and Community Wellness Training Grant Fund to provide grants to local law enforcement agencies for Mental Health First Aid for Public Safety training and Critical Incident Stress Management peer support training; requiring the Governor to include in the annual budget bill \$1,000,000 for the Fund; and requiring the Governor's Office Of Crime Prevention, Youth, and Victim Services to administer the Fund and report to the Governor and General Assembly on December 31 each year.

This bill requires a mandated appropriation in the annual budget bill.

# STATE BOARD OF ELECTIONS - PROCUREMENT OVERSIGHT

Requiring the State Administrator of Elections or the procurement officer for the State Board of Elections to disclose requests for proposals, invitations for bids, and proposed procurement contracts to the State Board; and requiring the State Board to vote to approve or reject certain requests for proposals, invitations for bids, and procurement contracts.

JUVENILE COURT – JURISDICTION – GUN OFFENSES (JUVENILE GUN OFFENSES ACCOUNTABILITY ACT OF 2023)

Altering the jurisdiction of the juvenile court to establish that the juvenile court has exclusive original jurisdiction over a child who is at least 10 years old alleged to have committed a certain offense involving the use or possession of a firearm.

## CRIMINAL LAW - SEX TRAFFICKING - FELONY

Reclassifying as a felony instead of a misdemeanor certain sex trafficking offenses; and establishing an affirmative defense of duress if a defendant committed an alleged violation as a result of an act of another charged with violating certain prohibitions against sex trafficking.

#### ESTATES AND TRUSTS – REGISTERED DOMESTIC PARTNERSHIPS

Establishing requirements for the registration and termination of domestic partnerships with the register of wills; repealing provisions on legitimacy and illegitimacy of children and providing for the parentage of a child born or conceived by registered domestic partners; requiring the register of wills to recognize as domestic partnerships relationships established under the laws of other jurisdictions if the laws are substantially similar to the provisions of the Act; etc.

Clarifying that an expunged conviction does not constitute a conviction that disqualifies a person from eligibility for a handgun permit.

Requiring certain expedited proceedings in a wrongful detainer action if the property that is the subject of the action is, at the time of the complaint, advertised or listed for sale or lease by the complainant and requiring that notice of a hearing or appeal be served in person or, under certain circumstances, posted conspicuously on the property; etc.

SEXUAL ASSAULT EVIDENCE COLLECTION KITS – PRESERVATION AND STORAGE

Altering requirements for the storage and preservation of sexual assault evidence collection kits; authorizing the Attorney General to direct a certain person to comply with provisions of the Act; and authorizing the Attorney General to apply to a certain court for an order to show cause under certain circumstances.

Requiring the Governor's Office of Crime Prevention, Youth, and Victim Services to establish and administer a certain reporting program relating to sexual assault evidence collection kits; requiring a law enforcement agency and a person with control or possession of a sexual assault evidence collection kit to report certain information to the program and comply with certain regulations; and clarifying the uses for the Rape Kit Testing Grant Fund.

Establishing the Affordable Life, Wills, and Estate Planning for Seniors Program in the Maryland Legal Services Corporation to provide seniors with low to moderate financial means access to affordable civil law–related services; establishing that an individual who is at least 60 years old and has a family income that does not exceed 75% of the median family income for the State is eligible to participate in the Program; requiring the Governor to provide an appropriation of \$500,000 in the annual budget bill for the Program; etc.

Establishing procedures for child advocacy centers when there is a change in certain health care providers for children; and establishing that the Health Care Worker Whistleblower Protection Act applies to behavioral, mental, and other health care providers working with child advocacy centers to ensure their protection if raising concerns about center operations, services, and standards of care.

Requiring that the procedures for declaring an impasse and submitting a dispute to binding arbitration be conducted in accordance with certain provisions of the Montgomery County Code if the Sheriff of Montgomery County and a bargaining representative are unable to reach agreement during negotiations on matters applicable to employees of the Montgomery County Sheriff's Office; and generally relating to collective bargaining for employees.

Authorizing the parties to a collective bargaining agreement for employees of the Housing Opportunities Commission of Montgomery County to request the services of a mediator—arbitrator during a term of a collective bargaining agreement under certain circumstances; establishing the process for mediation—arbitration; and requiring the parties to share equally the costs of the mediator—arbitrator's services.

# PROPERTY AND INCOME TAXES – CREDITS FOR CONSTRUCTION AND PURCHASE OF HOUSING IN WESTERN MARYLAND

Requiring the governing body of certain counties and municipal corporations located in Western Maryland to grant a property tax credit on certain newly constructed dwellings; allowing certain persons who construct more than 10 middle–income homes in Allegany County, Garrett County, or Washington County to claim a credit against the State income tax; requiring the Department of Housing and Community Development to administer the credit; etc.
