HOUSE BILLS INTRODUCED FEBRUARY 24, 2023

HB 1276 Delegate Hornberger

CORPORATIONS AND ASSOCIATIONS – COOPERATIVES –
NONESCHEAT CAPITAL CREDITS

Providing that certain unclaimed money held by a cooperative and due to a past member is not considered abandoned property; authorizing a cooperative to use this money only to assist members or to donate to charitable organizations; requiring money not expended within 3 years to be considered abandoned property; etc.

HB 1277 Frederick County Delegation

FREDERICK COUNTY – ELECTRONIC TIP JAR MACHINES –
AUTHORIZATION AND REGULATION

Authorizing a person authorized to operate a tip jar in Frederick County to operate an electronic tip jar machine if the person obtains a license for the machine from the State Lottery and Gaming Control Commission; and requiring the Commission to adopt regulations for the operation and licensing of electronic tip jar machines.

HB 1278 Delegate Bhandari**PHARMACISTS – STATUS AS HEALTH CARE PROVIDERS AND REIMBURSEMENT**

Altering certain definitions of “health care provider” to include pharmacists for the purposes of provisions of law related to health care malpractice claims and HIV testing; and requiring the Maryland Medical Assistance Program, the Maryland Children’s Health Program, and certain insurers, nonprofit health service plans, and health maintenance organizations to provide coverage for services within the scope of practice of a licensed pharmacist under certain circumstances.
