## **SENATE BILLS INTRODUCED February 2, 2023**

#### **GROUP HEALTH INSURANCE – ISSUANCE TO TRUSTEES OF A FUND – MULTIPLE EMPLOYERS**

Altering a certain provision of law authorizing the issuance of a policy of group health insurance to allow the issuance of a policy to the trustees of a fund adopted by two or more employers and to the trustees of a fund established by two or more employers regardless of whether the employers are in the same or related industry; and applying the Act to all policies, contracts, and health benefit plans issued, delivered, or renewed in the State on or after January 1, 2024.

## INCOME TAX – SUBTRACTION MODIFICATION – MILITARY RETIREMENT INCOME

Phasing in, over a period of 2 years, an increase in a subtraction modification under the Maryland income tax to allow for a subtraction of all military retirement income.

## ENVIRONMENT – STATE WETLANDS – SHORELINE RESTORATION

Altering the requirements for improvements made to protect a person's property against erosion; requiring the Department of the Environment, in coordination with the Department of Natural Resources, to designate priority shoreline restoration zones where conditions exist that degrade the resilience of the land and the habitat connectivity between the land and water; establishing in a certain Fund a coastal resilience and living shoreline restoration account to provide grants for certain shoreline stabilization replacement projects; etc.

Providing that value-added agricultural activities are a farm or agricultural use of land for assessment purposes; creating a subclass of real property consisting of improvements on an actively used farm that support value-added agricultural activities; requiring improvements on an actively used farm that support value-added agricultural activities to be assessed at the agricultural use rate; etc.

Altering the requirements of the school health services program to allow participation by certain nonpublic schools; prohibiting a county board of education from expending more than \$40 per student, adjusted for inflation, to provide school health services to students in certain nonpublic schools; prohibiting a county board from providing adequate school health services in nonpublic schools that discriminate in certain ways; and requiring the Governor to provide \$4,000,000 in the annual budget bill starting in fiscal year 2025 for the program.

This bill requires a mandated appropriation in the annual budget bill.

Requiring a local department of social services to provide a housing allowance to households that are receiving temporary cash assistance or transitional support services and are not receiving a certain housing subsidy where the tenant's portion of rent is based on a percentage of the tenant's income; and requiring the continuation of a housing allowance for 6 months following the termination of temporary cash assistance if the household is receiving or is eligible to receive Supplemental Nutrition Assistance Program benefits.

## STATE PERSONNEL – TELEWORKING PROGRAMS, POLICIES, AND GUIDELINES – REQUIREMENTS

Establishing certain requirements for each teleworking program, policy, and guideline adopted by a certain appropriate official in State government; authorizing certain State employees to initiate a certain grievance; and requiring the University System of Maryland to include in a consolidated memorandum of understanding certain terms relating to teleworking.

Establishing the Black Bass Conservation Fund in the Department of Natural Resources to further black bass management; requiring the Department to administer the Fund as a special, nonlapsing fund; and requiring the Department to establish a process through which an individual who purchases a certain license online to make a voluntary donation to the Black Bass Conservation Fund.

Authorizing the State Board of Cosmetology to issue a limited license to provide eyelash extension services.

Requiring the Department of General Services to establish a maximum acceptable global warming potential for certain categories of eligible materials, any cement or concrete mixture, used in certain eligible projects; requiring a unit of State government to specify the eligible materials that will be used in an eligible project in the solicitation for an eligible project; requiring a successful bidder or offeror of an eligible project to submit certain information about each eligible material proposed to be used in an eligible project; etc.

Altering the grounds on which a deputy sheriff having a rank of major or below in Washington County may be discharged after 2 years of continuous employment; providing that a special deputy sheriff in Washington County is not a State employee for certain purposes; authorizing sworn deputy sheriffs at the rank of sergeant and below and correctional deputies at the rank of sergeant and below to engage in collective bargaining with the Washington County Sheriff and the County Administrator; etc.

Authorizing the Director of the State Lottery and Gaming Control Agency to issue certain fraternal organizations a license for not more than five instant ticket lottery machines; providing that proceeds from instant ticket lottery machine sales by a fraternal organization are to be distributed in a certain manner; and declaring the intent of the General Assembly that the Agency solicit proposals from multiple vendors for the lease or purchase of instant ticket lottery machines under the Act.

Establishing the Woman– and Minority–Owned Shellfish Aquaculture Enterprise Fund as a special, nonlapsing fund to assist woman– and minority–owned businesses entering into or expanding in the shellfish aquaculture industry; requiring the Maryland Agricultural and Resource–Based Industry Development Corporation to develop partnerships with certain entities to facilitate the award of loans from the Fund and identify potential loan recipients; and requiring interest earnings of the Fund to be credited to the Fund.

Requiring the Department of Natural Resources to establish a Restorative Aquaculture Pilot Program to provide financial incentives to holders of aquaculture leases who maintain the lease in accord with certain criteria and maintain the restorative conditions for at least 4 years; and authorizing a holder of an aquaculture lease who is participating in the Pilot Program to meet certain requirements by shellfish seed planting only.

Requiring a county or municipal corporation to define, by law, who is a law enforcement officer or rescue worker; and altering eligibility for the tax credit to include certain disabled law enforcement officers or rescue workers who were domiciled in the State within a certain number of years before the officer or worker died or was determined to be disabled; and applying the Act to all taxable years beginning after June 30, 2023.

Expanding the forms of financial assistance available under the Appraisal Gap From Historic Redlining Financial Assistance Program; altering eligibility requirements for projects that may receive financial assistance under the Program; altering the time period when applications may be submitted under the Program; repealing certain restrictions on the amount of financial assistance that may be provided under the Program; etc.

Authorizing the correction of the designated beneficiary election for certain retirees of the State Police Retirement System, Law Enforcement Officers' Pension System, or Judges' Retirement System who retired on or before December 31, 2012, if the retiree named an individual of the same sex to be a designated beneficiary and the retiree married the designated beneficiary on or after January 1, 2013.
