## **SENATE BILLS INTRODUCED February 6, 2023**

## **SB 750** Senator Folden

ELECTION LAW - VOTING - PROOF OF IDENTITY

Altering the manner in which an election judge is required to establish the identity of a voter; requiring an election judge to refer a voter for provisional voting if the voter is unable to provide the required identification; and prohibiting a person from voting or attempting to vote under a false form of identification.

## **SB 751** Senator Folden

## PROPERTY TAX CREDIT – DISABLED OR FALLEN LAW ENFORCEMENT OFFICER OR RESCUE WORKER – ALTERATIONS

Altering, for purposes of a certain property tax credit, the definition of "fallen law enforcement officer or rescue worker" to include disabled law enforcement officers or rescue workers who have died regardless of the cause of death; requiring the amount of the credit for a newly acquired dwelling owned by a disabled or fallen law enforcement officer or rescue worker or the surviving spouse or cohabitant to be in the same proportion as the property tax credit for a certain former dwelling; etc.

Establishing that certain records of elected officials are not personnel records for the purposes of inspection under the Public Information Act; and establishing that certain records of the State Ethics Commission and Joint Committee on Legislative Ethics are available for public inspection under certain circumstances.

Establishing the Maryland Wiretap and Electronic Surveillance Reform Work Group to study the effectiveness of Maryland's wiretapping and electronic surveillance laws; and requiring the Work Group to report its final findings and recommendations regarding revisions to Maryland's wiretapping and electronic surveillance laws to the Governor and General Assembly by December 1, 2024.

Making permanent a requirement that the Comptroller distribute \$14,000,000 of certain abandoned property funds to the Access to Counsel in Evictions Special Fund; and making permanent a requirement that the Governor include in the annual budget bill an appropriation of \$14,000,000 from the Fund to the Maryland Legal Services Corporation.

CORRECTIONAL SERVICES – PREGNANCY AND POSTPARTUM SUPPORT (PREVENTION OF FORCED INFANT SEPARATION ACT)

Requiring the Division of Correction to allow a certain pregnant woman and a certain woman who recently gave birth to transfer to the prerelease unit for women for a certain time period; establishing the Healthy Start Bonding Program to facilitate strong bonds between incarcerated women and their children; and requiring the Division to allow liberal visitation between certain individuals and certain children under certain circumstances.

Requiring an individual who provides security guard services to the individual's employer to be certified as a security guard; regulating certain security guard employers; altering the certification and renewal standards for security guards; requiring the Maryland Police Training and Standards Commission to identify or establish certain training programs for the certification and renewal of certification of security guards; requiring security guards to complete certain security training programs; etc.

Requiring the Commissioner of Correction to report certain information regarding the gender identities of inmates and the housing status of transgender, nonbinary, or intersex inmates; prohibiting an employee of a correctional facility from discriminating against inmates on the basis of certain protected classes; requiring the managing official of a correctional facility to develop a written nondiscrimination policy regarding inmates; etc.

Repealing the prohibition against a person using or possessing with intent to use, delivering or selling under certain circumstances, or manufacturing or possessing with intent to deliver or sell under certain circumstances drug paraphernalia to inject, ingest, inhale, or otherwise introduce into the human body a controlled dangerous substance; altering a prohibition against a person possessing or distributing controlled paraphernalia under certain circumstances; etc.

Increasing penalties for a person causing physical injury to a Baltimore City special enforcement officer, a special parking enforcement officer, or a special traffic enforcement officer while the officer is engaged in the performance of the officer's official duties; and providing that a person who violates the Act is guilty of the felony of assault in the second degree and is subject to imprisonment of up to 10 years or a fine of up to \$5,000 or both. Authorizing a person who is serving a term of confinement to petition a court to modify or reduce the sentence under certain circumstances; providing that a certain petitioner is entitled to assistance of counsel and, if indigent, representation by the Office of the Public Defender; authorizing a certain person to apply to the Appellate Court of Maryland for leave to appeal a certain order in a certain manner and within a certain period of time after the court passes a certain order in accordance with the provisions of the Act; etc.

Authorizing a seasonal restaurant in Wicomico County to operate without providing potable running water to customers if the restaurant is located in a certain area and uses a graywater system and a community sewerage system is not available to serve the restaurant; and requiring the owner or operator of a seasonal restaurant authorized to operate without providing potable running water to customers under the Act to safely dispose of graywater in a certain manner.
