SB 951 **Howard County Senators**

HOWARD COUNTY – BOARD OF EDUCATION – TERMS AND PUBLIC
CAMPAIGN FINANCING

Altering the terms of the members of the Howard County Board of Education;
and authorizing the governing body of Howard County to establish a system of
public campaign financing for members of the county board of education.

SB 952 **Senator McCray**

HISTORIC REVITALIZATION TAX CREDIT – CREDIT AMOUNTS AND
FUNDING – ALTERATIONS

Altering certain credit amounts and limitations on a certain credit against the
State income tax for certain rehabilitation projects under the historic
revitalization tax credit program; and altering the amount of certain
appropriations that the Governor, in certain fiscal years, is required to include
in the annual budget bill for the Historic Revitalization Tax Credit Reserve
Fund and the Small Commercial Project Trust Account within the Reserve
Fund.

This bill requires a mandated appropriation in the annual budget bill.

SB 953 **Frederick County Senators****FREDERICK COUNTY – ELECTRONIC TIP JAR MACHINES –
AUTHORIZATION AND REGULATION**

Authorizing a person authorized to operate a tip jar in Frederick County to operate an electronic tip jar machine if the person obtains a license for each the machine from the State Lottery and Gaming Control Commission; and requiring the Commission to adopt regulations for the operation and licensing of electronic tip jar machines.

SB 954 **Senator Klausmeier****OVERDOSE RESPONSE PROGRAM – OPIOID OVERDOSE REVERSAL
DRUGS – CHOICE OF FORMULATION AND DOSAGE**

Requiring the Maryland Department of Health to allow certain entities provided opioid overdose reversal drugs by the Department under the Overdose Response Program to choose the formulation or dosage of opioid overdose reversal drugs approved by the federal Food and Drug Administration with which the entity is to be provided.
