SENATE BILLS INTRODUCED January 17, 2024

SB 360 The President (By Request – Administration)

BUDGET BILL (FISCAL YEAR 2025)

Making the proposed appropriations contained in the State Budget for the fiscal year ending June 30, 2025, in accordance with Article III, Section 52 of the Maryland Constitution; etc.

SB 361 The President (By Request – Administration)

CREATION OF A STATE DEBT – MARYLAND CONSOLIDATED CAPITAL BOND LOAN OF 2024, AND THE MARYLAND CONSOLIDATED CAPITAL BOND LOANS OF 2015, 2016, 2017, 2018, 2019, 2020, 2021, 2022, AND 2023

Authorizing the creation of a State Debt in the amount of \$1,792,830,000, the proceeds to be used for certain necessary building, construction, demolition, planning, renovation, conversion, replacement, and capital equipment purchases of the State, for acquiring certain real estate in connection therewith, and for grants to certain subdivisions and other organizations for certain development and improvement purposes; etc.

BUDGET RECONCILIATION AND FINANCING ACT OF 2024

Altering or repealing certain required appropriations; authorizing the use of certain funds for certain purposes; altering the funding formula for community colleges and the State aid program for private nonprofit institutions of higher education; authorizing or altering the distribution of certain revenue; requiring interest earnings for certain special funds to accrue to the General Fund of the State for fiscal years 2024 through 2028; authorizing the transfer of certain funds; etc.

This bill requires a mandated appropriation in the annual budget bill.

PROCUREMENT CONTRACTS – DISCLOSURES TO SECRETARY OF STATE – BENEFICIAL OWNERSHIP

Altering the definition of "beneficial ownership" to mean any ownership interest of 25% rather than 5% for the purposes of certain disclosures made by certain businesses to the Secretary of State under certain circumstances.

ELECTION LAW – CASTING GENERAL ELECTION BALLOT IN MULTIPLE STATES – PROHIBITION

Prohibiting a person from willfully or knowingly casting a ballot in a general election in more than one state in the same year.

FAMILY LAW – CHILD CUSTODY EVALUATORS – QUALIFICATIONS AND TRAINING

Specifying certain qualifications and training necessary for an individual to be appointed or approved by a court as a custody evaluator; and specifying that certain expert evidence is admissible in certain child custody and visitation proceedings under certain circumstances.

TEACHERS' PENSION SYSTEM - REEMPLOYMENT OF RETIREES

Establishing an exemption from a reemployed retiree earnings offset for retirees of the Teachers' Pension System who are reemployed by certain employers if the retiree's salary is funded from certain sources; and providing for the retroactive application of the Act.

NATURAL RESOURCES – ANTLERLESS DEER HUNTING PROGRAMS – AUTHORIZATION

Authorizing a person to receive a raffle ticket for each antlerless deer hunted by the person during a certain raffle program that has as its objective the hunting of antlerless deer.

STATE RETIREMENT AND PENSION SYSTEM – MILITARY SERVICE CREDIT – ELIGIBILITY

Repealing a limitation for members of the State Retirement and Pension System to receive certain service credit for active duty with the commissioned corps of the Public Health Service, the National Oceanic and Atmospheric Administration, or the Coast and Geodetic Survey.

PROPERTY TAX EXEMPTION – RENTAL INCOME – REPORTING REQUIREMENT

Requiring the owner of real property that is exempt from real property tax under certain provisions of law to report any rental income that is attributable to the property to the State Department of Assessments and Taxation under certain circumstances.

COMMUNITY SCHOOLS – RENTAL ASSISTANCE FOR COMMUNITY SCHOOL FAMILIES PROGRAM AND FUND – ESTABLISHMENT

Establishing the Rental Assistance for Community School Families Program to provide rental assistance to eligible student households; requiring the State Department of Education, in consultation with the Department of Housing and Community Development, to administer the Program; establishing the Rental Assistance for Community School Families Fund; requiring the Governor to include in the annual budget bill an appropriation of \$10,000,000 for the Fund; etc.

MARYLAND MEDICAL ASSISTANCE PROGRAM – PROVIDER AGENCIES AND PERSONAL CARE AIDES – REIMBURSEMENT AND WAGE REPORTS (HOMECARE WORKERS LIVABLE WAGE ACT OF 2024)

Requiring provider agencies to submit certain reports to the Maryland Department of Labor regarding wage rates for personal care aides on or before September 1 each year, beginning in 2025; and requiring, by September 30, 2024, and every 2 years thereafter, the Maryland Department of Health to submit reports to the Senate Finance Committee and the House Health and Government Operations Committee regarding reimbursement rates for provider agencies and any recommended regulatory or legislative changes.

ELECTION LAW – DEADLINE FOR SELECTION OF LIEUTENANT GOVERNOR

Proposing an amendment to the Maryland Constitution by requiring a candidate for Governor in a primary election to designate a candidate for Lieutenant Governor within 21 days after the primary election; requiring a candidate seeking a nomination for Governor by any method other than a primary election to designate a candidate for Lieutenant Governor at the time of filing a declaration of intent to seek nomination; submitting the amendment to the qualified voters of the State at the general election in November 2024; etc.

CRIMINAL LAW - THEFT - MAIL AND MAIL DEPOSITORY KEY

Prohibiting the theft of mail from a mail depository owned by the United States Postal Service; prohibiting the theft of a device used to open a mail depository owned by the United States Postal Service; prohibiting the theft of mail with intent to commit identity theft; prohibiting the theft of mail from an elderly or disabled person with intent to commit identity theft; and establishing penalties for violations of the Act.

STATE EMERGENCY MEDICAL SERVICES BOARD – LICENSES AND CERTIFICATES – APPLICATION REQUIREMENTS

Prohibiting the State Emergency Medical Services (EMS) Board from requiring an applicant to provide proof that the applicant is lawfully present in the United States or have a Social Security number or Individual Taxpayer Identification Number as a condition for licensure or certification; and requiring the EMS Board to require applicants for a license or certificate to disclose certain information or provide alternative documentation and record the information in the applicant's file for a certain purpose.

STATE CONTRACTS - PROHIBITED PROVISIONS

Prohibiting certain provisions from being included in State contracts; specifying that certain provisions are void if included in a State contract; and specifying the applicable law and interpretation of State contracts.

HIGHER EDUCATION – MPOWERING JOINT STEERING COUNCIL – FUNDING

Requiring the Governor, beginning in fiscal year 2026, to include a certain appropriation in the annual State budget bill for the MPowering Joint Steering Council to use exclusively on the University of Maryland Institute for Health Computing; and requiring the Governor in fiscal year 2029 and each fiscal year thereafter to include an appropriation of \$6,000,00 in the annual budget bill.

This bill requires a mandated appropriation in the annual budget bill.

HIGHER EDUCATION – TEACHER DEVELOPMENT AND RETENTION PROGRAM – DEFINITION

Altering the definition of "institution of initial eligibility" to include community colleges as eligible institutions as part of the criteria for applicants for the Teacher Development and Retention Program.

CRIMINAL LAW - THEFT OF A HANDGUN

Establishing the felony of theft of a handgun; and establishing a penalty for theft of a handgun of, for a first conviction, imprisonment of up to 5 years or a fine of up to \$1,000 or both and, for a second or subsequent conviction, imprisonment of up to 10 years or a fine of up to \$2,500 or both.

TASK FORCE TO STUDY CRIME CLASSIFICATION – RENAMING, MEMBERSHIP, AND DUTIES

Extending the Task Force to Study Crime Classification and renaming it the Task Force to Study Crime Reclassification and Penalties; requiring the Task Force to study and make recommendations regarding the penalties for crimes and civil offenses under State law, the potential need for reclassification of certain crimes, the alteration of penalties, and whether certain changes should be made to crimes lacking an explicit mens rea; etc.

POLICE RECRUITMENT AND RETENTION WORKGROUP

Establishing the Police Recruitment and Retention Workgroup to study issues and factors potentially contributing to recruitment challenges and the decline in police officer retention statewide; and requiring the Workgroup to report its findings and recommendations to the Governor and the General Assembly on or before December 30, 2025.

EDUCATION – INTERSCHOLASTIC AND INTRAMURAL JUNIOR VARSITY AND VARSITY TEAMS – DESIGNATION BASED ON SEX (FAIRNESS IN GIRLS' SPORTS ACT)

Requiring certain interscholastic and intramural junior varsity and varsity athletic teams or sports sponsored by certain schools to be expressly designated based on biological sex; prohibiting certain entities from taking certain adverse actions against a school for maintaining separate interscholastic and intramural junior varsity and varsity athletic teams and sports for students of the female sex; and providing that certain individuals have the right to bring a civil action under certain circumstances.

CRIMINAL LAW – DISPLAY OF OBSCENE MATERIALS TO MINORS – AGE VERIFICATION

Requiring a website operator or other person who displays, exhibits, sells, shows, or advertises for sale obscene material to adhere to certain age verification standards.

BALTIMORE COUNTY - NUISANCE ACTIONS - COMMUNITY ASSOCIATION

Altering the definitions of "community association" and "local code violation" to authorize community associations to seek judicial relief for nuisance abatement in Baltimore County; and repealing a provision of law requiring the Circuit Court for Baltimore County to determine the amount and conditions of a bond filed by a community association in a certain nuisance action.

MARYLAND ENERGY ADMINISTRATION – CARBON CAPTURE OPPORTUNITY PROGRAM – ESTABLISHMENT

Establishing the Carbon Capture Opportunity Program in the Maryland Energy Administration to assist nonprofit and for—profit businesses engaged in carbon capture projects or carbon capture research; and requiring the Administration to establish application procedures, provide technical assistance to participating businesses, assist participants in applying for federal and private grant funding, and publicize the availability of the Program.

Altering certain definitions relating to student enrollment that are generally used for the calculation of funding for general education programs.

Providing that student members on certain county boards of education may vote on certain matters and may attend certain executive or special sessions under certain circumstances; and providing that student members of county boards of education have certain voting rights and may attend certain executive or special sessions.

RESTRICTIONS ON USE – SOLAR COLLECTOR SYSTEMS – ALTERATION

Prohibiting a restriction on land use that increases the cost of installing a solar collector system by at least 5% over a certain cost or that reduces the efficiency of the system by at least 10% under a certain energy generation level; authorizing a community association to impose certain restrictions on the installation of solar collector systems in common areas or common elements; authorizing a community association to install a solar collector system in common areas or common elements under certain circumstances; etc.

OYSTERS, STRIPED BASS, AND CRABS – COMMERCIAL AUTHORIZATIONS – SUSPENSIONS AND REVOCATIONS

Prohibiting the Department of Natural Resources from revoking a person's authorization to catch oysters, striped bass, or crabs unless the person has been convicted of or entered an accepted plea of nolo contendere to a certain crime; altering and establishing certain procedures for the suspension or revocation of an authorization to catch oysters, striped bass, or crabs; and authorizing the Department to reinstate a certain authorization under certain circumstances.
