STATE BOARD OF SOCIAL WORK EXAMINERS – MEMBERSHIP AND EXAMINATION REQUIREMENTS

Repealing certain examination requirements for bachelor and master social worker licenses; requiring an applicant for licensure as a certified social worker or certified social worker—clinical to pass an examination prescribed by the State Board of Social Work pertinent to the license sought; and increasing from 2 to 4 the number of consumer members on the State Board of Social Work Examiners.

Exempting certain religious educational institutions accredited by certain accrediting bodies from the requirement to obtain a certificate of approval from the Maryland Higher Education Commission to operate in the State.

HOWARD COUNTY - ROOM RENTAL TAX - MAXIMUM RATE AND DISTRIBUTION HO. CO. 18-25

Increasing from 7% to 8% the maximum sales or use tax rate that Howard County is authorized to impose on room rentals in the County for sleeping accommodations for transients; and requiring Howard County to distribute revenue attributable to a tax rate greater than 7% to the Howard County Tourism Council.

HB 1524 Wicomico County Delegation

WICOMICO COUNTY BOARD OF EDUCATION - ELECTION OF MEMBERS, STUDENT MEMBER, AND COMPENSATION

Altering, beginning with the general election in 2026, the districts from which certain members of the Wicomico County Board of Education are elected; adding a student member from the 11th or 12th grade in good standing and regularly enrolled in the public school system to the county board for purposes of advising the county board on the thoughts and feelings of students in the County public schools; and providing that the members of the county board are entitled to certain compensation and reimbursement.
