#### HB 1526 Delegate Phillips

BUSINESS OCCUPATIONS AND PROFESSIONS – PROFESSIONAL ENGINEERS – EXAMINATION

Requiring an applicant for a license to practice engineering to pass an examination in the fundamentals of engineering given by the State Board for Professional Engineers before passing the required examination in the principles and practice of engineering.

# HB 1527 Delegate Roberts

ILLEGAL DUMPING AND LITTER CONTROL LAW – VIDEO EVIDENCE AND REWARD PROGRAMS

Requiring each county to establish a certain program allowing a member of the public to submit video evidence of an alleged violation of the Illegal Dumping and Litter Control Law to an appropriate enforcement unit within the jurisdiction; and requiring a program established under the Act to allow a member of the public to receive half the total amount of any fines collected in relation to the violation of the Illegal Dumping and Litter Control Law if the video evidence leads to a conviction.

# TASK FORCE TO STUDY STUDENT ATHLETE NAME, IMAGE, AND LIKENESS PROGRAMS IN MARYLAND – ESTABLISHMENT

Establishing the Task Force to Study Student Athlete Name, Image, and Likeness Programs in Maryland; requiring the Task Force to study and make recommendations on how the House v. NCAA case settlement may affect certain revenue sharing programs at universities in the State and the future use of name, image, and likeness programs for student athletes in the State; and requiring the Task Force to report its findings and recommendations to certain committees of the General Assembly by December 1, 2025.

#### HB 1529 Delegate McCaskill

BALTIMORE COUNTY BOARD OF EDUCATION – ALTERATIONS OF ELECTED MEMBER DISTRICTS AND ESTABLISHMENT OF REDISTRICTING PROCESS

Requiring, beginning with the 2034 general election, certain members of the Baltimore County Board of Education to be elected from certain districts in certain elections; and establishing the process for how the Baltimore County school board districts are reapportioned after each decennial census of the United States.

# HB 1530 Delegate McCaskill

PUBLICLY FUNDED PREKINDERGARTEN – ELIGIBLE PREKINDERGARTEN PROVIDER DATA DASHBOARD

Requiring, beginning July 1, 2026, the State Department of Education to maintain on its website a data dashboard with certain information regarding certain eligible prekindergarten providers in the State; requiring the Department to partner with a nonprofit organization that has experience in maintaining a data dashboard for child care providers; and requiring the Department to establish a process that allows an eligible prekindergarten provider to opt out of being included in the data dashboard.
