REAL PROPERTY – IMPLIED WARRANTIES – INCOMPLETE OR MISSING IMPROVEMENTS

Providing that certain provisions of law pertaining to implied warranties do not apply to an improvement that was incomplete or missing at the time of the delivery of the deed.

MARYLAND MEDICAL ASSISTANCE PROGRAM – MATERNAL HEALTH MONITORING PILOT PROGRAM

Establishing the Maternal Health Monitoring Pilot Program in the Maryland Department of Health to support pregnant and postpartum Maryland Medical Assistance Program recipients who have higher risks of pregnancy complications because of maternal hypertension or maternal diabetes; requiring the Department to choose a managed care organization to administer the Program; requiring the managed care organization to contract with a technology vendor to offer remote patient monitoring services to participants in the Program; etc.

This bill requires a mandated appropriation in the annual budget bill. EFFECTIVE JULY 1, 2025

TRANSPORTATION – IDENTIFICATION CARDS – ISSUANCE TO MINORS

Prohibiting the Motor Vehicle Administration from requiring a parent or legal guardian of a minor 15 years of age or older to cosign or be present at the time of submission of the minor's application for an identification card. EFFECTIVE OCTOBER 1, 2025 TR, § 12-301(a) - amended

CONDOMINIUMS – MANDATORY INSURANCE COVERAGE

Requiring a certain condominium unit owner to obtain a certain insurance policy for the unit; requiring a certain insurance policy to include certain provisions; and authorizing a council of unit owners to acquire an insurance policy on behalf of a unit owner who does not maintain a certain required insurance policy and charge the insurance premium as an assessment to the unit owner.

MARYLAND PUBLIC ETHICS LAW – REGULATED LOBBYISTS – REPORTING REQUIREMENTS

Altering the dates by which a regulated lobbyist must file a certain report to the State Ethics Commission; and altering the contents of the report so as to include a list of each matter on which the regulated lobbyist performed lobbying activity, a description of the lobbyist's position on each matter, and each bill number or a description of each legislative action on which the lobbyist performed lobbying activity.
