HB 348 Delegate Stewart

MOTOR VEHICLES – SPEED MONITORING SYSTEMS – SAFETY CORRIDORS

Authorizing the State Highway Administration to use speed monitoring systems in areas determined to be of high risk to vulnerable road users and priority corridors in the Administration's Pedestrian Safety Action Plan; and requiring the Comptroller to distribute revenue from the civil fines collected from the use of certain monitoring systems to a fund for the State Highway Administration to cover the costs of implementing and administering certain speed monitoring systems, for highway safety purposes and Administration system preservation.

HB 349 Prince George's County Delegation

PRINCE GEORGE'S COUNTY – SPEED MONITORING SYSTEMS – MARYLAND ROUTE 210 PG 306–25

Increasing civil penalties for violations recorded by speed monitoring systems on Maryland Route 210 (Piscataway Highway) in Prince George's County that involve exceeding the maximum speed limit by certain amounts; and repealing the termination provision for the authority to place speed monitoring systems on Maryland Route 210 (Piscataway Highway).

BUDGET BILL (FISCAL YEAR 2026)

Making the proposed appropriations contained in the State Budget for the fiscal year ending June 30, 2026, in accordance with Article III, Section 52 of the Maryland Constitution; etc.

HB 351 The Speaker (By Request – Administration)

CREATION OF A STATE DEBT – MARYLAND CONSOLIDATED CAPITAL BOND LOAN OF 2025, AND THE MARYLAND CONSOLIDATED CAPITAL BOND LOANS OF 2011, 2012, 2013, 2014, 2015, 2016, 2017, 2018, 2019, 2020, 2021, 2022, 2023, AND 2024

Authorizing the creation of a State Debt in the amount of \$1,814,825,000, the proceeds to be used for certain necessary building, construction, demolition, planning, renovation, conversion, replacement, and capital equipment purchases of the State, for acquiring certain real estate in connection therewith, and for grants to certain subdivisions and other organizations for certain development and improvement purposes; etc.

HB 352 The Speaker (By Request – Administration)

BUDGET RECONCILIATION AND FINANCING ACT OF 2025

Establishing or altering certain administrative penalties; altering or repealing certain required appropriations; authorizing the use of certain funds for certain purposes; establishing certain funds; authorizing, requiring, or altering the distribution of certain revenue; altering the rates and rate brackets under the State income tax on certain income of individuals; requiring certain groups of corporations to file a combined income tax return reflecting the aggregate income tax liability of all members of the group; etc.

Preliminary analysis: local government mandate

This bill requires a mandated appropriation in the annual budget bill.

EDUCATION – SCHOOL BUILDING ENERGY USAGE – MONTHLY REPORT

Requiring each county board of education to collect data on energy usage and report the data collected to the Interagency Commission on School Construction; requiring the Commission to adopt regulations specifying the data to be collected and the means and frequency of reporting; and requiring the Commission to analyze the data collected and provide recommendations for improving school building energy efficiency and usage.
