SENATE BILLS INTRODUCED January 20, 2025

SB 419 Senator Jackson

INCOME TAX – SUBTRACTION MODIFICATION – PUBLIC SAFETY VOLUNTEERS

Increasing, from \$7,000 to \$10,000, the amount of a subtraction modification under the Maryland income tax for an individual who is a qualifying public safety volunteer for a taxable year beginning after December 31, 2024.

STATE LAKES PROTECTION AND RESTORATION FUND – ALTERATION AND EXTENSION

Altering the purpose and authorized uses of the State Lakes Protection and Restoration Fund by specifying that it may be used only for the protection and restoration of Deep Creek Lake; and extending the termination date applicable to certain provisions relating to the purpose, use, and funding of the Fund to June 30, 2027.

This bill requires a mandated appropriation in the annual budget bill. EFFECTIVE JUNE 1, 2025

SB 421 Senator McKay

CRIMINAL LAW – DESTROYING FUNERARY OBJECTS AND CEMETERY ELEMENTS – STATUTE OF LIMITATIONS AND PROHIBITION

Extending from 1 year to 3 years the statute of limitations for prosecutions relating to destroying funerary objects and other elements of a cemetery to begin at the time local authorities knew or reasonably should have known of the violation; and prohibiting a person from willfully destroying, damaging, defacing, or removing landscaping or part of the grounds of a cemetery.

JUVENILE COURT - JURISDICTION

Altering the jurisdiction of the juvenile court by repealing provisions specifying that the juvenile court does not have jurisdiction over a child alleged to have committed certain acts.

MARYLAND MEDICAL PRACTICE ACT AND MARYLAND PHYSICIAN ASSISTANTS ACT – REVISIONS

Repealing obsolete and redundant language in, clarifying language in, and making language consistent across certain provisions of law governing the State Board of Physicians and the regulation of physicians, physician assistants, and allied health professionals; altering certain licensure requirements; altering the grounds for discipline for physicians, physician assistants, and allied health professionals; altering certain disciplinary procedures; etc.

URBAN STATE HIGHWAYS – SPEED LIMITS – EXCEPTIONS

Authorizing the State Highway Administration to decrease the maximum speed limit by 5 miles per hour on certain urban State highways without an engineering and traffic investigation.

ENVIRONMENT – COAL COMBUSTION BY–PRODUCTS – FEES, COORDINATING COMMITTEE, AND REGULATIONS

Providing that a certain base fee established by the Department of the Environment that is paid by a certain generator of coal combustion by–products is not less than \$2.30 per ton; altering the factors that the Department is required to consider in establishing the fee; establishing the Statewide Coal Combustion By–Products Coordinating Committee to share information, monitoring results, and certain remedial actions with respect to certain coal combustion by–product sites; etc.

SB 358 Senator King

MARYLAND DEAF CULTURE DIGITAL LIBRARY – FUNDING AND BUDGET SUBMISSION

Requiring the Governor to include in the annual budget bill an appropriation of \$450,000 to the Maryland Deaf Culture Digital Library; and requiring the Deaf Culture Digital Library to submit its annual operating budget to the State Library Agency on or before June 1 each year.

This bill requires a mandated appropriation in the annual budget bill.

STATE BOARD OF SOCIAL WORK EXAMINERS – MEMBERSHIP AND EXAMINATION REQUIREMENTS

Repealing the examination requirements for bachelor and master social worker licenses; and altering the number of consumer members on the State Board of Social Work Examiners.

VEHICLE LAWS – INJURY OR DEATH OF VULNERABLE INDIVIDUAL – PENALTIES

Altering the penalties for causing the serious physical injury or death of a vulnerable individual as the result of an individual operating a motor vehicle in violation of certain provisions of the Maryland Vehicle Law; and providing that an individual convicted of a certain violation is subject to not just a fine of \$2,000 but also imprisonment of up to 2 months or both.
