SENATE BILLS INTRODUCED February 8, 2025

SB 1028 Senator Gile

NATURAL RESOURCES – VESSELS – CARBON MONOXIDE WARNING LABELS

Prohibiting a person from operating a gasoline–powered vessel on the waters of the State unless the vessel has carbon monoxide warning labels affixed in conspicuous locations in the vicinity of both the transom and the helm of the vessel.

ESTATES AND TRUSTS – INTERPRETATION OF WILLS – EXTRINSIC EVIDENCE OF INTENT (GRANNY'S LAW)

Authorizing, under certain circumstances, a personal representative to petition the Orphans' Court to interpret a decedent's will in accordance with the decedent's intent as demonstrated by certain extrinsic evidence; establishing a certain rebuttable presumption as to a decedent's intent; authorizing the personal representative to require a certain legatee to demonstrate the use of a legacy under the decedent's will; authorizing the personal representative to petition the court to issue a certain order or judgment; etc.

BALTIMORE COUNTY AND BALTIMORE CITY – VEHICLE LAWS – LIGHTING ON PRIVATELY OWNED VEHICLES

Authorizing not more than five of the highest ranking officers from certain nonprofit volunteer emergency medical services organizations located in Baltimore County and Baltimore City to have their privately owned vehicles equipped with red or red and white lights or signal devices which may be displayed only while on route to or at the scene of an emergency.

CRIMINAL LAW – CHILD'S ACCESS TO FIREARMS – PENALTY (NY'KALA STRAWDER ACT)

Increasing the penalty to up to 5 years of imprisonment or a fine or both for storing or leaving a loaded firearm in a location where the person knew or should have known that an unsupervised minor has access to the firearm.
