#### MODERNIZATION OF MILITARY LAWS ACT

Establishing rules of interpretation related to the uniformed services; altering the rule of interpretation for "veteran"; requiring the Secretary of Veterans and Military Families to develop certain policies related to life transitions of veterans, service members, and military families; and altering the application of certain provisions of law related to veterans, the uniformed services, and the filing of certificates of candidacy, the powers of the Governor, State veterans' cemeteries, and housing and employment discrimination.

Establishing rules of interpretation related to the uniformed services; altering the rule of interpretation for "veteran"; altering the application of certain provisions of law governing public health and the regulation of health occupations to apply to all uniformed services, rather than only the armed forces; altering the circumstances under which licenses for fishing in tidal waters do not lapse; etc.

# SB 283 Senator McCray

# STUDENTS WITH FINANCIAL NEED – COLLEGE PREPARATORY PROGRAMS – EXAM FEE PROHIBITION

Prohibiting a county board of education, beginning in the 2025–2026 school year, from charging students with financial need exam fees related to the International Baccalaureate Diploma Program, the Cambridge AICE Diploma Program, or a program consisting of certain Advanced Placement courses.

# SB 284 Senator McCray

# BALTIMORE CITY – ALCOHOLIC BEVERAGES – HOURS OF OPERATION VIOLATIONS – CIVIL PENALTIES

Establishing for a first offense by a holder of an alcoholic beverages license in Baltimore City of operating the licensed premises outside specified hours of operation without obtaining a certain exemption a fine of not less than \$1,000 or suspension of the license or both, and for a second or subsequent offense a fine of not less than \$2,000 and not more than \$20,000 or suspension of the license or both.

# SB 285 Chair, Finance Committee (By Request – Office of the Attorney General)

ATTORNEY GENERAL – COLLAPSE OF FRANCIS SCOTT KEY BRIDGE – REPORTING

Altering from each month to every 6 months the frequency with which the Attorney General is required to report to the General Assembly on options for recovering economic damages arising from the collapse of the Francis Scott Key Bridge.

DOMESTIC PARTNERSHIP AND MARRIAGE – REQUIRED INFORMATION

Clarifying required information for registering a domestic partnership or obtaining a marriage license; and requiring a declaration of domestic partnership filed with the register of wills to include the Social Security number of each domestic partner who has a Social Security number.

# **SB 287** Senator West

CRIMINAL LAW – INTERFERENCE WITH ACCESS TO OR EGRESS FROM A RELIGIOUS FACILITY – PROHIBITION

Prohibiting a person, acting alone or with others, from preventing another from entering or exiting a religious facility; and providing that a person who violates the Act is guilty of a misdemeanor and on conviction is subject to imprisonment of up to 90 days or a fine not to exceed \$1,000 or both.

# SB 288 Senator McCray

#### ARBITRATION REFORM FOR STATE EMPLOYEES ACT OF 2025

Altering the collective bargaining process for State employees, including by requiring the selection of a neutral arbitrator to oversee all aspects of collective bargaining, establishing a process of arbitration in the event of impasse, and providing that certain decisions of a neutral arbitrator are advisory; requiring that each budget bill contain the appropriations necessary to implement all terms and conditions of employment in certain memoranda of understanding for the next ensuing fiscal year; etc.

# BALTIMORE CITY - REMOVAL OF DEBT BALLOT QUESTIONS

Removing the requirement that certain debt created by the Mayor and City Council of Baltimore be approved by the legal voters of the City of Baltimore through a majority vote at a certain election; and providing that the proposed amendment to the Maryland Constitution be submitted to the qualified voters of the State for adoption or rejection at the next general election to be held in November 2026.

Requiring an applicant for a roadside tree removal permit to provide a certain notice in a certain manner to all owners of property abutting and adjacent to the property subject to the tree removal and to the governing body of any common ownership community that has control over the land on which the tree to be removed is located.

# SB 291 Senator Sydnor

CRIMINAL PROCEDURE – PETITION TO REDUCE SENTENCE (MARYLAND SECOND LOOK ACT)

Authorizing an individual who is serving a term of confinement to petition a court to reduce the sentence or sentences under certain circumstances; and establishing procedures for a proceeding under the Act.

# SB 292 Senator Sydnor

MOTOR VEHICLES – SECONDARY ENFORCEMENT AND ADMISSIBILITY OF EVIDENCE

Requiring a police officer to document all reasons for a traffic stop or other stop on a citation or police report resulting from the stop; establishing that certain evidence obtained during a traffic stop or other stop in violation of certain provisions may be or is inadmissible in certain proceedings; authorizing a police officer to enforce certain provisions of the Maryland Vehicle Law only as a secondary action; etc.

Requiring each member of a county board of education to complete certain antibias training at least once during the member's term.

# SB 295 Senator McCray

INCOME TAX – INCOME TAX RECONCILIATION PROGRAM – ESTABLISHED (MARYLAND FAIR TAXATION FOR JUSTICE–INVOLVED INDIVIDUALS ACT)

Establishing the Income Tax Reconciliation Program in the State to allow certain justice—involved individuals to establish installment payment plans and receive a waiver of any interest and penalties that accrue for unpaid income tax due for a taxable year beginning after December 31, 2024, but before January 1, 2030; requiring the Comptroller to administer the Program; requiring the Comptroller, in collaboration with the Department of Public Safety and Correctional Services, to develop an awareness campaign about the Program; etc.

Authorizing the Public Access Ombudsman to delegate to a staff member of the Office of Public Access Ombudsman any of the powers and duties granted to the Ombudsman.

# SIGN LANGUAGE INTERPRETERS – LICENSING REQUIREMENT

Altering from January 1, 2025, to July 1, 2026, the date by which an individual must be licensed by the State Board of Sign Language Interpreters before providing certain sign language interpretation services or making certain representations.

Authorizing the court to admit into evidence in certain criminal proceedings certain out of court statements made by a vulnerable adult victim or witness under certain circumstances and subject to certain requirements.

#### CANNABIS AGENTS - REGISTRATION - SECURITY GUARDS

Providing that a cannabis agent who is employed to provide security services for a cannabis licensee or cannabis registrant as a security guard or by a security guard agency is not required to obtain a State or national criminal history records check if the cannabis agent is authorized to provide security guard services in accordance with certain provisions of law.
