POSITION: SUPPORT

Chair Davis, Vice Chair Dumais and Committee Members, I write to express my strong support for HB 1410 on behalf of the Maryland and DC AFL-CIO and the many thousands of working men and women our unions represent.

The Secure Maryland Wage Act would set minimum wage and benefit rates to be paid to individuals employed at three "heightened security interest locations": Baltimore Washington Internal Airport (BWI), Pennsylvania Station in Baltimore, and the Port of Baltimore.

These locations are major transportation hubs and significant drivers of economic activity in the region. BWI generated \$4.4 billion in economic impact in 2017, in 2019, the Port handled a record 43.6 million tons of international cargo, while Penn Station serves over 3 million passengers annually.¹

Workers provide vital services at these locations that ensure they are safe and well maintained. By setting minimum wage and benefit rates at these sites, HB 1410 will work to help create employment standards conducive to reducing turnover and improving the retention of experienced and trained employees.

The wages and benefits required by the bill, based on SCA determinations of the prevailing rates of security guards in the area, ensure local job standards are not undercut, and importantly, will give any worker currently paid below them, a better chance of affording a more stable and dignified life.

These locations support the jobs of thousands of workers in our state. Their operations are too important to be compromised by low road employment practices. Similar policies have been
