Senate Bill 361

Anne Arundel County - Alcoholic Beverages - Barbershop and Beauty Salon License

Chairman Pinsky, Vice Chair Kagan and Members of Education, Health and Environmental Affairs:

Thank you for the opportunity to introduce **Senate Bill 360 - Anne Arundel County - Alcoholic Beverages - Barbershop and Beauty Salon License**. This is a simple bill creating a barbershop and salon, beer and wine license in the county. It will allow beauty salons and barbershops to serve wine and beer to their customers by the glass for on-premises consumption only. It also caps the amount a customer can consume to 5 ounces and stipulates no alcohol can be served after 9:00pm at night.

In the past, many of these businesses requested a license to serve alcohol but none existed. The intent of this limited license is to allow these business to offer their customers, at no cost, a single glass of wine or beer during their appointment.

The Anne Arundel Senate Delegation supports SB 361 as does the Board of License Commissioners for Anne Arundel County.

I respectfully request the Committee to give SB 361 a favorable report.
