## **Senate Bill 460**

**The Chesapeake Bay Foundation (CBF) SUPPORTS SB 460 as enhancing transparency and responsiveness to environmental violation complaints and providing public accountability for environmental agency enforcement actions.** The Environmental Accountability and Transparency Act creates an autonomous Office of Environmental and Natural Resources Ombudsman housed within the State Office of the Attorney General to assist with communication between the public and the agencies on their activities. The office would maintain a website with information regarding pollution complaints for the Maryland Departments of Environment, Natural Resources, and Agriculture.

Access to information regarding reported environmental violations and enforcement actions, as provided in this legislation, may ease, rather than add to current administrative burdens. Under this legislation, the Environmental and Natural Resources Ombudsman would maintain a website that lists inspection and enforcement actions, violations deemed “significant noncompliance,” and other violations and enforcement information from the Maryland Departments of Environment, Natural Resources and Agriculture. The information must be kept for three years and maintained in a database format that is searchable by category. This readily available resource may reduce the need for members of the public and advocacy organizations to resort to public information requests, or repeated inquiries into past agency actions.

The Chesapeake Bay Foundation regularly communicates with agencies regarding complaints of environmental violations, including violations of erosion and sediment control laws related to new construction, and agriculture-related concerns, such as livestock exclusion from streams or CAFO stormwater pond overflows. This legislation’s concentration of communications responsibility in one office would greatly expedite response and follow-up with these and other complainants, delivering the intended public access and encouraging critical public engagement.
