



AMENDMENTS TO HOUSE BILL 800
(First Reading File Bill)

AMENDMENT NO. 1

On page 1, strike beginning with "requiring" in line 7 down through "year," in line 9; strike beginning with "authorizing" in line 15 down through "website," in line 17; and strike beginning with "if" in line 18 down through "government" in line 19.

On page 2, in line 7, strike "16-111 and".

AMENDMENT NO. 2

On page 2, strike in their entirety lines 25 through 31, inclusive.

On page 3, in line 6, strike "NOVEMBER 30" and substitute "DECEMBER 15"; in line 12, strike "IN" and substitute "SUBJECT TO PARAGRAPH (3) OF THIS SUBSECTION, IN"; after line 17, insert:

"(3) PARAGRAPH (2) OF THIS SUBSECTION MAY NOT BE CONSTRUED AS A WAIVER OF INFORMATION THAT IS PROTECTED BY PRIVILEGE.";

and in line 22, after "OF" insert "AT LEAST".

On page 4, in line 9, strike "JULY 1, 2021" and substitute "DECEMBER 1, 2021"; in line 10, strike "OR (D)"; strike in their entirety lines 12 through 14, inclusive; in line 15, strike "(D)" and substitute "(C)"; strike beginning with "IF" in line 15 down through "THE" in line 17 and substitute "THE"; and in line 25, strike "(E)" and substitute "(D)".
