Testimony in Support of SB 965 - Day Care Centers for Elderly and Adults - Reimbursement Senate Finance Committee March 10, 2020

The Maryland Senior Citizens Action Network (MSCAN) is a statewide coalition of advocacy groups, service providers, faith-based and mission-driven organizations that supports policies that meet the housing and care needs of Maryland's low and moderate-income seniors.

MSCAN strongly supports HB 584 which would provide much-needed help for Maryland's Adult Medical Day Centers by providing reimbursement for a minimum of 4 hours of care on a day when the center might have to close for a weather emergency or in a case where a participant has to leave the center for a medical emergency. When centers are not reimbursed the Medicaid rate of just \$82.24 per day for weather or medical emergencies, they must still cover fixed costs such as wages and benefits for staff, rent, as well as transportation costs to and from the centers. This creates a real financial strain on centers, many of which are struggling to stay open. One MSCAN member organization reports that the last non-profit Adult Medical Day Care Center in their county has closed. Now all low-income seniors have to go many miles to Baltimore County for Adult Medical Day Care services. HB 584 provides a small remedy to help centers which operate on a shoestring to serve the lowest income vulnerable seniors. In Montgomery County, one of their oldest and most-respected Adult Medical Day Centers will be closing on March 20, 2020. In spite of philanthropy of more than \$5 million dollars over the last ten years, the center reports that it loses \$2,000 a day due to the high costs of serving their very frail participants; some with dementia and others with complicated diseases such as Multiple Sclerosis which may even require tube feeding. In order to provide quality service to their clients, the center needs to hire one staff member for every 3 or 4 participants, plus the cost of specialized paratransit services for these health-impaired individuals. A loss of \$2,000 a day is clearly unsustainable for any center. Participant fees and government support fall far short of the need.

The support outlined by HB 584 seems particularly fair when it is realized that nursing homes have protection from loss of income through the **bed-hold process**. When a resident is in the hospital, nursing facilities are reimbursed the **full** Medicaid rate of \$273 per day. Please note that Adult Medical Day Care facilities can serve **more than three** participants for the price of one day in a nursing home!

MSCAN respectfully requests a favorable report on this bill to enable this much-needed service to survive in Maryland. Thank you for your consideration.
