HB 934—Public Safety - 9-1-1 Emergency Telephone System

March 3, 2020

Sponsor Testimony

Chairwoman Pendergrass, and Honorable members of the Health & Government Operations Committee:

HB 934 makes various changes to the statutory framework that governs the State's 9-1-1 system. In 2018, the NG911 Commission was formed to support the State in its efforts to evolve emergency service and implement Next Generation 9-1-1 (NG911) technology Statewide. Our work has been conducted by four subcommittees that identify ways to enhance current statutory and regulatory frameworks; assess the governing bodies and funding of the 9-1-1 system; evaluate technology needs throughout the State; and identify best practices, training, policies, and procedures for 9-1-1 Specialists.

The Commission produced a 65-page report with 23 unanimous recommendations incorporated into three bipartisan bills that laid an important foundation for advancing NG911 in Maryland. Despite the progress that has been made to improve Maryland's 9-1-1 emergency response systems, there is more work to be done.

What was once an emergency system built around landline telephones is evolving into a multimedia voice, text, video Internet protocol system more appropriate for modern times. Maryland's Commission to Advance NG911 across Maryland issued a second annual report in December, outlining 25 unanimous recommendations to advance the project. They are as follows;

Summary of NG911 Commission Recommendations in HB934

- Mandate regular audits by the Comptroller's office of telephone companies and 9-1-1 service providers to
 ensure that funds are remitted accurately.
- Protect the rights and privacy of callers as NG911 enables people to send pictures and video to 9-1-1.
- Enforce Kari's Law, ensuring that everyone can reach an emergency center by dialing 9-1-1 on any phone without a prefix.
- Enact statewide training requirements for 9-1-1 Specialists.
- Reorganize the structure of the Emergency Numbers Systems Board (Maryland 9-1-1 Board).
- Clarify the definition of a Public Safety Answering Point (9-1-1 Center).

I am pleased to be a member of this commission along with my colleague Delegate Susan Krebs. I urge this committee's favorable report of HB 934.
