Dear Delegate Adams and Committee Members:

I am writing in support of HB 950. Maryland Voting Equity Reform Day should be celebrated as the change from all "at-large" county council members written into the earlier Maryland Constitution to county district representation has enabled minorities of all kinds greater voice in the decisions made by legislators. The term "at-large" would seem to designate that the members would act without favoritism, but in practice the reverse was the case.

In Dorchester County, where the change was first envisioned, from 1850 through 1980, no county council members were elected 1) from a rural area, or 2) "of color". All council members came from the county seat, and all were white. The decisions by the council reflected these two facts.

With a day celebrating the change to the Maryland Constitution, students and all citizens of Maryland will become more aware of the importance of how they are represented.
