WHY ARE WE HERE AGAIN?

Hello, my name is John Gundling. I live in Hagerstown, MD and have done so without incident was 33 years. I have been a Second Amendment supporter since I was 14 years old and attended Military School, graduating with honors.

Last year the General Assembly introduced HB786, a true infringement on privacy [Fourth Amendment] as well as the Second Amendment. Today the very same bills, HB0004 and SB0208 come before the GA Senate with no hint of modification to preserve the God-given Rights of all American Citizens.

In particular senate bill 208 would deny any citizen and law abiding gun owner the right to lend my child, my wife, or my friend who doesn't own a shotgun or rifle, to participate in shooting sports, even if I'm right there with them; to maybe go hunting albeit supervised, and prove himself a responsible gun custodian. In addition this bill would make it virtually impossible to sell my shotgun or rifle to another person, regardless of my honorable intent.

This long gun bill known last year has House Bill 786 was defeated for several legal reasons at Sine die. Now the House and Senate has resurrected this bill again using whatever misnomer, politically correct but misleading term to subjugate citizens into serfs and subjects. Terms like "gun violence", "increasing public safety" [the actual statistics say otherwise], "common sense gun control", or any other totalitarian term that is/are all propaganda designed to cajole and persuade unsuspecting law abiding citizens to give up their God-given rights of self-determination via self-preservation.

The absurdity of this misguided proposal, and tragic irony as well, is that the legislation will do nothing to put a dent in violent crime or the murder rate in Maryland's most violent cities.
