My residence is located on 48th street, otherwise known as "show center" for participations on "the strip." From my balcony, I have repetitively witnessed the disrespect to our community as a whole during all hours of the day and night. From the vantage point of my home, I look at the permanent damage left in multiple areas from hours of cars burning tires and doing donuts. When I look down the street to the 45th street light, you can see hundreds, if not thousands, of people crowding the street while cars do burnouts. Along with the damage that is left for taxpayers to repair, the behavior is downright dangerous to everyone involved. In fact, it's completely out of control.

This behavior happens on both public and private properties. In the private parking lots of Satellite Café and Dry 85 restaurant, participants cause excessive noise with vehicles and take over parking lots with enormous crowds. A little further north at 48th street, participants were seen skidding and spinning wheels for the onlookers from the Ocean Colony balconies. They overpower our sidewalks, invade our neighborhoods and make it dangerous for our residents and visitors to travel anywhere. We are literally hostages of our own town.

In the midtown area pedestrian traffic is always heavy, as there are several hotels, restaurants and bars in that area. The Town of Ocean City and our partners in the State of Maryland have taken proactive steps by installing a median fence to help reduce the number of pedestrians crossing the highway outside of a designated crosswalk. When the large crowds begin to spill into the highway to get up close and personnel with vehicles doing burnouts, the avenues of a safe exit are narrowed. If a vehicle lost control like it did this past year in this area, the outcome with be devastating.

Our community has been before you, and we stand before you again, asking for assistance from our legislators. We need your help, your support and leadership to aid our Motor Vehicle Event Task Force with creating successful strategies to prevent this behavior before something terrible happens. I strongly and respectfully request that this committee provide **Senate Bill 878 Worcester County- Special Event Zones- Prohibitions** with a favorable report.

POSITION: SUPPORT

The Maryland Chiefs of Police Association (MCPA) and the Maryland Sheriffs' Association (MSA) SUPPORT SB 878. This bill is intended to address public safety situations that occur in Ocean City during automotive or motor vehicle events where the public gathers in large numbers and in close proximity to a highway. Ocean City hosts numerous events throughout the year. However, one unsanctioned event in particular tends to draw crowds that sit along Coastal Highway to cheer on drivers in certain types of vehicles. This leads to excessive speed, spinning of wheels, speed contests, and negligent and reckless driving on the part of individuals. It has become increasingly difficult for law enforcement, even with assistance from other agencies, to effectively address the number of violations that occur. SB 878 is proposing to mitigate these occurrences through increased penalties and fines in the designated "special event zones."

Specifically, the bill defines exhibition driving and authorizes the State Highway Administration and a local authority to designate a "special event zone" on roadways and reduce speeds. A person found to be in violation of exceeding the reduced speed limit, negligent driving, participating in a race or speed contest, spinning wheels or causing excessive noise would be subject to imprisonment or a fine not exceeding \$1,000 or both.

SB 878 proposes a reasonable solution to address the egregious behavior that occurs during this event. For these reasons, MCPA and MSA SUPPORT SB 878 and urge a FAVORABLE Committee Report.

Dear Members of the Judicial Proceedings Committee,

First, I would like to thank the committee for the continued time you have given our community to address the concerns of dangerous behavior and lawlessness that takes place in Ocean City during various motor vehicle events. Your previous support for our Special Event Zone legislation has allowed us to increase fines for speeding and helped us take the first step toward increasing public safety.

As host to hundreds of popular events each year, including several motor vehicle events, only three require Special Event Zones. While previous legislation has assisted in addressing speeding during these events, our community is still held hostage to event participants and we are placed great danger.

More specifically, there is one social media driven, pop-up event which occurs annually in September in which the large majority of attendees show little respect for our laws, our law enforcement officers and our community as a whole. In 2019, participants stood on the sidewalks of our streets and threw beer bottles at our police officers, they harassed our residents and caused a near riot on our streets.

Below is one example of an email we received from a resident after the pop-up event in 2019.

"As residents of a beach town, we are hardy. We can withstand unpredictable flooding, high winds, dangerous storms. However, the storm that came through this weekend under the guise of "H2Oi" is something that is predictable and can be stopped. They destroyed our street, disrespected the residents and threatened the safety of everyone who lives here. I understand you believe you did everything possible, but that's not true. I've included only one of many pictures I have of what they've done to our street. As a resident of 60th, and on behalf of the rest of the residents on this street, I implore you to shut down the public parking on the last weekend of September for the H2O event next year. Hundreds of kids were gathering in a mob in the street doing burnouts and burning away the asphalt. Hundreds of kids were listening to blaring music well into the early hours of the morning. Hundreds of kids were smoking and drinking and then throwing their trash into the street, onto our property. I would've included the pictures of trash the next morning that looked as though a carnival came through, but the wonderful residents of 60th street woke up early and

cleaned the entire street. Shortly after, we all locked our doors and shut ourselves in as the animals awoke and resumed destroying the town. The police were called by multiple residents, multiple times a day, and despite them doing their best, they were outnumbered and not prepared to deal with what was going on. Our condo buildings all have ample parking and none of us need the public street parking, which is why we beg you to shut down the public parking for next year's event. We heard from many officers that every street was like this, but of the streets we've seen, ours is by far the worst. I encourage you to come and see the damage for yourselves. The picture I included is just one spot where asphalt was burned away by their tires, but there are multiple spots. I have screenshots from their social media group where they are saying they will return to 60th street next year because "that's where all the burnouts happen". I also have a lot more pictures of the damage and videos I would gladly share if you need to see via email. Thank you for your time. I will be sending this letter once a week until I receive a response"

We received dozens of emails and hundreds of social media comments that echoed the same fear, frustration and demand for change. Expanding the violations covered under the Special Event Zone legislation is for no other reason than to keep our community safe and give our police officers additional tools needed to enforce and discourage the reckless and unsafe conditions we experience during these three event weekends. Our goal is not to arrest or cite individuals, but to discourage and deter behavior that threatens the safety of our residents and visitors.

This legislation is not only supported by the City Council, the Motor Event Task Force, the Maryland Chiefs of Police Association as well our residents, business community and visitors. As a community, we agree that something must change. I strongly and respectfully request that this committee provide Senate Bill 878 Worcester County – Special Event Zones – Prohibitions with a favorable report.

- 1. Create no parking zones on streets where cars congregate for pictures or to show off. Bayside 32nd Street (my address) is one street used for photos, especially in the area just east of the Calico Jack docking area.
- 2. Install temporary cameras in trouble zones off of Coastal Highway so as not to rely on social media

postings. Again, where 32nd Street and Penguin drive intersect is one such area as there is enough room for daredevils to spin their cars.

- 3. Establish a citizens patrol with faster method to contact police, perhaps an app that links to the call center.
- 4. Send a letter from the city to businesses and property owners discouraging them from allowing long-term parking and loitering or face penalties. I know there are signs posted by most businesses now, but how is that enforced?
- 5. I believe assistance from the National Guard will be helpful, especially at night when large crowds make it difficult for drivers to see. This would give our own forces more opportunity to patrol side streets.
- 6. Encourage civic groups to conduct street clean-up on Friday, Saturday, and Sunday mornings so there isn't so much for street cleaners to do on Monday.
- 7. Use any possible laws to impound vehicles. Tickets aren't working. Eliminating cars will eliminate problems.
- 8. Establish vehicle check points along Coastal Highway and at town entrances for inspections. Those who don't pass inspection should not be allowed to enter town.
- 9. Provide details of arrests made during the event, including the number of arrests for disorderly conduct.

Hi, I'll be brief as I know your time is both limited and valuable. I'm sure you have your best minds working on a solution to the H2Oi unsanctioned event problem. We were in the OC area over the past week but were able to avoid the problem areas. We noticed there were none of the H2Oi cars on Assateague Island - probably due to the pair of 15 mph speed bumps on the Island in both the incoming and outgoing lanes.

Just a suggestion (my oldest son's, actually): if you could deploy large temporary speed bumps on each of the 3 access roads (US 50, MD 90, & MD 528) into Ocean City (and figure out how to manage the resulting traffic problems), you could exclude most of the H2Oi vehicles and remove the attraction that draws the participants to the unsanctioned event.

Just a suggestion, FWIW.

I would like to address my suggestions to the Motorized Event Task Force. I am a condo owner on the Boardwalk who has participated in multiple car events for 20 years! I am not simply a residential owner who is not inhibited for complaining about every thing they do not like about a town that has all the benefits supported by a resort community dependent on special events and resort \$\$.

Of the multiple events, only the non-sanctioned H2Oi event presents a real problem to OC as evidenced by the past week-end. Although I was not present I did learn that a neighbor in our Condo had a parking lot problem with a participant. Our process of dealing with this problem is complicated by dealing with Condo Mgt and a towing Co. problems. May I suggest that your police forces obtain car boots (renting them from another municipality) for the weekend, equipping your patrol officers with multiply units and applying the boots on appropriate violations, private or municipal, where appropriate. This would allow private towing companies time to impound the vehicles and hit the participants where

they are immediately affected.

These consequences could be announced over social media, particularly for this group, and I bet the immediate reality of redeeming a vehicle from impound would be more incentive than waiting to pay a fine or penalty in the future. In the extreme, this enforcement technique might be legislatively incorporated in the Special Events rules and regulations, for example, application to private property violations.

I hope this suggestion might be seriously considered. I think it would have very minor consequences, if any, to the multiple motor events that have positive effects on the economy and future of OC.

I would appreciate an acknowledgement of this suggestion.

As residents of a beach town, we are hardy. We can withstand unpredictable flooding, high winds, dangerous storms. However, the storm that came through this weekend under the guise of "H2Oi" is something that is predictable and can be stopped. They destroyed our street, disrespected the residents and threatened the safety of everyone who lives here. I understand you believe you did everything possible, but that's not true. I've included only one of many pictures I have of what they've done to our street. As a resident of 60th, and on behalf of the rest of the residents on this street, I implore you to shut down the public parking on the last weekend of September for the H2O event next year. Hundreds of kids were gathering in a mob in the street doing burnouts and burning away the asphalt. Hundreds of kids were listening to blaring music well into the early hours of the morning. Hundreds of kids were smoking and drinking and then throwing their trash into the street, onto our property. I would've included the pictures of trash the next morning that looked as though a carnival came through, but the wonderful residents of 60th street woke up early and cleaned the entire street. Shortly after, we all locked our doors and shut ourselves in as the animals awoke and resumed destroying the town. The

police were called by multiple residents, multiple times a day, and despite them doing their best, they were outnumbered and not prepared to deal with what was going on. Our condo buildings all have ample parking and none of us need the public street parking, which is why we beg you to shut down the public parking for next year's event. We heard from many officers that every street was like this, but of the streets we've seen, ours is by far the worst. I encourage you to come and see the damage for yourselves. The picture I included is just one spot where asphalt was burned away by their tires, but there are multiple spots. I have screenshots from their social media group where they are saying they will return to 60th street next year because "that's where all the burnouts happen". I also have a lot more pictures of the damage and videos I would gladly share if you need to see via email. Thank you for your time. I will be sending this letter once a week until I receive a response.

We went before the State Legislature last year to get the authority to establish a Special Event Zone to lower speed limits and increase fines. We are working with businesses and Condo Associations to increase private security. The turning Coastal HiWay into Coastal SpeedWay with roaring engines, squealing tires, and speeding reckless driving, not so much. There was none of that in the parade on Friday morning. As I walked from Seacrets to 28th Street on Thursday evening I saw a fender bender accident, a mass of county, state & Ocean City police attempting to maintain order and writing citations, I realized the noise was being made by two types of vehicles. One was late model oversized pickup trucks, and the other was late model Mustangs & Camaros. These vehicles were not part of the hundreds of vehicles in the parade.

As for the motor cycle accident that is now the talk of Ocean City. No one should be surprised that it occurred. When the City government, merchants, and citizens invite thousands of noise, speed loving car enthusiasts, we should know that will get lots of unsavory, fanatics and crazies, too. We were aware of planned events like Wine on the Beach, the Coin and Currency Show and Summer Cruisin' next week, but it wasn't until we were approaching Rt 90 that we discovered the activity and mayhem along Coastal Highway from unsanctioned H20i groups. We did not find this event advertised on various Ocean City websites nor did we find warnings from the expected activities mentioned. It wasn't until we visited oceancitymd.gov website that we saw the warnings. We did receive an email this past week from our HOA management company warning us of the speed limit changes issued but we didn't understand what the changes were for.

We spent the evenings inside our unit because we were too frightened to go out. We normally walk to local restaurants to eat but couldn't because the sidewalks were packed with people and the roads were buzzing with noise. Near us, OC police and State Troopers were stationed on 56th street and across the street near KY West. The volume of people congregating along the roads and in parking lots was unbelievable. Johnny's Pizza and Subs was a hot spot. Why weren't people asked to leave? People were along the sidewalk standing and seated in folding chairs. There was even an individual that had put up a tent to watch the loud, obnoxious cars. People were drinking beverages, alcoholic and non-alcoholic, and leaving their trash behind. Each morning the entire area was littered with their garbage.

BILL TITLE: Worcester County – Special Event Zones – Prohibitions

REVIEW AND ANALYSIS:

This legislation seeks to prohibit a person from engaging in exhibition driving within a special event zone in Worchester County. This legislation defines exhibition driving and specifies the penalties for violating the section.

In 2018 the General Assembly passed legislation prohibiting speeding in defined special event zones. Since then, in Worchester County, there have continued to be three special event s per year. Two are sanctioned by Ocean City, MD and one is not. The behavior of some of the drivers during these events is reckless and a danger to both pedestrians and drivers alike.

This legislation seeks to expand the authority of the 2018 law and provide the city of Ocean City and its law enforcement partners a better ability to control the behavior of the participants who do not feel the need to adhere to Maryland's current laws. This legislation will allow law enforcement to remove a person from the special event zone and curtain their continued lawless behavior. Without the ability to remove the participants of illegal activity, as we have seen in the past, they will receive their citation and continue their illegal course of conduct.

This legislation is paramount for the Ocean City to continue to be a destination for both residents and visitors to feel safe and enjoy all of the activities offered.

For these reasons, the Department of State Police urges the Committee to give Senate Bill 878 a favorable report.

Dear Chairman Smith and Committee Members:

The Maryland Department of Transportation (MDOT) supports Senate Bill 878 and offers the following information for the Committee's consideration.

Senate Bill 878 defines and prohibits "exhibition driving" in "special event" zones in Worcester County. The bill expands the authorization for MDOT State Highway Administration (MDOT SHA), on its own initiative or at the request of a local authority, to designate an area on a State highway as a "special event" zone and reduce established speed limits in the special event zone. The change would be made after a determination that it is necessary to ensure public safety. Senate Bill 878 would grant the same authority to local jurisdictions in Worcester County on local highways.

MDOT SHA's top priority is the safety of the over 6 million road users that travel on the approximately 17,000 lane miles that it operates and maintains. The "special events" defined in Senate Bill 878 often involve thousands of individuals converging on a condensed location, which can create dangerous situations for pedestrians and motorists alike.

Lowering the speed limits and prohibiting certain driving activities within special event zones will help prevent and mitigate the type of hazardous driving activities that have been responsible for numerous senseless deaths and injuries in Maryland. In 2008, an accident that occurred during a drag race event on Route 210 in Prince George's County killed eight bystanders and injured numerous others. It was reported that the vehicle that struck and killed the bystanders was traveling at approximately 110 miles per hour. In June 2009, a drag race accident claimed two lives and seriously injured two others on I-70 in Woodlawn. More recently, in July 2019, during an unsanctioned car event in Ocean City, two individuals, including a juvenile, were struck after a driver lost control of his vehicle while attempting to do a burnout maneuver on a crowded street. By classifying events such as these, as well as the surrounding areas, as "special event zones," participants would be subject to stricter penalties for a wide range of dangerous driving activities. MDOT supports Senate Bill 878 and believes that its enaction will prevent serious situations and tragedies like those described above.
