Bill: HB 302, Deadly Weapons on School Property – Nonpublic Schools

Position: Support with Amendment #263-224-1

Reason for position:

Text of Amendment #263-224-1:

Included in Section A – "This section does not apply to:"

"A person: (a) designated by a non-public school for security at that school, who holds a valid Maryland carry permit; or (b) who is on campus only for the purpose of dropping off or picking up a student and who holds a valid Maryland carry permit."
