AMENDMENTS TO HOUSE BILL 1076
(First Reading File Bill)

AMENDMENT NO. 1

On page 1, in line 7, after “purpose;” insert “requiring the Maryland Department of Health to review certain information on a certain basis; authorizing the Maryland Department of Health and the Family Investment Administration to manage and enter into data-sharing agreements with certain entities for a certain purpose;”; and in line 11, after “purposes;” insert “requiring the Family Investment Administration to review certain information on a certain basis;”.

AMENDMENT NO. 2

On page 2, in line 29, before “**THE**” insert “**(A)** THIS SECTION APPLIES ONLY TO:

- (1)** MEDICAID; AND
- (2)** THE SUPPLEMENTAL NUTRITION ASSISTANCE PROGRAM.

(B)”;

and in the same line, strike “**ENTER**” and substitute “:

- (1)** ENTER”.

On page 3, in line 1, after “**PROGRAM**” insert “, INCLUDING SHARING:

- (I)** DEATH RECORDS;

(Over)

(II) GAMBLING WINNINGS;

(III) LOTTERY WINNINGS;

(IV) TAX FILINGS OR INFORMATION; AND

(V) INCOME RECORDS OR INFORMATION.

(2) REVIEW ANY INFORMATION SHARED IN ACCORDANCE WITH PARAGRAPH (1) OF THIS SUBSECTION TO IDENTIFY ANY CHANGES IN CIRCUMSTANCES THAT MAY AFFECT AN INDIVIDUAL'S ELIGIBILITY FOR THE PROGRAM:

(I) FOR ITEMS (1)(I) THROUGH (III) OF THIS SUBSECTION, AT LEAST MONTHLY; AND

(II) FOR ITEMS (1)(II) AND (V) OF THIS SUBSECTION, AT LEAST QUARTERLY.

(C) THE DEPARTMENT MAY ENTER INTO AND MANAGE DATA-SHARING AGREEMENTS WITH ANY NATIONAL, STATE, OR LOCAL DEPARTMENT, AGENCY, OR DIVISION OR INDEPENDENT VENDOR IN ORDER TO PROVIDE ADDITIONAL DATA OR INFORMATION RELEVANT TO THE PROVISIONS OF THIS SECTION";

in line 27, after "(E)" insert "(1) THIS SUBSECTION APPLIES ONLY TO:

(I) MEDICAID; AND

(II) THE SUPPLEMENTAL NUTRITION ASSISTANCE PROGRAM.

(2)”;

and in the same line, strike “ENTER” and substitute “:

(I) ENTER”.

On page 4, in line 1, strike “(1)” and substitute “**1. A.**”; in line 3, strike “(2)” and substitute “**B.**”; after line 6, insert:

“(II) IN ACCORDANCE WITH SUBSECTION (E)(2)(I) OF THIS SECTION, SHARE THE FOLLOWING INFORMATION:

- 1. DEATH RECORDS;**
- 2. GAMBLING WINNINGS;**
- 3. LOTTERY WINNINGS;**
- 4. TAX FILINGS OR INFORMATION; AND**
- 5. INCOME RECORDS OR INFORMATION.**

(III) REVIEW ANY INFORMATION SHARED IN ACCORDANCE WITH SUBPARAGRAPHS (I) AND (II) OF THIS SUBSECTION TO IDENTIFY ANY CHANGES IN CIRCUMSTANCES THAT MAY AFFECT AN INDIVIDUAL’S ELIGIBILITY FOR THE PROGRAM:

(Over)

1. FOR ITEMS (II)1 THROUGH 3 OF THIS PARAGRAPH, AT LEAST MONTHLY; AND

2. FOR ITEMS (II)4 AND 5 OF THIS PARAGRAPH, AT LEAST QUARTERLY.

(3) THE ADMINISTRATION MAY ENTER INTO AND MANAGE DATA-SHARING AGREEMENTS WITH ANY NATIONAL, STATE, OR LOCAL DEPARTMENT, AGENCY, OR DIVISION OR INDEPENDENT VENDOR IN ORDER TO PROVIDE ADDITIONAL DATA OR INFORMATION RELEVANT TO THE PROVISIONS OF THIS SECTION.”;

and in line 7, strike “(F)” and substitute “(G)”.
