

Testimony in support of SB477 Enoch Pratt Free Library – Operating Hours and Funding Senate Budget and Taxation Committee Wednesday, February 3, 2021

Chairman Guzzone, Vice Chairman Rosapepe, Distinguished Senators and my Committee Colleagues:

On behalf of the citizens of Baltimore and the Enoch Pratt Free Library, I respectfully introduce **SB477 Enoch Pratt Free Library – Operating Hours and Funding.** 

This bill requires an annual appropriation of \$3 million to be used for branches of the Enoch Pratt Free Library to extend operating hours and services to enhance accessibility for the convenience of residents served by Enoch Pratt Branches, namely evenings and weekends. This bill also requires a funding commitment from the City of Baltimore:

City of Baltimore's Obligation:

- 25% match annually (\$750,000)
- Mayor and City Council must report annually on the impact of extended hours

This bill is an extension of similar legislation passed in 2016 which authorized the appropriation of \$3 million over the past five years through FY22. As an historical footnote, this legislation dates back to January of 2016 when the Pratt Library made the courageous decision to remain open to the public after normal hours in the wake of the Freddie Gray unrest.

That moment sparked a renewed recognition of the important role that the Pratt Library System plays as a vital resource for the community. Since that time, funding from this legislation has enabled Enoch Pratt Library branches to expand their hours and advance the library's commitment to equity, inclusion, through greater access to library resources, programs, and services.

This means greater access to services such as free internet, educational resources, workforce development assistance, social workers, and the Pratt's Lawyer in the Library program as well as traditional library circulation of books and other reference materials. we know too well that

many citizens lack critical access to affordable internet. Statewide data show that factors such as race, income, and geography create additional barriers to access. I represent neighborhoods in Baltimore with some of the lowest household incomes, yet despite this fact, since the Pratt extended their hours four years ago, Enoch Pratt has seen a significant increase in utilization which you will hear more about during the Pratt's CEO Heidi Daniel's testimony.

And on a personal note, as the father of 4-school age children who are at home on-line for remote classes, access to the internet is critical for everyone.

### This bill has the support of the entire Baltimore City Senate Delegation who have also cosponsored and provided a letter of support.

I also want to acknowledge that I recently had the honor of joining two of our B&T Committee Members, *Senators Nancy King* and *Sarah Elfreth* on a Legislative Panel hosted by the *Maryland Library Association*, during which both were recognized for their leadership and strong advocacy on behalf of Libraries across Maryland, including the Pratt Library which serves as the designated **State Library Resource Center.** 

I cannot stress enough the importance of this bill and what it means to the citizens of Baltimore especially now when institutions like The Enoch Pratt Free Library are stepping up to provide greater services during this time of COVID relief.

I respectfully urge your support and a favorable committee report on SB477.

### **POSITION: SUPPORT**

Chair Guzzone, Vice Chair Rosapepe, and Members of the Committee, please be advised that the Baltimore City Administration (BCA) **supports** Senate Bill (SB) 477.

Senate Bill 477 would remove the sunset on the mandate of an additional \$3 million annually from the State to fund additional operating hours for the Enoch Pratt Free Library (Pratt). The City would continue to provide a 25% match – \$750,000 – in funding to further support the increased hours of operation.

The Pratt is an invaluable fixture in our City. SB 477 is pertinent to ensuring that our students and residents continue to have increased access to the vital resources and services the library system provides. We hope that the library can build on the growth afforded to them with the extension of this funding by ensuring that all branches can operate under additional hours with a commitment to equity and inclusion for the benefit of all communities across the City.

Even during the pandemic, the Pratt has made great strides to provide programming and resources for our communities. Without the mandated funding, the library would be forced to reduce services and lay off workers at a time when the constituents of this City need library access the most. ### SENATE BILL 477 Enoch Pratt Free Library – Operating Hours and Funding (McCray)

### STATEMENT OF INFORMATION

DATE: February 3, 2021

### **COMMITTEE: Senate Budget & Taxation**

**SUMMARY OF BILL:** SB 477 makes permanent the \$3 million annual mandated appropriation to support the additional operating hours for all branches of the Enoch Pratt Free Library.

**EXPLANATION:** The Department of Budget and Management's (DBM) focus is not on the underlying policy proposal being advanced by the legislation, but rather on the \$3 million ongoing mandated appropriation.

DBM has the responsibility of submitting a balanced budget to the General Assembly annually, which requires spending allocations for FY 2022 to be within the official revenues estimates approved by the Board of Revenue Estimates in December 2020. Mandated appropriations have a direct impact on constructing a structurally balanced budget. Flexibility in allocating available funds is paramount, particularly when the aggregate of increased spending mandates is unsustainable.

Economic conditions remain precarious as a result of COVID-19, making revenue predictions for the remainder of FY 2021 and FY 2022 highly volatile. The impact of the COVID-19 pandemic is a significant budgetary vulnerability, making the addition of new, permanent funding mandates premature.

The highest priority of the Administration is to work with the 2021 General Assembly in enacting the Governor's emergency Recovery for the Economy, Livelihoods, Industries, Entrepreneurs, and Families Act (SB 496/HB 612 RELIEF Act). The RELIEF Act provides \$1 billion in direct stimulus and tax relief for Maryland working families, small businesses, and those who have lost their jobs as a result of the COVID-19 pandemic. Senate amendments add \$520 million in additional relief.
