The Chesapeake Bay Foundation **SUPPORTS** SB 882, which would restore funding to the State Aided Educational Institutions Program in the FY23 budget. For the second year in a row, the Governor's budget proposal zeroed out educational funding that had long been provided to the Chesapeake Bay Foundation to support environmental education programs throughout the State. The State aid allows CBF to leverage additional financial resources and supports Maryland students and teachers in meeting Maryland's environmental literacy requirement.

MSDE's Budget Request for FY 2022 funding for the Chesapeake Bay Foundation's educational programs was struck in the Governor's budget proposal

For 40 years, Chesapeake Bay Foundation's (CBF) award winning outdoor education programs has maintained a contract with MSDE through the State Aided Educational Institutions Program (SAI). In FY 2020, CBF was funded at \$437,341. In FY 2021, The Maryland State Department of Education included CBF in its budget request, but without warning, the money was eliminated in the Governor's proposed budget. The same sequence repeated itself for FY 2022: MSDE requested the funding, and then the funding was zeroed out in the Governor's Budget.

The Chesapeake Bay Foundation helps local school systems meet environmental literacy graduation requirements

CBF provides professional learning courses for approximately 200 Maryland teachers and school administrators every summer that provide immersive multi-day field experiences that help them craft curricula on the Bay's ecology, Chesapeake history, and citizenship. CBF's education program supports Maryland State Department of Education and local school systems in meeting environmental literacy graduation requirements, curriculum standards, and state commitments. The State's funding enables CBF to reach educators and help them provide lessons on Maryland's rich natural heritage and the Chesapeake Bay.

The State's program funding extends unique opportunities to economically disadvantaged students and schools

Each year, CBF's six Maryland education programs serve over 10,000 MD students and teachers at education sites in Annapolis, Baltimore, Havre de Grace, and at island centers on the Eastern Shore. CBF education programs reach every school district in Maryland nearly every year. For many students, the CBF program represents their first time being out on the water and having a hands-on experience with all the

Dear General Assembly Members,

CBF's Environmental Education Programs are important to me because they offer engaging relevant lessons to my students that align with the Next Generation Science Standards as well as their local environment. I have been participating in CBF programs since the late 1990s. My students have spent invaluable time canoeing, boating, and wading all while studying the Chesapeake Bay, their bay. The environment where they live becomes a part of their learning and they learn how to help the bay's future.

Participating in a CBF experience means so much to my students. Not only do they have an outdoor educational experience, but they learn how to use scientific equipment we don't have available in the classroom. Students analyze and compare data and use higher-level thinking skills to apply the information in real-world situations.

The most important lessons that I can offer to students are the ones that help them connect to their home - the Chesapeake Bay, Maryland, and our planet. That connection is built through experiences that immerse them in the lore, the science, the history, and the sense of place they get when they go into the field with experts in those topics.

The Chesapeake Bay Foundation is made up of people who absolutely love our region, its history, and the science behind keeping it healthy. These are the people who take students into marshes for days at time to teach them about biodiversity and how humans impact our environment. They teach students about the science of sea level rise, temperature and salinity changes, and threatened habitats, through student-driven inquiry. These are the people who devote their lives and careers to making sure that Marylanders know why the Chesapeake Bay is vital to the region, and they help children cultivate a love of place through experiential learning.

There is no greater experience I can offer my students than taking them to Smith Island to meet folks who can tell them about how their lives and livelihoods are dependent on the health of their environment. My students get a different perspective on life, economics, and the environment by listening and learning from people who live so close to the bay. Students from urban and suburban areas can't know about what life is like on the Eastern Shore or along the bay if they don't get the opportunity to experience it themselves.

The hectic, noisy days of my students lives leave them stressed and unaware of how quiet nature can be. On a field experience with CBF, they learn that the smell of a marsh can be something that means productivity. They learn to connect the pieces of ecosystems by lying down in the grass and seeing the tiny things that make up the fundamental parts of life in our bay. They make memories that will connect them to the bay forever.

Failure to support the restoration of CBFs State Aided Institution funding in the Maryland State Department of Education budget will take away opportunities from students for which there are no substitutes. You can't learn how to connect with the bay just by reading about it. You can't learn to love the bay if you never get to be a part of it. I am a long-time participant of the Chesapeake Bay Foundation's (CBF) Principal Leadership Program (PLP). My original opportunity to participate in the program was when I was a new principal at Summit Hall ES in Gaithersburg. My interest was prompted by a memorandum from the Montgomery County Public Schools' Outdoor and Environmental Educational Programs (OEEP). I had been associated with the program as a classroom teacher when I accompanied Grade 6 students to various sites in Maryland and Virginia for their outdoor education experience. After becoming a principal in 2003, I worked with my staff to work to becoming a Maryland Green School.

During the certification process, attending the PLP gave me a wealth of ideas to bring back to the staff. With help of OEEP staff and instructors from the local chapter of the Audubon Society, the school's lead teacher compiled an extensive record of student and staff experiences which was submitted to the Maryland Association of Environmental and Outdoor Educators (MAEOE). Our efforts were successful and in 2013 Summit Hall attained Green School status.

Later that year, the school was nominated by the Maryland State Department of Education (MSDE) for the U. S. Department of Education (USDE) Green Ribbon. After an additional compilation of the school's environmental experiences, the Green Ribbon was awarded to Summit Hall. The students and staff were thrilled and eagerly continued their efforts to live up the standards the awards represented. The school's accomplishments were prompted by my initial and ongoing relationship with the CBF. My experiences have allowed me to mentor administrators from the Chesapeake Bay watershed as they begin their work to save the Bay.

Students continue to use monitor the school's energy use. Because of energy conservation, the school system's School Energy Resource Team (SERT) regularly awards Summit Hall rebates that the school can use to support student learning. The older students supervise younger students by giving up their recess periods to assist them to distinguish trash recyclable materials.

Over the past ten years, we've written two grants to access funds through the Chesapeake Bay Trust and over 1000 students have participated in Meaningful Watershed Experiences which brought them outdoors and into nature to experience place-based environmental education opportunities. We serve a diverse student population for whom these field trips are often their first opportunity to see the Chesapeake Bay which is less than 25 miles away. The Anacostia River is just five miles down Rt. 202. Our students crave these active, meaningful, real-life learning experiences.

CBF Education programs have been our partners, mentors, and inspiration for these powerful educational experiences. The Blueprint for Education promises to make sure that every student in every neighborhood has a great public school. CBF has been on this mission for the past several decades, and the results have been exceptional outdoor learning opportunities for adults and students. Nothing is more important than learning to live in a peaceful and healthy community. Learning to protect and care for our natural resources should be a #1 priority.

I own two homes. One in Virginia and one in Maryland - both are near or on the water. I grew up in Cape St. Claire, Maryland. I recall being a teenager in the 1970's, swimming in our local beaches and seeing dead fish floating in the water. We apparently were not smart enough then to know that we should protect our water quality, but I was starting to realize that if I did not personally care for my local environment - I had no one else to blame when it was stinky, dirty and unhealthy. I have made it my life's mission to teach children that they can make a difference in their local, national, and global communities. CBF helps me do that work every day.

I ask that you please support the restoration of CBF's State Aided Institution funding in the Maryland State Department of Education budget. The educational opportunities provided by CBF are vital to the long-term protection of our natural resources in the Chesapeake Bay watershed and beyond. Thank you for your consideration.

Dear General Assembly Members:

I have been a teacher with Prince George's County Public School, since August 2000. I began teaching at Kenmoor MS in Landover, Maryland in August 2019. Before that time, I taught at Lewisdale ES in Hyattsville, MD. In 2011, I took a two-week environmental workshop, which changed my life. During that time, I learned about the environmental issues facing our watershed. After that workshop, I began to explore many more opportunities to learn about the environment. Along the way, I learned about the important work conducted by the Chesapeake Bay Foundation. I also became a mentor teacher with them in 2013. As a mentor teacher, I continue to learn about the issues facing the Bay, plus I was able to bridge the gap between CBF's mission and the curriculum of PGCPS, by working with teachers in our county. During that time, I began to take my students to our local stream and conduct chemical, physical and biological testing with my students. I calculate that over 600 students benefited from what I learned from CBF and other environmental programs. Students were able to determine new career paths (water ecologist, microbiology), due to these rich experiences.

Once again, I would like to reiterate that environmental organizations, such as the CBF, provide many opportunities to learn about the environment and how our lives are impacted by it. Lewisdale ES is a Title 1 school, with many immigrants. Due to my relationship with the educators of CBF, my students learned about solid waste reduction and implemented a school wide recycling program completely run by fifth graders. Some students told me that they started recycling in their homes and talked to neighbors in their apartment buildings about the value of recycling material. No doubt, our visits to recycling centers, water treatment sites, and composting facilities (all organized by CBF), played a huge part in this awareness and willingness to act. Students also restored habitat in our school courtyard, which involved the whole community (parents/businesses/artists and the government agencies). We also did yearly clean up and green up activities in the community, at our school, and in the park where we did our water studies. Needless to say, these experiences were rich and memorable for our students.

Lastly, I strongly believe you should support the restoration of CBF's State Aided Institution funding in the Maryland State Department of Education budget. It is critical that the work CBF does through this funding is continued to meet the needs of all communities in Maryland.

My name is Amelia Farrell and I'm a graduate of Annapolis High School's International Baccalaureate Program. For over half my time in high school, I was involved with the Chesapeake Bay Foundation as a part of their Student Leadership Program. My first experience with the Bay Foundation was going on a fall trip to Tangier Island- a tiny island in the Bay off the coast of Crisfield, Maryland. During that trip, a group of about 20 kids and I learned about the people and culture of Tangier Island itself, how to lead a tree planting, and just enjoyed time in nature. While this may not sound too life-changing, it was the exact opposite for me. This first trip I took with the Chesapeake Bay Foundation completely changed my outlook on the environment of Maryland and the Chesapeake Bay itself. I had gained a grand value and appreciation for environmental education and the protection of the natural beauty of Maryland.

CBF has provided countless environmental education experiences across Maryland, Pennsylvania, and Virginia for students, and every experience I participated in provided me new, valuable information that I have taken in and used to better myself and the world around me.

What's so valuable about these programs is that they are truly building passionate leaders dedicated to bettering Maryland and the world. Through those experiences, students have developed the skills to advocate for causes and educate others, but also learned how to navigate the world for ourselves. The Chesapeake Bay Foundation doesn't tell students what to think they give us information, share data, and allow us opportunities to learn through hands on experience, which is the most important aspect of all. By exploring the Bay, its forests, farms, and streams, seeing Bay creatures up close to learn about them, and talking directly with both scientists and watermen, we are able to learn so much more than we ever would have sitting in a classroom. Our session was an hour and a half long, most of the respondents said their favorite part was that they

were able to hear directly from the students who were involved. Without my prior environmental education experiences with CBF, I would not have had the courage or professionalism to speak at that event. Again, the Student Leadership Program is unique and valuable because it combines learning about the Chesapeake Bay, this amazing and hugely important natural resource, with actual life skills, like public speaking, social and event organization, and civic engagement- standing up for what you believe in.

Unfortunately, my time as a high school Student Leader with CBF has come to an end, but my passion for protecting and preserving the environment has only grown. When I was filling out my college applications and had to list my intended major, it wasn't even a thought to list anything else but Environmental Studies. During my time with CBF, I was introduced to so many different ways to restore and protect the Bay, but I was hooked after my first community advocacy experience. I truly felt like I was making a difference when I talked to my local legislators about why they should support legislation that protects the environment, and the Bay as a result. I want my career to be dedicated to environmental protection in governance because that is where I truly believe change can be most effective. I was a passionate, determined person before my time in the Student Leadership Program, but now, thanks to the dozens of environmental education opportunities provided to me by the Chesapeake Bay Foundation, I can use my skills for something bigger than me.

March 3, 2021

Maryland Humanities offers this testimony in support of proposed SB882. This bill would require mandated level funding at the FY21 level in FY23 and hopefully restore the Chesapeake Bay Foundation (CBF) as a recipient of critical grant funding for its educational programming for youth via the SAI ("State-Aided Institution") grant program of the Maryland State Department of Education.

Thank you to the committee for its past support of this vital resource for non-profit organizations that offer critical, supplementary educational experiences to Maryland youth. Maryland Humanities is one of 56 nonprofits currently funded through the program and currently is one of 44 nonprofits collectively advocating on behalf of the SAI program as part of MASO, or the Maryland Alliance of SAI Organizations. CBF is a fellow MASO member, despite having been cut from the SAI program in FY21 and proposed again in FY22.

Efforts to sustain the SAI program and restore funding to FY20 levels—including the inclusion once more of CBF—are so necessary. Informational Statement – SB882/HB1053 Operating Budget for Education

Laura Bogley, JD - Director of Legislation, Maryland Right to Life

On behalf of our members across the state, we urge the members of the Maryland General Assembly to protect Maryland school children from being preyed upon by the abortion industry. We will make every effort to prevent Planned Parenthood and other abortion businesses from setting up shop in our children's schools.

While the Supreme Court through an extreme act of judicial activism overturned Maryland's criminal ban on abortion and created a federal right to abortion, there is no legal right for abortion organizations to operate on public property or to be compensated through public funding.

The Maryland State Department of Education is entrusted by parents and the state with the education of Maryland children. The state has taken it upon themselves to provide Reproductive Health curriculum and services. The state has contracted those responsibilities out to third parties, including to Planned Parenthood and other organizations and health providers that advocate for abortion and provide abortion counseling and referral. These services are being offered without parental knowledge or consent. Each year the Maryland Department of Health and the Maryland State Department of Education force taxpayers to subsidize the abortion industry not only through Medicaid reimbursements and Family Planning Program fungibility, but also through grants and contracts awards. In 2020 MDH gave Planned Parenthood nearly \$80,000.00 in Covid relief grant monies. The Maryland State Department of Education has failed in their duty to parents and students to ensure that contractors are providing medically accurate and age appropriate health education and services.

There is bi-partisan unity on prohibiting the use of taxpayer funding for abortion. State funding for abortion on demand is in direct conflict with the will of the people. In fact, 58% percent of those surveyed say they oppose taxpayer funding of abortion, including 31% of Democrats, 83% of Republicans, and 65% of independents. 80% of Americans polled favor laws that protect both the lives of women and unborn children.

Funding restrictions are constitutional - The Supreme Court has held that the alleged constitutional "right" to an abortion "implies no limitation on the authority of a State to make a value judgment favoring childbirth over abortion, and to implement that judgment by the allocation of public funds." When a challenge to the constitutionality of the Hyde Amendment reached the Supreme Court in 1980 in the case of Harris v. McRae, the Court ruled that the government may distinguish between abortion and other procedures in funding decisions -- noting that "no other procedure involves the purposeful termination of a potential life" -- and affirmed that Roe v. Wade had created a limitation on government, not a government funding entitlement.

For these reasons, we respectfully urge you to vote against the expansion and funding of any NARAL or Planned Parenthood or affiliated organization endorsed programs or policies in Maryland schools. Thank you.

SENATE BILL 882 Operating Budget – Education Programs – Mandated Funding (Guzzone)

STATEMENT OF INFORMATION

DATE: March 3, 2021

COMMITTEE: Senate Budget & Taxation

SUMMARY OF BILL: SB 882 mandates an appropriation in FY 2023 for each of the programs within the Funding for Educational Organizations (R00A03) equal to the greater of the funding for the program in FY 2021 or FY 2022, plus an additional \$150,000.

EXPLANATION: HB 1053 mandates a total of \$1.3 million in FY 2023, including increased funding for: Maryland School for the Blind; Blind Industries and Services of Maryland; Other Institutions; Aid to Nonpublic Schools; and Broadening Options and Opportunities for Students Today.

DBM has the responsibility of submitting a balanced budget to the General Assembly annually, which requires spending allocations for FY 2022 to be within the official revenues estimates approved by the Board of Revenue Estimates in December 2020.

Economic conditions remain precarious as a result of COVID-19, making revenue predictions for the remainder of FY 2021 and FY 2022 highly volatile. Many individuals and households are unemployed or underemployed, with many industry sectors operating at much less than 100% capacity. Federal stimulus programs are providing much needed relief, but the impact of the COVID-19 pandemic continues to present a significant budgetary vulnerability.

The General Assembly and Administration have successfully enacted the Governor's emergency Recovery for the Economy, Livelihoods, Industries, Entrepreneurs, and Families Act (SB 496 RELIEF Act), which provides \$1.1 billion in direct stimulus and tax relief for Maryland working families, small businesses, and those who have lost their jobs as a result of the COVID-19 pandemic. It is incumbent upon us to allow the impact of this unprecedented relief package on the State's economy to take effect. Further mandated spending increases need to be reevaluated within the context of an ongoing pandemic.
