I am a lifelong resident of Washington County and the Hagerstown, Maryland area. The purpose of this letter is to express my empathic support for the proposed Multi-Use Facility in Hagerstown. Rarely do you get an opportunity to make a single choice that will forever reshape the landscape of a community. This is one such moment. The addition of a facility like this would give an urban core that has struggled to revitalize for decades the final critical push. This facility will serve as the anchor project to include multiple housing redevelopment opportunities, additional city infrastructure, neighborhood revitalization, and job opportunities.





Dear Chairman Guzzone and members of the Budget and Tax Committee:

The Greater Hagerstown Committee (GHC) strongly supports SB-926 "Economic Development – Maryland Stadium Authority – Hagerstown Multi–Use Sports and Events Facility". This bill is critical in advancing a catalytic project in our community that with bring vitality, activity, investment, and disposable income to an area in need of support.

GHC has made "Building Vibrant Urban Centers" a major goal in our strategic plan since being founded in 1987. We see strong urban centers as a means to attract quality companies and workforce talent to our county, as well as provide a better quality of life for our citizens. As did most American cities, Hagerstown suffered the negative impacts of a national migration decades ago from urban centers to the suburbs. Jobs moved outside the city, the housing stock changed from predominately owner occupied to rental properties, and many of our historic buildings became vacant. For over 40 years, our community has worked tirelessly to change the tide and restore our urban centers back to a destination location for all. We are seeing slow progress but have had success when we've invested in catalytic infrastructure projects such as the University System of Maryland – Hagerstown, Barbara Ingram School for the Arts, a new regional library, expanded Maryland Theatre, a Cultural Trail, or new parking structures. Nearly all of these projects were only made possible through partnerships with the State and the private community.

GHC sees a new multi-use sports and events facility in our downtown as the catalyst to take our revitalization efforts to the next level. From study of how these facilities have impacted other communities, this project will:

- Revitalize our struggling core
- Increase our tax base to provide local governments more money to invest in critical services like police, EMS, education, etc.
- Diversify housing opportunities
- Expand offerings in our Arts and Entertainment District
- Incentivize investors to repurpose and reuse long vacant buildings particularly upper floors
- Attract 200,000 to 400,000 people into the City's core for events, games and concerts to bring more disposable income downtown that will sustain and support the many small businesses in this area
- Attract new businesses and new residential development to an area of great need
- Attract young and upwardly mobile people to the City's core to live, work, and play
- Create walk-to-work jobs for disadvantaged neighborhoods



Our community is doing all we can on our side to prepare for this project. We have a local ownership group that will be investing millions to buy and build an expansion team for the Atlantic League. We are also investing in supporting infrastructure such as the final phase of our cultural trail (a key amenity that will complement the facilities design) and an \$8M new parking deck that will not only support this facility, but also the reuse of the many vacant buildings in our A&E District as investors are drawn to this area.

We are asking for your support of SB-926 to bring life to Hagerstown's urban core. This bill will authorize the Maryland Stadium Authority (MSA) to partner with Washington County on this endeavor and bring this catalytic project to a reality. MSA has proven to be a trusted, successful State organization to oversee projects of this magnitude — a project that smaller rural communities like ours would struggle to do on our own. MSA has successfully built stadiums and projects to areas east of us, and this bill will allow them to build their first project in Western Maryland.

Dear Senators and Fellow Marylanders,

Washington County has experienced significant change over the past couple of years with regard to family activities in downtown Hagerstown. Our existing baseball stadium is old and most would say beyond repair, not the least reason being that it lies in a floodplain. And we have recently lost our Minor League Baseball team. A new facility in a new location is sorely needed to promote Downtown Revitalization, growth in tourism and hospitality, and being home to a newly planned Baseball team.

The University System of Maryland at Hagerstown specifically has Downtown Revitalization in its Mission Statement. Not only do we pursue it with our own expansions, but support other organizations in their efforts to revitalize downtown. Every USMH academic building (4) was vacant and in need of significant reconstruction before put into use. We have also worked with local developers in creating private student housing. Both such buildings were vacant eyesores and now with private investment, these buildings are generating income for the developers and providing needed residence for our students. We are seeing the impact of all of these investments on our downtown core, and believe that investment in a new stadium and multi-activity facility will further strengthen the city's economy.

Our Hospitality and Tourism Management degree program, offered by the University of Maryland Eastern Shore, is newly housed in what was an old vacant bank building. We are leasing this space from developers who invested significantly in its renovation to our specs, placing it once more on the tax rolls. The new stadium being proposed in Senate Bill 926 would be another contributor to Washington County's second-largest economic driver – the Hospitality and Tourism industry.

We heartily support the construction of a new facility for multi-use family activities in Downtown, including being home to a new Minor League Baseball team, other sports and outdoor events. This facility, and the teams and activities it would attract, should bring increased foot traffic and vibrancy to Downtown, and should increase the likelihood of keeping residents in the County and potentially new ones moving in. We would work in close partnership with this initiative.

To build a facility of this nature, in our area, will greatly enhance the economy of Western Maryland not just Hagerstown. The location chosen is in the city's core. This area lies within an Opportunity Zone that will bring other businesses and entertainment venues to the downtown and also help current businesses thrive, as the area, hard hit due to COVID, tries to rebound. The Arena will drive investor confidence into the City's core. Not only will this bring additional tourism into the area, it will support the current employment and create new employment opportunities. The most disadvantaged population in Hagerstown will be able to find employment, as the location is within walking distance or easily accessed via public transportation.

As multiple events would be held at this location, the hospitality and tourism industry, within the county would reap the benefits. As a business located outside the city's core, we recognize that having a strong center city only expands to the outer edges making Hagerstown more viable than ever before. The draw of this facility would continue the growth of the retail, hotel and restaurant industries in Hagerstown, especially at the already growing Halfway Blvd area where the Valley Mall is located.

The Heart of the Civil War Heritage Area has good reason to support Senate Bill 926 and the development of a new minor league baseball stadium in Hagerstown. While our role is to invest in and support the development of heritage tourism product, we know that the broader offerings of our destination are what inspire a visitor to choose our area over other places for their leisure time and spending.

As stated in our Management Plan, under the heading of Various & Distinctive Commercial offerings, "Travelers do not live by history and Civil War sites alone." The 2005 plan goes on to specifically mention Washington County's abundance of sports and recreation activities as having capacity to grow and do more for heritage tourism, calling out Hagerstown Suns Baseball in a chart of attractions. Sadly, the contraction of the Minor League Hagerstown Suns by Major League Baseball, with the added complication of the pandemic, has limited Hagerstown's ability to deliver what Civil War travelers want when they are not on the battlefield or exploring a history museum: memorable hospitality services – restaurants, lodging, and shopping opportunities – as part of their leisure experiences. The good news is that Hagerstown and the surrounding small towns are well situated to rise to the opportunities that will come with the business stimulated by a new minor league baseball stadium - bed and breakfasts and hotels, and Main Street shopping, restaurants and craft beverage makers are poised to respond to demand that will come with the stadium.

Yet, when heritage travelers weigh their choices as they plan vacations, it can often be the array of additional amenities that determines where leisure time will be spent. A new stadium will certainly help pull the scales in the direction of Hagerstown for folks deciding where their discretionary spending will find the best balance of opportunity for their families.

Of course, in the minds of many Americans, Washington County is the very place where baseball originated. Legend has it that during the Civil War, General Abner Doubleday occupied the hill and played (and created the game of) baseball on the field below what is now known as Doubleday Hill. This is recognized to be a myth, but the romance of baseball and the Civil War calls to visitors and we happily welcome them while gently debunking the myth. And it is true that Doubleday and his men were briefly bunkered down along the Potomac River, just a few miles from where the new stadium will be built. Surely, Hagerstown is the place for Maryland's next minor league baseball stadium, and without delay.
