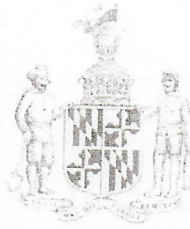

**HB 1100 - Harford County - Alcoholic Beverages - Gift Basket Permit**

**House Economic Matters Committee**

**February 19, 2021**

Chair Davis and the Members of the Economic Matters Committee:

For the record I am Teresa Reilly, Harford County Delegation Chair, here to introduce **HB 1100-Harford County - Alcoholic Beverages - Gift Basket Permit** which is cross-filed with **SB 390**.

This bill establishes a gift basket permit in Harford County. The bill authorizes the Harford County Board of License Commissioners to issue the permit to a person (1) whose primary business is the sale and delivery of flowers; (2) whose business includes the sale and delivery of gift baskets of flowers, food, or other items; and (3) who does not hold another alcoholic beverages license or permit.

- The board may not issue a permit for use in conjunction with or on the premises of a chain store, supermarket, or discount house.
  - A permit holder may sell and deliver, to consumers of a legal drinking age located in the county, gift baskets containing specified volumes of beer, wine, or liquor products, purchased from a retail license holder. (**Up to 72oz. of beer, 2.25 Liters of wine, 2.25 Liters of Liquor**)
- The permit holder must maintain records and submit reports required by the board.
- The annual permit fee is \$100.

**I respectfully ask for a Favorable vote on HB 1100 -Harford County-Alcoholic Beverages-Gift Basket Permit which is a Harford County Delegation Bill and is supported by the Harford County Liquor Board.**

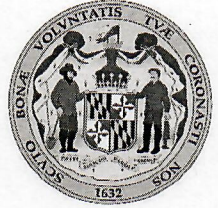
