PLEASE RECONSIDER WHAT YOU ARE THINKING OF DOING – FOCUS ON THE LONG RUN AS NO SMALL COMPANY CAN HANDLE IT. HELP SHOULD BE COMING DIRECTLY FROM THE STATE GOVERNMENT AND NOT THE BACKS OF THE SMALL COMPANIES.

I'M SURE IT WILL BE NO SURPRISE THAT I WILL ADVOCATE THAT ANYONE IN THE MARYLAND GENERAL ASSEMBLY VOTING FOR THIS BILL WILL BE OPPOSED AT ELECTION TIME EITHER.
